### Summary:

On 27 Sep 18 at about 1050 hours, I was working OPD patrol unit 1J07 with Ofc. R. Moore 8051. We were wearing full police wool uniforms. I was driving marked patrol vehicle 1444. At that time we responded to the above call. Cover Ofc. R. Kirkland 8347 responded as well.


Upon arrival, we contacted, Brooks, Marcus (S1), who was spray painting rocks IFO statements S1 advised that he believed he was going to jail and that he had a restraining order.

S1 directed us to his neighbor's residence (Management), where the RP lived. Ofc. Kirkland and myself made contact with the RP, Graves, Malcolm (V1) and his spouse, (OP1), who advised us that they had an active restraining order against S1. OP1, handed me the restraining order.

The restraining order stated that S1 must not Harass, Annoy, or Molest V1 or OP1. V1 said that S1 violated his restraining order by hitting the hood of his 08, Audi, TT, 2D, Blk in color (Veh1) with a water hose. V1 directed me to Veh1 and I observed marks on the hood of Veh1 consistent with a wet hose making contact with a dusty hood. There was no apparent damage. V1 stated that S1 did not talk to him during the incident.

V1 and S1's garage were separated by a few feet in a adjoined building. V1 along with S1 stated he was lawfully able to use his water hose which was connected to V1's residence.

I went back to my vehicle and found the following restraining order:

Ofc. Moore confirmed the restraining order via CRIMS. The restraining order stated that S1 could lawfully use any of the communal facilities.

S1 stated that he did not intentionally hit V1's car with the water hose. S1 said that V1's garage door closed on top of his water hose and he had to pull it out. S1 had a video that showed him making a motion with the hose, apparently when the hose made contact with the car. The camera on his residence appeared to show him facing the building's driveway, as well as V1's car.

The footage showed V1 backing his car over where S1's water hose would have been. As V1 waited in front of his driveway, S1 pulled his water hose and it made contact with the hood of V1's car. V1 got out his car, got back in, and drove back into the garage.

I could not determine S1's intentions when pulled the water hose onto Veh1's hood.

V1 wanted S1 arrested. I advised V1 he would have to sign the citizen's arrest form. V1 said that he would sign the form.

I accepted V1's arrest, put S1 in handcuffs, searched S1, and placed him in the back of my patrol car.

Ofc. Kirkland had V1 sign the citizen's arrest form and took a written statement from V1. V1 stated the following in his written statement.

At about 1005 hours, V1 was getting ready to leave to work in Veh1. V1 backed out of his garage onto his driveway and waited for his garage door to close.

V1 stated as he was in his driveway, S1 swung and hit Veh1 on two separate occasions. V1 got out of Veh1 and told S1 " Don't touch my car." S1 stood in his driveway with a smirk on his face.

V1 went back into his house and called the police.

Officer Kirkland used his PDRD to document the marks on the vehicle's hood.

I transported S1 to North County Jail.

It appeared on 27 Sep 18, V1 was in Veh1 in his driveway waiting for the garage door to close. S1 was watering his driveway and hit Veh1's hood with his water hose. V1 has an active restraining order against S1 which states

S1 is not allowed to harass V1.

My PDRD was activated.

I handcuffed and searched S1.

I did not use or witness any uses of force.

V1 was provided an OPD Resource and Marsy's card.

There are no known witnesses.

S1 and V1 both had video surveillance of the driveway area.
