RESOLUTION ADOPTING OAKLAND
POLICY PLAN AND PROVIDING FOR
THE MAINTENANCE AND AMENDMENT
THEREOF.

WHEREAS, the Oakland City Council, by Resolution No. 51836 C.M.S., directed the preparation of a Policy Plan, which has been prepared; and

WHEREAS, the City Planning Commission has held a public hearing and made its recommendations on said proposed Policy Plan; and

WHEREAS, the City Council has itself held a public hearing on said Policy Plan and finds that it constitutes an appropriate, systematic statement of City goals and policies; now, therefore, be it

RESOLVED: That the City Council hereby adopts as the Policy Plan the goals, text and map policies, rules for interpretation of maps, and rules for amendment which are contained in the Policy Plan document, including a list of revisions, which document is on file with the City Clerk, and all amendments thereto hereafter adopted by the City Council; and be it

FURTHER RESOLVED: That the Policy Plan shall serve as the City Council's comprehensive statement of basic goals and policies; and be it

FURTHER RESOLVED: That the Policy Plan shall serve as a guide for the future actions of the City Council and all departments and agencies under the authority of the City of Oakland, or, where appropriate, as the Council's recommendations to citizens, business, and developers and to those public agencies over which it has no direct authority; and be it

FURTHER RESOLVED: That the City Manager is hereby instructed to direct his staff to publish and maintain the Policy Plan in an appropriate format; and be it

FURTHER RESOLVED: That the published Policy Plan document may include additional or changed graphics and background text, as long as said graphics and text make no substantive change in the Plan's intent and meaning.
