Situation General:

OPD expected the Grand Jury in Ferguson, Missouri, to reach its decision on or about 24 Nov 14. OPD had spent weeks planning for this announcement and anticipated demonstrations to occur upon the decision being made public.

OPD was aware of various groups that advertised demonstrations to commence on the day of the announcement beginning at 1900 hours at Frank Ogawa Plaza (FOP), with participants gathering as soon as 1600 hours. Demonstrations were planned regardless of whether or not there was an indictment.

It was believed the demonstrations could enter a second operational period, or demonstrations would

occur for days afterwards.

#### Situation Specific:

On 24 Nov 14, the Grand Jury's decision was made public. As a result, several demonstrations occurred from 24-29 Nov 14:

- 1. 24 Nov 14: Prior to the decision, several groups called for a demonstration on the day of the announcement:
  - a. BAMN (By Any Means Necessary) / Fuck the Police (FTP)
  - b. Stop Mass Incarceration Bay Area
  - c. Oakland Emergency Response to Mobilize if Darren Wilson is Not Indicted for Murder of Mike Brown
- 2. 25 Nov 14: Demonstrations to occur at 14<sup>th</sup> & Broadway
  - a. BAMN/FTP
  - b. Stop Mass Incarceration Bay Area
- demonstration and march began at FOP.
  4. 27 Nov 14: . . However, OPD mobilized MFFs in anticipation for a demonstration and march. No event occurred this date.
  - 28 Nov 14: OPD mobilized MFFs for the following events:
    - a. BAMN/FTP daily protest at FOP
    - b. Revolutionary Communist Party (RCP) "Black Lives Matter Friday" protest at Walmart located at 8400 Edgewater.
- 6. 29 Nov 14OPD mobilized MFFs for the following events:
  - a. BAMN/FTP daily protest at FOP
  - b. RCP and other groups at Walmart and also at Police Administration Building (PAB)

#### Mission

5.

The Mission of the Oakland Police Department (OPD) was to conduct crowd management for the events from 24-29 Nov 14 with the assistance of other City departments and outside law enforcement agencies, if needed. The mission was conducted with a view to achieving the following overarching goals:

- 1. Protect life;
- 2. Maintain Officer Safety;
- 3. Protect vital facilities;
- 4. Protect property;
- 5. Maintain Public Peace and Order; and
- 6. Uphold Constitutional Rights of Free Speech and Lawful Assembly.

#### Commander's Intent

This operation's purpose was to facilitate a lawful rally and march in compliance with Department policy as directed in Training Bulletin III-G, OPD Crowd Control and Crowd Management Policy. Violent behavior, major destruction/vandalism of property, and other criminal activity would not be tolerated; those who participated in such acts would be arrested when and if safe to do so.

OPD intended to execute this police operation in a cooperative manner and, to the extent possible, without

requiring the use of force. To that end, OPD would try to identify group leaders and to initiate dialogue to seek their cooperation. The OPD Tactical Negotiations Team would carry out this task. Any response to this event was contingent on the amount of protestors/marchers and their behavior. If clear violations of the law were observed, it would remain the Incident Commander/Operation Commander's discretion whether an arrest was made or not. Arrests would be made only if safe to do so. The Incident commander would be responsible for the overall Command and Control of this operation.

Strong supervision and command were essential to maintaining a unified, measured and effective police response. Impulsive or independent actions by officers were to be avoided. Police personnel needed to maintain professional demeanor and remain neutral in word and deed despite unlawful or anti-social behavior on the part of crowd members. Unprofessional police behavior could inflame a tense situation and make crowd control efforts more difficult and dangerous.

OPD would enforce applicable laws and arrest specific individuals who were committing crimes. In the event of a declaration of an unlawful assembly, OPD would disperse crowds in an orderly manner to predetermined egress routes and arrest individuals who fail to disperse.

Repeated announcements would be made advising them of our intent to arrest them if they do not leave. Announcements should be made in different locations if the crowd is large and noisy. Sufficient time would be allotted for those who wish to leave before any further police action is taken. Those remaining and refusing to leave would be cited or arrested.

OPD would follow and request all law enforcement agencies participating pursuant to a mutual aid request to follow OPD policies respecting crowd control management, unlawful assemblies, use of chemical agents and less-lethal impact munitions, use of force, arrests and transporting in-custody individuals to jail. Responding units would be briefed on the operation at the staging location and their crowd control munitions would be inspected. Chemical agents could be used to disperse riotous crowds ONLY at the direction of the Incident Commander. Use of chemical agents could be deployed at the supervisor and MFF command level under exigent circumstances.

#### Key Tasks

The following was our list of our mission-essential tasks:

- Gather information on the intent and plans of the event organizers;
- Attempt dialogue with event organizers/liaisons;
- Monitor the rally and facilitate a march;
- Prevent/Respond to acts of violence and major acts of property damage/vandalism and arrest those responsible for the acts;
- Enforce applicable laws by identifying and arresting specific individuals engaged in unlawful behavior when safe to do so;
- If necessary, issue dispersal orders and disperse crowds in an orderly manner to predetermined egress routes. Safely cite/arrest individuals who fail to disperse;
- Process arrestees in accord with OPD policy/procedures;
- Investigate uses of force, complaints and criminal acts in accord with OPD policy/procedures;
- Maintain strong team discipline.

#### End State

This operation was successful and the following conditions were achieved:


- First Amendment Rights of event participants safeguarded;
- No acts of violence or vandalism occur;
- No officers are injured; and
- Only reasonable force is employed in executing the mission.

#### Concept of Operations:

For each operation, OPD established four MFF Companies, each with four platoons, designed for small unit tactics. After receiving the operations briefing, each MFF company was deployed to the area of operation. Tango and video teams were assigned each operation. Other assets available to the operation included: Public Information Officer(s), motor squad/dual purpose squads for traffic control; bicycle squad for crowd intervention and management; TNT in an SUV and ATVs with sound equipment for announcements; and Argus for aerial reporting.

During operations, MFF Platoons were directed to maintain a visible presence in and around the demonstration areas, and any identified demonstration locations and march routes. All personnel were to remain mobile and flexible ready to respond to address crowds and crime concerns (violence or vandalism). In addition, personnel were directed to cite and arrest law violators when appropriate. CHP was notified of the event and prepared to assist with freeway access points. Outside LE Agencies were provided a warning order in anticipation of mutual aid.

#### General Sub-Unit Tasks:

- 1. MFF Companies
  - a. On order, facilitate marches, by trailing and/or paralleling the protesters. Maintain close, visible presence with the crowd.
  - b. Provide force protection for vital infrastructures such as the PAB, highways, etc.
  - c. Identify and cite / arrest individuals committing crimes, when tactically feasible to do so.
  - d. Maneuver to assist in crowd containment and control, and mass arrests, if required. This may include preventing crowd access to critical infrastructure and/or freeways.
- 2. Motors/Dual Purpose Motorcycle Squads
  - a. Deploy to the protest rally points.
  - b. Control traffic for the protest and/or march. Provide ongoing traffic control as needed.
  - c. Patrol the downtown area, maintaining visibility, enforcing laws, and citing for infractions.
  - d. Provide force protection for vital facilities and/or MFFs.
- 3. Bicycle Squad
  - a. Deploy to the protest rally point, maintaining a visible presence and citing for infractions.
  - b. Monitor protester activity and identify criminal elements. Pay attention to bicycle violations.
  - c. Recon march route and target locations.
  - d. Trail and/or parallel marches. This will be a primary assignment, if the demonstrators become

mobile on bicycles.

- 4. TNT Field Units
  - a. Respond to the protest area, prepared to respond to crowd activity.
  - b. Conduct liaison with event leaders throughout the operation.
  - c. Communicate with crowd during rallies and marches, in order to provide support, guidance, and direction.
  - d. Be prepared to provide dispersal orders and egress routes.

### **Operation on 24 Nov 14**

1400 - Operations briefing: Alpha Company.

1500 – Operations briefing: Bravo, Charlie and Delta Companies.

1610 – EOC is operational.

1635 – Five protestors at FOP.

1710 – Six protestors at Federal Building and about 35 protestors at 14<sup>th</sup> and Broadway.

1820 - Crowd (about 150 protestors) moving n/b Broadway from 14th.

1830 – Crowd returned to 14<sup>th</sup> and Broadway. Several protestors wearing masks.

1835 – Part of the crowd (Group 1 of about 70-100) moving s/b Broadway from 14<sup>th</sup> while the other part

(Group 2 of about 70-100) remains at 14<sup>th</sup> and Broadway.

1838 – Group 1 moving e/b 8<sup>th</sup> Street from Broadway.

1850 – Group 1 at freeway 880 at Jackson attempting to get on freeway.

1855 – A protestor from Group 1 arrested for spray painting a police vehicle. Group 1 moving n/b Jackson.

1900 – Group 2 (about 100-150) are peaceful and remain at 14<sup>th</sup> and Broadway in intersection.

1904 – Mutual Aid activated.

1912 – Group 1 (about 100) moving n/b Broadway at 12<sup>th</sup> Street.

1915 – Group 1 joined Group 2 in intersection of 14<sup>th</sup> and Broadway (about 500 protestors).

1925 - Crowd moving n/b Broadway from 14<sup>th</sup>.

1937 – Moving n/b Webster from 21<sup>st</sup>.

1940 – A rock thrown at Chase Bank window at Webster and 20<sup>th</sup> and glass shattered. 24-Hr Fitness also vandalized. Moving e/b Grand and stopped at Harrison.

1950 – Crowd moving e/b Grand from Harrison. Trash can set on fire at 20<sup>th</sup> and Harrison.

2000 - Moving e/b Grand at El Embarcadero and approaching MacArthur.

2005 – Bottles, hub-caps and other projectiles thrown at officers.

2015 – Protestors running e/b onto the w/b 580 freeway on-ramp near Trader Joes store. CHP officers being overrun and requesting assistance.

2015 – Another crowd of protestors (Group 2 of about 80-100) at FOP.

2025 - Crowd of about 500 on freeway 580 blocking w/b traffic.

2028 – Group 2 at FOP (about 150) moving e/b 14<sup>th</sup> from Broadway.

2030 – IC approves Unlawful Assembly announcements at freeway 580 to get crowd off freeway. Bottles thrown at officers and protestors leaving the freeway in various directions.

2036 – Group 2 moving e/b 14<sup>th</sup> crossing Jackson.

2039 – Arrests being made on freeway 580.

2047 – An unlit flare and multiple projectiles thrown at CHP officers. Group 2 moving e/b 19<sup>th</sup> approaching Lakeside.

2050 – Protestors scaling wall to get on to freeway 580 e/b at Lakeside and Harrison.

2056 – Rocks and bottles thrown at officers on freeway. CHP making arrests.

2105 – One protestor being arrested.

2111 – Protestor arrested on freeway 580 just east of off-ramp.

2116 – Group 2 at 500 block MacArthur and Group 1 (main freeway 580 crowd) near Trader Joe's store at Grand and MacArthur.

2130 – Crowd of about 1,000 protestors on freeway 580 (east and west bound directions) at MacArthur and Grand.

2140 - CHP assisting OPD with skirmish lines on freeway to box protestors in and make arrests.

2148 – CHP making arrests.

2151 – Protestors throwing rocks and bottles at officers.

2158 – Majority of protestors off the freeway and leaving the freeway n/b and s/b on Grand.

2200 - Crowd (about 500-600) moving s/b Grand passing El Embarcadero.

2203 – About 15-20 protestors at 14<sup>th</sup> and Broadway.

2208 – Large bonfire burning at Grand and MacArthur.

2219 - Main crowd at Grand and Webster.

2229 – Crowd moving s/b Telegraph from W. Grand.

2240 – Crowd moving s/b Broadway from 14<sup>th</sup>.

2242 – Many protestors wearing masks and widows at Chase Bank being broken.

2247 – Crowd stops at 8<sup>th</sup> and Broadway. Skirmish line formed in 700 block Broadway.

2248 – Starbucks store at 8<sup>th</sup> and Broadway vandalized.

2301 – Fire burning in roadway at 8<sup>th</sup> and Broadway.

2306 - Bottles thrown at officers on skirmish line.

2310 – Starbucks store being looted by protestors.

2314 – TNT making Unlawful Assembly announcements at 7<sup>th</sup> and Broadway.

2325 – Bottles and brick being thrown at officers.

2335 – OPD and CHP making arrests in 700 block Broadway.

2340 - TNT continuing with Unlawful Assembly announcements.

2343 - Protestors vandalizing and looting Smart and Final store in 800 block Broadway.

2349 – Brick thrown at officers at 8<sup>th</sup> and Broadway. Officer sustained facial injury from being hit with brick.

2353 – TNT continuing to give announcements (about 25 announcements given thus far).

2355 – Bonfire burning in roadway in 900 block Broadway.

2357 - Crowd of about 400-500 on Broadway from 8<sup>th</sup> to 10<sup>th</sup>.

0011 – Two looting suspects arrested by QRF at 11<sup>th</sup> and Clay.

0022 (25 Nov) – Full bottles of alcohol stolen from Smart and Final being thrown at officers.

0023 - OPD Tango Team and ACSO deployed smoke and gas munitions on crowd.

0025 – Crowd dispersing. Crowd of about 50 moving n/b Broadway from 12<sup>th</sup>.

0034 - Bonfire burning at  $11^{\text{th}}$  and Broadway.

0035 – Crowd at 13<sup>th</sup> and Broadway. ACSO deployed gas at crowd.

0036 -Crowd at  $14^{th}$  and Broadway.

0101 – Large bonfire burning at 16<sup>th</sup> and Broadway and crowd of protestors near the bonfire.

0107 - Crowd of about 100-150 dispersed in different directions north on Broadway and Telegraph from

 $16^{\text{th}}$  as officers moved toward them.

0114 – Group of 50 protestors at 19<sup>th</sup> and Franklin.

0118 – Four 594PC (spray painted building) suspects at 20<sup>th</sup> and Telegraph arrested.

0120 – Two trash can fires in the 2100 block Broadway.

0200 – No protestors/activity at FOP.

0233 – Operation summary: one officer injured and 37 arrests.

0315 – EOC secured/End of operation.

### **Operation 25 Nov 14**

1200 - Operations briefing: Alpha and Bravo Companies.

1400 – Operations briefing: Charlie Company. EOC is operational.

1500 – Operations briefing: Delta Company.

1627 – About 25 protestors (Uhuru Movement) at FOP with a bullhorn being used.

1653 - Crowd increased to about 50 protestors at FOP.

1700 – About 10 protestors with signs at the PAB. TNT contacted the group and they refused to discuss their plans.

1740 – About 100 protestors from FOP begin to march, moving s/b Broadway from 14<sup>th</sup> Street. About 20-30 protestors stay behind and remain at FOP.

1747 – The group at the PAB begin to move n/b Broadway from 7<sup>th</sup> Street.

1750 – The FOP and PAB groups now moving e/b 9<sup>th</sup> Street from Broadway (about 200 protestors).

1755 – Crowd moving s/b Alice Street from e/b 9<sup>th</sup>.

1800 - Crowd moving w/b 8<sup>th</sup> from s/b Alice (about 300 protestors).

1805 – Crowd moving n/b Broadway from w/b 8<sup>th</sup>.

1810 – Crowd moving n/b Telegraph.

1815 – Crowd moving w/b 19<sup>th</sup> from n/b Telegraph; heading toward freeway 980.

1820 – Crowd at 18<sup>th</sup> and Castro and they're running onto freeway 980; both sides/directions of 980 shut down by protestors.

1828 – Protestors leaving freeway at the 19<sup>th</sup> and Brush off-ramp.

1834 – The crowd split in two groups. The main group (Group 1) moving w/b 19<sup>th</sup> from Brush and the splinter group (Group 2) moving w/b 17<sup>th</sup> from Castro.

1835 – Mutual Aid activated by IC.

1840 – Group 1 moving e/b W. Grand from n/b Market and Group 2 moving e/b 16<sup>th</sup> from West.

1845 – About 30-50 protestors at FOP (Group 3).

1848 – Group 1 moving e/b W. Grand at Northgate and Group 2 moving e/b 16<sup>th</sup> at MLK.

1850 – Group 3 at FOP increased to about 100-150 protestors. Group 1 (about 70 protestors) moving s/b Telegraph from e/b W. Grand.

1859 – Group 3at FOP entered intersection at 14<sup>th</sup> and Broadway and were joined by Groups 1 and 2 bringing all groups together (total crowd size about 500-600 protestors).

1905 – Crowd moving s/b Broadway from 14<sup>th</sup>.

1915 – Crowd moving e/b  $9^{th}$  from s/b Broadway and then s/b Jackson from e/b  $9^{th}$ . OPD skirmish line at  $7^{th}$  and Jackson prevent crowd from entering freeway 880 at  $6^{th}$  and Jackson.

1921 – Crowd stopped in 700 block Jackson chanting and shouting at OPD skirmish line at  $7^{\text{th}}$  and Jackson. Some bricks were thrown at officers. TNT instructing crowd to move w/b  $8^{\text{th}}$ . 1923 – Another group of about 50 protestors at FOP.

1935 – Crowd at 700 block Jackson moving w/b 8<sup>th</sup> to n/b Broadway.

1943 – Crowd arrived at 14<sup>th</sup> and Broadway and one protestor burns a flag.

1948 to 1954 – Crowd moving w/b 14<sup>th</sup> from Broadway. OPD skirmish line set at 14<sup>th</sup> and Castro.

Crowd stopped at skirmish line at 14<sup>th</sup> and Castro and some throw rocks and bottles at officer.

2002 to 2009 – Crowd moving n/b MLK from 14<sup>th</sup> and then to 17<sup>th</sup> and Castro.

2017 to 2043 – Crowd of about 350 protestors move s/b Castro from 17<sup>th</sup>, then e/b 16<sup>th</sup> to n/b Clay, to n/b San Pablo to e/b W. Grand, to n/b Northgate. OPD set skirmish line at Northgate and Sycamore and some in crowd throws bottles at officers.

2044 to 2054 – Crowd moving n/b Telegraph. A dumpster is set on fire at Sycamore and Telegraph as well as garbage cans set on fire along Telegraph.

2056 – Crowd at 34<sup>th</sup> and Telegraph (Walgreens). Part of crowd ran behind the Walgreens and up the embankment leading onto freeway 580 e/b; all lanes of traffic on 580 e/b blocked by protestors. About 100-150 protestors stayed behind and remained at the Walgreens (34<sup>th</sup> and Telegraph).

2057 to 2105 – OPD and CHP contained the group on freeway 580 e/b and made arrests. Many protestors left the freeway and went down the embankment from which they came. Protestors threw rocks and

bottles at officers.

2117 – OPD continuing to make arrests on freeway 580 e/b for 647c PC (Obstruction of Street, Sidewalk or Other Public Place).

2121 – Remaining Walgreens crowd (about 100-200) moving n/b Telegraph toward W. MacArthur.

2124 – Crowd surrounds a CHP officer and vehicle in the 3700 block Telegraph and vandalizes the CHP vehicle.

2128 – CHP deploys gas on crowd.

2130 to 2140 – Some in crowd throw bottles and incendiary devices at officers in the area of W. MacArthur and  $40^{\text{th}}$  along Telegraph. Several fires are also started along Telegraph.

2143 - Unlawful Assembly announcements made by TNT at  $38^{\text{th}}$  and Telegraph.

2145 – Some in crowd breaking into the car dealership at  $40^{\text{th}}$  and Telegraph.

2148 – Crowd moving n/b Telegraph from  $40^{\text{th}}$ .

2150 – Some in crowd looting the Kelly Moore Paint store at 4156 Telegraph.

2155 – Unlawful Assembly announcements made by TNT at 40<sup>th</sup> and Telegraph.

2200 – Some in crowd looting the Walgreens and T-Mobile stores at 49<sup>th</sup>/50<sup>th</sup> Telegraph.

2210 - About 75-100 protestors in the intersection of  $40^{\text{th}}$  and Telegraph with a fire burning in the roadway.

2214 – Another group of protestors moving w/b  $55^{th}$  from Telegraph. Unlawful Assembly announcements made by TNT. Some in the crowd throw rocks and bottles at officers on  $55^{th}$  as they continued moving w/b  $55^{th}$  toward MLK.

2231 to 2236 – Crowd moving s/b MLK from 55<sup>th</sup>. An OPD Tango Team deploys a hand thrown CS Blast munition in to crowd.

2237 – Crowd moving w/b 53<sup>rd</sup> from MLK. Fire started in the intersection of 53<sup>rd</sup> and MLK.

2248 – Crowd moving s/b Market approaching 40<sup>th</sup>.

2300 – Crowd (about 200 protestors) moved w/b through various streets and ended up at 43<sup>rd</sup> and San Pablo. Some in crowd throw bottles at officers at 43<sup>rd</sup> and San Pablo. An OPD Tango Team deploys a Saf-Smoke munition in to the crowd.


