Street Sweeping in Oakland. The requester is hoping you can answer the questions about Oakland's street sweeping program.

1. What/who pays for the street sweeping program? **Street Sweeping is paid for through the Comprehensive Cleanup Fund.**
2. How is it determined where street sweeping occurs? **The Street Sweeping program was established in the fall of 1985 and certain areas opted out or were left out. Now neighborhoods have to use the petition process to get their street in the program. Those petitions must go to City Council to be approved.**
3. Where and how often does the street sweeper get emptied? **There are several staged areas that are used for the Street Sweepers to empty their loads in the area they are working. They will dump their loads two (2) to five (5) times in one shift depending on the cleanliness of the street.**
4. Where is all the debris/dirt collect deposited? **It is taken to a Waste Management facility in San Leandro.**
5. Does the street sweeper really pick anything up? **Yes, they do.**
