RE: 41 Temporary Taxi Medallions

To Whom It May Concern:

As you know, 41 Friendly Cabs are operating under temporary permits. The Oakland City Council authorized these temporary permits for a maximum of two years or until the legal case regarding ownership of the 41 Dolco permits is resolved (whichever is sooner). The first of the temporary permits will expire (by the passage of two years) on August 30, 2013. Please be advised that Friendly Cab must cease their operation of the vehicles operating under the 41 temporary cab permits in the order that the vehicles were cleared to operate. Please see attached schedule.

The first temporary medallions (TP # 19 & TP # 26) must cease operation by 4:30 p.m. on August 30, 2013 and the temporary vehicle permit and other indicia of being permitted ("City of Oakland Taxicab decal") shall be surrendered to our office by end of business on Friday, August 30, 2013. Any cabs operating under the other 39 temporary permits shall cease operation and have turned in all their indicia of being permitted, to our office by 4:30 p.m. on the "cease operation by" date shown on the attached schedule. If the "cease operation by" falls on a non-business day, the medallion shall be returned to us no later than the following business day.

Additionally, we understand that the lawsuit which Surinder and Baljit Singh filed in Alameda County Superior Court has resulted in a verdict last month, and it appears that the jury found the Singh's ownership claims to the 41 Dolco medallions is without merit.
