#### Summary:

On 13Nov11, at about 0950hrs, I was working as a solo Oakland patrol unit using the call sign 1L03. I was dispatched to [REDACTED] to investigate a report of a battery. Upon arrival, I made contact with VICT CHANG who wanted to file a report of a battery that occurred earlier this morning.

I noticed that CHANG had a 1 inch laceration near her left eye. I saw redness and bruising to her elbows. CHANG complaint of pain to her knees, back and neck. It appeared that CHANG had been involved in a physical altercation. CHANG refused any medical attention.

CHANG told me the following on a written statement: On 13Nov11, at about 0330hrs, CHANG had just attended a company party and gave [REDACTED] a ride home [REDACTED]. CHANG and [REDACTED] are [REDACTED]. When CHANG got to [REDACTED] house, CHANG asked to use his restroom. As CHANG was walking up the stairs to [REDACTED] house, [REDACTED] confronted CHANG.

CHANG knows the female as "Anahisa" and CHANG has never seen her before. CHANG understands that "Anahisa" is [REDACTED] "Anahisa" turns out to be SUSP ANAHI VASQUEZ [REDACTED].

"Anahisa" attacked CHANG and accused her [REDACTED]. "Anahisa" grabbed CHANG, pulled CHANG's hair, kicked CHANG about 10 times, and punched CHANG numerous times. "Anahisa" eventually let CHANG go and CHANG was able to leave and drive home. CHANG wants to press charges. See her statement for further.

Technician K. Potter was on scene and took photos of the incident.

There are no known witnesses at this time.

I gave CHANG information on how to obtain a restraining order.
