Summary: On this date at approximately 1525 hours I was assigned to the patrol division as unit "2L30". I operated from fully marked vehicle number 1530 wearing full police uniform. I responded to the 2100 block of 50th Ave to meet with homicide Sgt(s) E. Joyner and E. Sherman (in regards to an earlier incident #1491).

Upon arrival I observed four Oakland PD semi-marked police vehicles parked in front of 2171 50th Ave. I also observed an Oakland Fire Department Arson Investigator vehicle and an OPD technician vehicle. Sgt. Joyner advised me that he and other OPD CID investigators were conducting a search pursuant to the service of a search warrant at 2171 50th Ave. I recognized the residence as one that had been recently reported to OPD as being burned by an arsonist in a "firebombing". There is a current investigation being conducted by OPD felony assault/arson investigators (OPD RD 97-62510).

I noted that the house was a white colored single family dwelling with extensive fire damage through out the front of the house. The north/side front window was covered with plywood. The front door and what appeared to be an additional front window were also boarded up with plywood. The plywood covering the front door had been removed allowing access to the residence.

Sgt. Joyner advised me that while serving a search warrant at 2171 50th Ave they discovered what appeared to be a human body in a freezer box. (The warrant was completed by OPD Sgt M. Foster and signed by the Honorable Cecilia Castellanos this date at 0845 hours.)

At approximately 1545 hours I was directed into the residence by CID Capt. P. Dunbar. Capt. Dunbar instructed me to complete a police report on the matter. Capt Dunbar directed patrol Sgt Wallace and I into the residence. Upon entering I saw what appeared to be the front room of the residence. I saw extensive fire damage and debris strewn about the floor. Approximately 15 feet from the area of the front door I observed a doorway, this led to what appeared to be the kitchen. There was extensive fire damage in the kitchen, I observed a burned stove, counter tops, sink, refrigerator and freezer box (all had fire damage). The freezer box was to the left of the front door (west.) of the refrigerator. (cont)

(cont) The freezer box was approximately 4 feet in length 3 feet high and 2 feet deep. The freezer box was damaged by fire, and it was opened. Inside the freezer box I observed what appeared to be a human body or a portion of one. I observed what appeared to be a human hand, arm and torso. The arm was at the north portion of the freezer box. There was no movement or signs of life, it was obvious the person was deceased. There appeared to be swelling to the arm and torso. It appeared that there was a light brown/yellowish "rubber" layer on top of the body. The layer appeared to have melted on the body. The body was in the process of decomposition.

At this point I secured the residence and monitored the activities of investigators at the scene. Based on the current arson investigation, which included numerous neighborhood interviews I was instructed by investigators not to conduct an area canvas.

I was advised by Sgt Joyner that the body was discovered by Sgt Sherman, Arson investigator Brandle and himself at 1531 hours.

At approx. 1602 hours Lt(s). Lacer and C.D. Williams conducted a search of the rear yard of the residence.

At approx. 1615 hours Oakland Fire Investigator M. Christian arrived at the scene to assist with the investigation.

At approx. 1625 hrs Oakland Fire Department truck number 2576 arrived at the scene. OFD Capt. G. Berry was in charge of the truck crew, they assisted by removing plywood from the windows of the residence. This was done to allow natural sunlight to enter the residence. The OFD crew was also summoned to bring artificial lighting equipment to the scene.

At approx. 1643 hours OPD Sgt. G. Hughes arrived at the scene to assist with the investigation.

I was notified by Sgt Sherman that Lt. Lacer had contacted the Alameda County Coroners office. At approx. 1704 hours Deputy Coroners Lawson #9 and Wilson #16 arrived at the scene. Based on the condition of the body in the freezer they determined they would need a different vehicle to transport the body. An additional coroner with a different vehicle was summoned by them.

At approx. 1707 hrs the assigned OPD homicide investigators Sgt(s) M.Foster and B.Brock arrived at the scene.

At approx 1820 hours Alameda County Deputy Coroner S.Gibb arrived at the scene, at 1830 hours Gibb entered the residence. OPD Patrol officer J.Oare assisted in securing a "dolly" to move the freezer box with the body. At 1853 hours the coroners removed the freezer with the body from the residence.

Based on OPD investigators receiving a police report from the Scotts Valley Police Department documenting that Allman Stevie was a missing person, it was suspected Allman was the person in the freezer box. It was also determined that the cause of death was unknown based on the position of the body and the natural process of decomposition. Based on the fact that the body was placed in a small freezer box and had been in a fire caused by arson it is apparent that Allman's death was due to foul play.

OPD patrol technician M.Gribi was at the scene for the collection of evidence, photographs and scene diagrams.

On 15Jul97, at about 1430 hours, I was assigned to the Criminal Investigation Division Homicide Section as a Sergeant/Investigator. Sergeant E. Joyner III was working as my partner and we went to a residence located at 2171 50th Avenue to assist with serving a search warrant. The warrant was prepared by Homicide Sergeant Michael Foster of the Oakland Police Department and signed on 15Jul97, 0845 hours, by Magistrate Cecilia Castellanos in the Municipal Court of the Oakland - Piedmont Judicial District, County of Alameda, State of California.

The residence at 2171 50th Avenue was the location of an arson fire on 1Jul97, RD# 97-62510. The residence had received severe structure damage and the entry and exit areas to the residence had been boarded up.

Prior to entering the residence Sergeant E. Joyner, OFD Arson Investigator M. Brando, and I were briefed on the search warrant by Lieutenant C.D. Williams. At about 1531 hours Joyner, Brando, and I entered the residence and began to conduct a search of the premises for property and things listed on the search warrant.

While searching the kitchen area I detected a strong odor of decay coming from a freezer located next to the south wall of the kitchen. The freezer appeared to have been damaged by fire. Brando lifted the lid and I examined the interior along with Brando, Joyner, and evidence technician M. Gribi. At this time I along with Brando, Joyner, and Gribi, observed the remains of a human body inside the freezer. The body was badly decomposed and the person was obviously deceased. The body was burned and concealed and there were obvious signs of foul play. The findings were reported to Lieutenants C.D. Williams and R. Lacer who were present at the scene.

At 1545 hours, Lieutenant R. Lacer notified and requested the Alameda County Coroners Bureau to respond to our location.

The search of the premises at 2171 50th Avenue was completed and Officer G. Galindo arrived at the residence and prepared an offense report.

At 1704 hours, Deputy Coroners J.D. Lawson and D.L. Wilson arrived and took custody of the body.
