ORDINANCE No. 11322 C. M. S.

AN ORDINANCE AMENDING PORTIONS OF ARTICLE 7, CHAPTER 6 OF THE OAKLAND MUNICIPAL CODE INCREASING THE SEWER SERVICE CHARGE

WHEREAS, the City was ordered by the United States Environmental Protection Agency and the Bay Area Regional Water Quality Control Board to eliminate wet weather overflows from public sanitary sewers; and

WHEREAS, the City has prepared a Compliance Plan to eliminate these overflows; and

WHEREAS, such Compliance Plan involves large expenditures of public funds; and

WHEREAS, the Council of the City of Oakland on June 23, 1987, previously approved in Ordinance No. 10877 C.M.S., a negative declaration for the sanitary sewer inflow/infiltration (I/I) rehabilitation program; and

WHEREAS, the City Council finds and determines that the requirements of the California Environmental Quality Act (CEQA) of 1970, the Guidelines as prescribed by the Secretary for Resources, and the provisions of the Statement of Objectives, Criteria and Procedures for Implementation of the California Environmental Quality Act: City of Oakland, have been satisfied, and this action on the part of the City Council does not constitute a project under CEQA pursuant to California Public Resources Code section 21080(6)(8); or in the alternative, that if this Ordinance is a project subject to CEQA that the Council has determined with certainty that no possibility exists that this Ordinance may produce significant environmental effects;

The Council of the City of Oakland does ordain as follows:

SECTION I:

SECTION 6-7.02 IMPOSITION OF SEWER SERVICE CHARGE IS AMENDED AS FOLLOWS:

SEC. 6-7.02 IMPOSITION OF SEWER SERVICE CHARGE. Every party in whose name sewage disposal service of the East Bay Municipal Utility District (District) is granted shall pay a charge for billing periods that begin on or after June 1, 1991, as herein provided for the use of sewer facilities owned and operated by the City.

- (a) A monthly charge of Nine Dollars and Thirty-Six Cents (\$9.36) is hereby established and assessed for the use of sewer facilities for every single-family residence as defined by the District's Business Classification Code 8800, Private Residence.
- (b) For multiple-family dwellings, as defined by the District's Business Classification Code 6514, Multiple Dwelling, the following monthly charges are hereby established and assessed for the use of sewer facilities:

Duplexes:

Ten Dollars and Fifty Cents (\$10.50) per month

Triplexes:

Fifteen Dollars and Seventy-Five Cents (\$15.75) per month

Fourplexes:

Twenty-One Dollars (\$21.00) per month

(c) For residential premises not included in (a) or (b) above, a charge based upon the cubic feet of water used on the premises will be made for the use of sewer facilities, which charge shall be computed and levied as follows:

Sixty-Four Cents (\$0.64) per 100 cubic feet per month.

In no case shall the total monthly charge be less than Nine Dollars and Thirty-Six Cents (\$9.36).

(d) For premises in the District's "Commercial," "Industrial," and "Public Authority" business certifications, a charge based on cubic feet of water used upon the premises will be made for the use of sewer facilities, which charge shall be computed and levied as specified below:

Industrial Accounts: Fifty-Eight Cents (\$0.58) per 100 cubic feet per month Commercial Accounts: Sixty-Four Cents (\$0.64) per 100 cubic feet per month Restaurants/Hotels: Sixty-Seven Cents (\$0.67) per 100 cubic feet per month Hospitals: Seventy-One Cents (\$0.71) per 100 cubic feet per month Laundromats/Carwashes: Seventy-Five Cents (\$0.75) per 100 cubic feet per month

In no case shall the total monthly charge be less than Nine Dollars and Thirty-Six Cents (\$9.36). Attachment A, attached hereto and made part hereof, details the rate charged each of the District's 88 Business Classification Codes (BCC).

(e) For premises with a sewage meter for measuring actual sewage flow from such premises, a charge based on cubic feet of measured sewage flow from the premises, and applicable to all buildings for water consumption cycles commencing on and after June 1, 1991, will be made for the use of sewer facilities, which charge shall be computed and levied as follows:

Seventy-Eight Cents (\$0.78) per 100 cubic feet of sewage flow per month.

In no case shall the total monthly charge be less than Nine Dollars and Thirty-Six Cents (\$9.36).

- (f) The sewer service charges established and assessed in sub-paragraphs (c) and (d) shall be applicable to premises where no meter is installed or available in said premises for measuring the volume of sewage from such premises into sewers. The sewer service charge for these premises shall be based upon the total amount of water used from all sources, as ascertained by the District, for sewage disposal service charges imposed by such District within the City.
- (g) The sewer service charge established and assessed in sub-paragraph (e) shall be applicable to premises where a portion of the water received from any source does not flow into sewers because of manufacturing or removal by other means and a meter is installed or available in said premises for measuring the volume of sewage from such premises into sewers. The sewer service charge for these premises shall be based upon the volume of sewage discharging from such premises into the sewers, as ascertained by the District for sewage disposal service charges imposed by the District within the City.
- (h) The charges established and assessed in sub-paragraphs (a), (b), (c), (d) and (e) shall become due and payable on receipt of bill therefore. Such charges shall be paid directly to the City or to the District, as directed upon the bill.

SECTION II:

Oakland Municipal Code Section 6-7.01(e) is hereby deleted.

SECTION III:

The City Council makes the following findings in support of adoption of this Ordinance, as required by California Public Resources Code Section 21080(b)(8):

The sewer rate increases are for the purposes of:

- a) Obtaining funds for capital improvements necessary to maintain services within the existing service areas in order to comply with the California Regional Water Quality Control Board's Order No. 84-67 ("Compliance Plan"), and
- b) Meeting operating expenses of the Compliance Plan, and
- c) Purchasing or leasing supplies, materials and equipment of the Compliance Plan.
