By THOMSON, MITCHELL S: 2/27/2014 8:35:08 AM Checked the property on 2-26-14. Requested by Matt of Elite Tree Service. He asked for feedback before applying for a tree permit. I told him:	
1. The Douglas fir would not be approved if removal was requested. The tree was in good health, adequate distance from home, no structural defects. Limbs do fall when winds gust 50-60 mph, difficult to prevent, and unreasonable to remove a healthy tree in order to prevent limb failure in high winds.	
2. Coast redwood would be approved. The top of the central leader was dead, the upper 20 feet, with no other flagging in the crown. The condition of the tree was not an emergency situation and a permit waiver was not warranted.	
3. The incense cedar in the front yard would be approved. The growing space was insufficient for the root system; the front walkway and steps to the home were being lifted. The tree had poor structure, multiple stems, and one dead stem (about 12" diameter). A limb fell from the tree in the November 2013 wind storm and killed a person. I would issue a waiver if he asked for it, otherwise it would be approved with the redwood on the same permit.
