Part 5 - Level 4 Narrative

On 14 May 2012, at about 1140 I was working as OPD patrol unit 1L08. I was wearing full police uniform and I was driving full marked police vehicle #1840. I responded to 389 Belmont St to cover Ofc. G. Bellusa who was investigating a report of a unsecure residence. Upon our arrival we approached and observed that the front door appeared to be kicked in. Ofc. Bullusa and I entered the apartment with or duty weapons out and began to clear the apartment. When we opened the front door we could see that the apartment appeared to be very small. As we were clearing the apartment I
observed a MB 5'9" tall approx 50 years and naked (was the occupant of the bathroom. Due to the fact that the front door was kicked in and that it was unknown at the time that was the occupant of the apartment I intentionally pointed my duty weapon at him. Ofc. Bellusa also pointed his duty weapon at I gave several commands and he complied. Due to the fact that was naked and did not appear to be armed, I lowered my duty weapon to a low ready until Bellusa handcuffed him.
advised us that he was the owner of the apartment and had his ID with his name and the address on it. also advised us that he kicked the front door open last night while he was drunk. was then taken out of the handcuffs was asked if he needed any medical attention. stated that he was fine and that he just drank way too much last night.
There was no other force used on the py me or Ofc.Bellusa.
was not injured during this incident.
Sgt. Chan was notified of the use of force.




