Ms. Santana,

On 17 OCT 2013, I received a phone call on my personal cell phone advising me that I was going to be "Walked out of the building" upon returning for the eventing from an unknown caller who identified his self as a friend of a friend before abruptly hanging up. Immediately I call my union rep Terry Meadows and advised of the call.

While at home yesterday from a blocked number, I received yet another call which advised me not to show up at work today or in the future. I have no idea if these are pranks or what, but I have also warned both Employee Relations and others in positions of authority of the ongoing harassment/threats that I have received since having made contact with you in February 2012 regarding issues of concern throughout the Oakland Police Department.

The harassment over the air on the police radio has become so obvious until various command officers have either made suggestions to me as to how to address them or if I would like for them to intervene. AT what point does it stop.

I have NO idea what awaits me at OPD this morning, but nevertheless the calls are not enough to deter me.
