Summary:

On 10 May 15, at about 1957 hours, I was working as OPD patrol unit 2J30, with Ofc R. Curtin 8973. We were both wearing full police uniform and I was driving a fully marked patrol unit 1491. Radio dispatched us to 10555 105th Ave, to investigate a report of a battery.

Upon arrival. I made contact with (S1) [REDACTED] who stated that she and her friends were eating inside the restaurant. When (S1) [REDACTED] got into an argument with one of the waitress. (S1) [REDACTED] advised the argument escalated into a physical fight between them. (S1) [REDACTED] does not want to press battery charges against the waitress. (S1) [REDACTED] had some small scraps on her left knee but did not sustaining any serious injuries.

Ofc R. Curtin made contact with the (V1) Guerrero, Lourdes, who told him today, she was working as a waitress at ROSITA'S RESTAURANT, when she got into an argument with a female customer (S1) [REDACTED] who appeared to be drunk. (V1) Guerrero advised the argument escalated into a physical altercation. (V1) Guerrero was not injured during the fight and does not want to press charges against (S1) [REDACTED] for battery. (V1) Guerrero just want (S1) [REDACTED] to leave the restaurant and don't come back.

I advised (S1) [REDACTED], she is not welcome to returned back into the restaurant and that (V1) Guerrero is not pressing charges.

(S1) [REDACTED] got a ride from a friend and left the scene with no further incident.

I provided (V1) Guerrero with a yellow resource card and instructed her on how to obtain a restraining order. I advised (V1) Guerrero if (S1) [REDACTED] return to the restaurant to give OPD a call.
