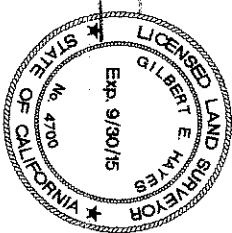

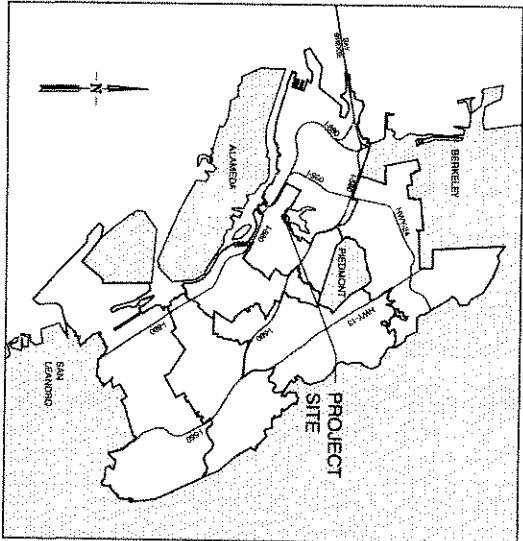

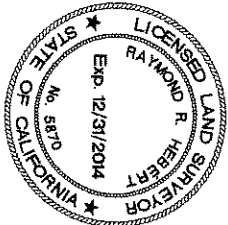
VICINITY MAP

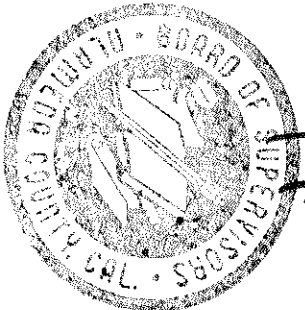

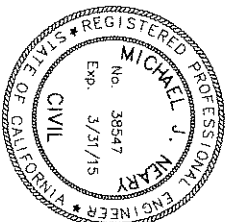

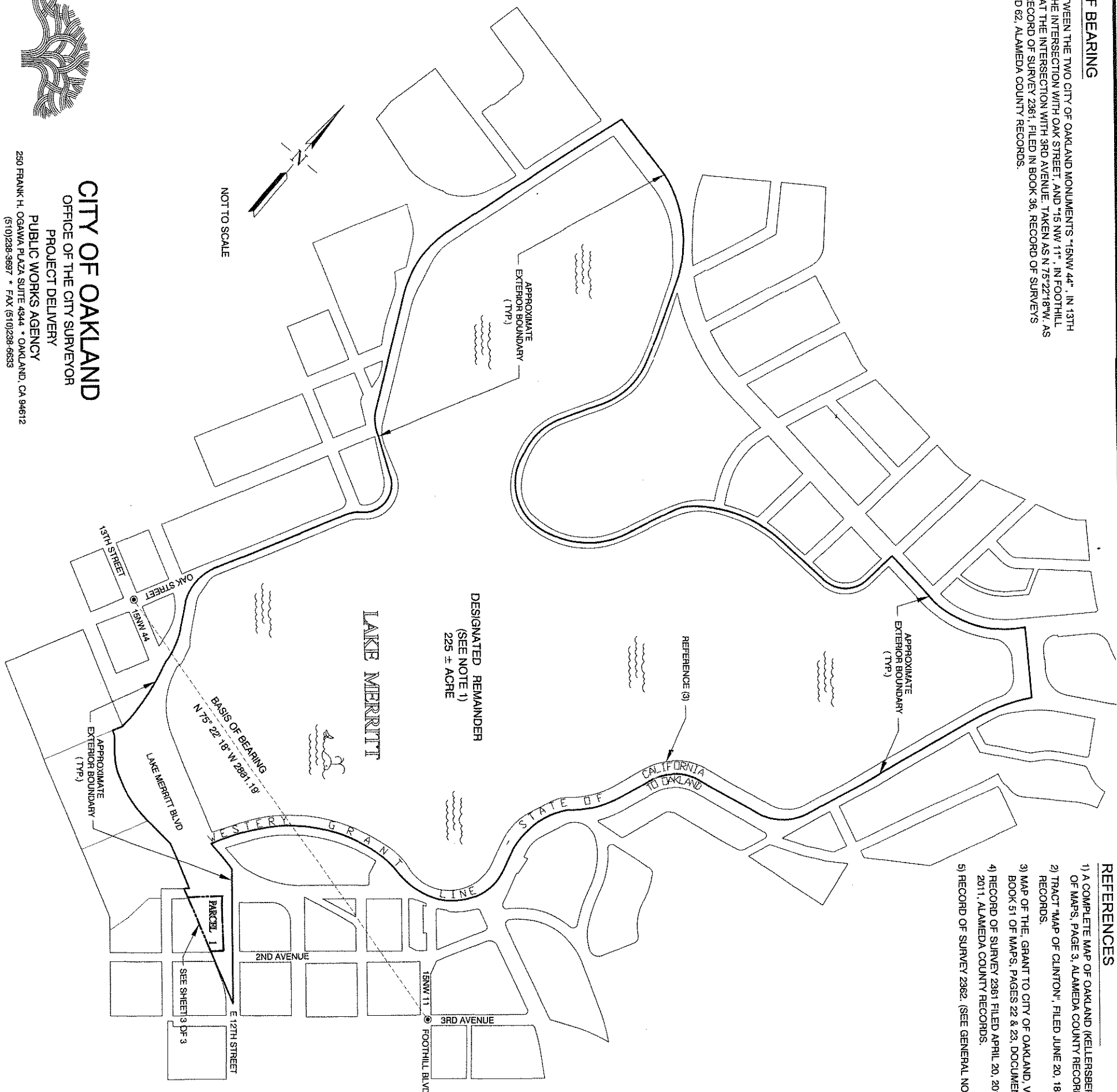

- 1) DESIGNATED REMAINDER OF THIS MAP INCLUDES SURROUNDING AND CONTIGUOUS PROPERTY, INCLUDING LAKESIDE PARK, LAKE MERRITT, AND VARIOUS STREETS GIVEN TO THE CITY IN THE 1800S, ALL OF WHICH ARE OWNED BY THE CITY OF OAKLAND PER REFERENCES (1), (2), AND (3) HEREON. THIS PROPERTY IS IN EXCESS OF FIVE ACRES AND IS REFERENCED AS A "DESIGNATED REMAINDER" BY THIS MAP. UNDER PROVISIONS OF 66434.E, AND 66445 (2) OF THE BUSINESS AND PROFESSIONS CODE OF THE STATE OF CALIFORNIA (AKA, SUBDIVISION MAP ACT), THE REMAINDER PARCEL NEED NOT TO BE SHOWN UPON THIS MAP AND, AS SUCH, IS REFERENCED BY GENERAL AREA ONLY, HEREON.
- 2) GENERAL INTENT: THE CITY OF OAKLAND, AFTER MAJOR REALIGNMENT OF ROADWAYS AND STREETS ALL WITHIN THE CITY OWNED RIGHT-OF-WAY, HAS DETERMINED THAT THERE IS A SECTION OF SURPLUS LAND THAT IS NO LONGER NEEDED AS A CITY ASSET. THE INTENT OF THIS MAP IS TO DESCRIBE THAT PORTION OF THE LAND LYING WITHIN THE CITY PROPERTY AND CREATE A SEPARATE LOT FOR FUTURE TRANSFER.
- 3) RECORD OF SURVEY 2362 (SHEET 2 OF 3, REFERENCE 5) IS CURRENTLY BEING PROCESSED BY THE OFFICE OF THE CITY SURVEYOR OAKLAND, CALIFORNIA, AND REFERENCES THE MONUMENTS CITED, THIS DOCUMENT, THOUGH NOT RECORDED AT THIS TIME, IS CITED HEREIN IN THE INTEREST OF CONTINUITY.
