Summary:

On 09 Jan 10, at about 2350, Officer C. Del Rosario and I were working as OPD Patrol Unit 6A02. We responded to the intersection of 11th St and Clay St to investigate a report of a battery.

We met with OP-1 SCOTT, Angelique who told us that an employee (later ID'd as OP-2 HAGOS, Abraham) at Arismona Restaurant (located at 561 11th St) slapped her hand. SCOTT stated that she was at Arismona on 09 JAN 10 at approximately 2320 Hrs with friends when she decided to go outside to get some air. SCOTT was with a friend in the elevator. A security guard (referring to HAGOS) was also standing in the elevator and would not let SCOTT close the door nor exit. SCOTT hit the alarm on the elevator because HAGOS would not let her out. HAGOS got upset and hit SCOTT's left hand with his open hand. HAGOS exited the elevator. The elevator door began to close and HAGOS returned, placing his hand in between the doors which made to doors open. SCOTT again hit the alarm and HAGOS again slapped SCOTT's hand. SCOTT and her friend were finally able to exit the elevator then flagged down a police officer to report the incident. SCOTT was injured from the incident and wanted to press charges against HAGOS. See written statement for further details.

We spoke with HAGOS who was on scene. HAGOS stated that he was working at Arismona's Night Club on 09 JAN 10, at approximately 2340 Hrs. He was working on the top floor as the door man. HAGOS saw a female black (referring to SCOTT) attempting to take the elevator to the first floor. HAGOS stated that the elevator is only used to go up to the second floor, and the stairs are used to go down to the first floor. HAGOS stated that he explained this process to SCOTT who became extremely angry with him. SCOTT pushed HAGOS and said, "I spent \$200.00 here." The elevator door began to close and SCOTT pushed HAGOS back. HAGOS stood back in front of the door and told her to stop. HAGOS again yelled for her to stop and put his hand in front of him to prevent SCOTT from hitting him. SCOTT told HAGOS, "I am an attorney and I have the right to" as she pushed the fire alarm button. HAGOS told her to stop and put his hand on the elevator button to stop her from hitting the fire alarm again. SCOTT kept yelling at him so he let her go. HAGOS wanted to press charges against SCOTT for pushing him. See written statement for details.

Due to the fact that SCOTT and HAGOS claim that the other person physically assaulted them, no officers observed either reported charge of battery, both SCOTT and HAGOS wanted to press charges against the

On Summary:

On 19Nov10 at approx 2200hrs, I was conducting a joint operation with State of California agencies; Alcoholic Beverage Control (ABC) and Bureau of Security and Investigative Services (BSIS). The goal of our operation was to identify locations and employees who work or employ persons for security purposes and to audit their security credentials.

At approx 2330hrs we relocated "Arsimona" located at 561 11th St. From our experience in ABAT, we knew that Arsimona operates business with a full security staff between 4-6 guards. We also were aware that prior security staff have been illegally armed. Numerous complaints have been generated that person(s) with suits are armed inside this premises. An OPD report (09-063459) from Sep 09' indicated that during that operation "VMA" security guards (Owned by the security staff was still employed by VMA or if a different company had provided the guards.

Undercover officers attempted to enter the establishment. The first security guard (later id'd as Bowden) was located positioned at the front door on the Clay St side of the club. Bowden was dressed in a suit, with a gold "Security Guard" badge. Bowden was checking id's and conducting PAT DOWN searches on male patrons.

As undercover officer(s) made entry, three other security guards were observed posted throughout various locations. All of them were dressed in plainclothes (no security guard uniforms) and had a gold badge either on the inside of their coat, on the vest or clipped to their belt.

As the undercover officer(s) exited the premises, I provided the location and descriptions of the guards (as given by the UC's) to the uniformed officers and investigators of BSIS. We made entry and contacted three identifiable security guards. Sgt Johnson contacted "Teddy" (later id'd as Kiflit, Tedros, licensee) Sgt Johnson advised Kiflit of our operation and requested that he gather his security guards and requested that they be escorted to the office.

Once all the security guards were present in the office. I asked if any guards were armed. Lyons, Corey replied that he was, and that he had a valid firearm permit. Lyons was disarmed by Ofc Albert for the safety of officers and BSIS investigators who are unarmed. I then explained the operation and introduced the investigators from the Bureau of Security and Investigative Services (BSIS).

I conducted an investigative field interview with Bowden. BSIS Inv Ziegler was informed that Bowden was conducting PAT searches, checking ID, was wearing a badge and claimed to be an employee of the club. Based on the fact that Bowden claimed he was an employee of the club and was paid by check, Inv Zeigler originally determined that Bowden did not need to possess the PSO Guard Card and was not to be cited. I informed Bowden that he could return back to his post. It wasn't until later when BSIS Inv. Taeza interviewed Kiflit and found out that Bowden was not on the Arsimona payroll and received 1099 tax forms, Bowden was then issued a citation #4964341 by Ofc Dolan for not having the required guard card.

During the same time, Ofc Albert conducted an investigative interview with Lyons. Ofc Albert informed BSIS Inv. Williams that Lyons was performing security duties, wearing a gold badge, had a firearm concealed under his coat along with 3 magazines, a baton and OC spray. Ofc Albert also informed Inv. Williams that Lyons was in possession of a valid "Permit For EXPOSED Firearm," "Baton Permit," and "OC Pepper Spray Permit." Inv Williams determined that Lyons was not in possession of the required guard card, had his firearm illegally concealed and also informed Ofc Albert that Lyons shall been dressed with a distinctive uniform with badge and patch. Ofc Albert issued Lyons citation #4856676 for the three listed violations. Lyons refused to give a written statement regarding this incident. Lyons did say that this was his second violation and was going to loose his guard license. Ofc Albert turned the firearm and magazines into OPD Property as Evidence. Lyons was given his Baton and OC Spray.

I contacted the third guard who was identified as Sherrard, Eddie. Sherrard admitted that he was performing security duties and was wearing gold star badge pinned to his vest. Sherrard stated that he was paid cash for his services and was not on the Arsimona payroll. BSIS Investigator Taeza requested that I cite Sherrard. Sherrard refused to give a statement, I issued him citation #4964340 for not having the required guard card.

BSIS Investigators conducted an interview with Kiflit, Tedros (see their reports for details) and requested that

OPD issue Kiflit a citation for hiring unlicensed security. I issued Kiflit citation #4887847. Originally Kiflit refused to sign the citation and was repeatedly asking why he was being cited. Finally after several explanations, Kiflit signed his citation.

Based on my training, knowledge, complaints and previous reports, I respectfully request that all individuals be held responsible for their actions to the fullest extent possible. This has continued to be an ongoing problem at this location.

There were no complaints or uses of force on this incident.

Sgt L. Johnson was on scene and approved the arrests/citations.

Ofc Eggers took a written statement from V1 who told him the following details. V1 stated that today around 0100hrs he was working as security at Arsimona in Oakland. He noticed S1 sitting on a table inside the club. He approached her and asked her to get off the table. V1 explained to her his role as security and she started talking back to him. V1 stated that he asked S1 to leave the club and she refused. V1 grabbed her by her upper arm and began to escort her out of the club for breaking the rules. While he was walking her out she turned, faced him and kicked him in the groin twice. V1 then placed her under citizens arrest and put handcuffs on her. V1 then walked her outside and transferred custody of S1 to police. V1 Stated that he wants to press charges on S1 and will assist the prosecution. (See statement for further information)

V1 told me that he was not injured and did not need medical attention.

On 02 May 12, at around 0030 hours, I was working as OPD patrol unit 3A03 with Ofc. N. Walker 8938. We were both wearing full police uniform and Ofc. Walker was driving OPD patrol unit 1765. At about this time we responded to 561 11th St. (Arsimona Bar and Grill) to investigate a report of a customer who was detained by security for paying with a counterfeit \$100.00 bill.

Upon arrival we contacted Security Manager (W-1) who had a male Hispanic, later identified as Granados, Jose (S-1) detained in plastic handcuffs IFO 561 11th St. W-1 stated that S-1 had purchased drinks from the bartender and paid with a counterfeit \$100.00 bill. W-1 stated that he wanted S-1 arrested. W-1 later told me that when he confronted S-1 about the counterfeit bill, S-1 admitted that he knew it was fake.

I later took a written statement from W-1.

I asked S-1 if he knew that the \$100.00 bill was fake and he stated that he had bought the bill for \$80.00 from someone. At this time I realized that S-1 was extremely intoxicated with a strong odor of alcohol from his person, slurred speech and bloodshot/watery eyes.

W-1 gave me the \$100.00 bill that S-1 had used to purchase drinks from the bar. I noticed the weight of the paper seemed lighter than standard U.S. Currency and it appeared to be counterfeit.

At this time S-1 was placed under arrest for 470(A)PC, Forgery with the intent to defraud. Ofc. Walker searched S-1 incident to arrest and placed him in the rear of our patrol car. S-1 stated the handcuffs hurt at which point we removed S-1 from the back seat and applied a second set of handcuffs making it more comfortable for S-1. I checked the handcuffs for proper fit.

Officer Walker contacted Bartender (W-2) who stated the following:

On 2 May 2012, at about midnight, W-2 was working as a bartender as Arisona Bar and Grill when S-1 ordered two drinks from W-2 and paid with the counterfeit \$100.00 bill. W-2 stated he knew the bill was counterfeit because of the texture and appearance of the bill. W-2 stated he has been a bartender for a long time and always hold money to a micro screen to determine if it is real. Once W-2 realized the bill was counterfeit he notified security.

Ofc. Walker to a written statement from W-2.

I did not admonish S-1 because he was extremely intoxicated and stated several times "I plead the 5th.".

W-1 signed the Arrest Report (CAR).

We transported S-1 to North County Jail.

Based on evidence along with W-1 and W-2's statement I believe S-1 knowingly purchased alcohol from W-2 at Arsimona bar and Grill using a counterfeit \$100.00 bill completing the crime of 470(A)PC (Forgery with the intent to defraud).

I-was treated in the most inhuman way at the Arsimona night Club in Oakland. I was verbally and physically assaulted by the security and management, and my belongings were stolen. I sincerely do not understand what I did to deserve this.

Around 11:30pm on Saturday night, I decided to get some air because the inside of the club was getting too hot. Before I left, the guy at the entrance gave me a ticket (to prove I had paid) so I can

get back in. I showed my ticket to the first bouncer who let me in but then the second bouncer pushed me away and said I cannot get back in. I told her that I had my purse and my jacket inside but she yelled that I needed to leave and she could not understand my

During the next 3 hours, I kept begging them to let me in to get my belongings, but all they did is curse me out and ask me to leave. At that point, I was so confused by what was happening to me. I then called Oakland police and told them the situation. They said they will send somebody. Finally, around 3 am, when the club management let me back in, I could not find my purse and my

Note that as I was looking for my stuff, the security was on my back asking me to leave. At that point, I bursted into tears and the owner, and the managers came over. I asked them why I was being treated like dirt for no reason. They started yelling at me and the owner told me: "Bitch, get out," and spits in my direction.

I went to my car around 3 am and around 3:30 am, a policeman called me and said the club had told him my friend had left with my belongings, which is a liel

Dear Policeman, I know you have a lot of cases but please consider also mine.

You might think I must have done something to deserve this, but I honestly assure you I did not do anything. I do not understand what gives the Arsimona club the right to abuse its customers. Thanks a lot for your understanding.

I have been suffering from insomnia/ anxiety since all this happened.

Summary

On 16Jun12, at about 0112 hrs, I was working as OPD patrol unit 3L04. I was wearing full police uniform and was driving fully marked patrol vehicle 1839. Radio dispatched me to 561 11th St (Club Arsimona) to investigate the report of a citizen holding a prisoner.

Upon arrival, I contacted (W-1) who works as the head security guard at Club Arsimona. W-1 advised he had a MB (later ID'ed as JORDAN, KEVIN (S-1) detained for Auto burglary. I observed S-1 was already in handcuffs when I arrived on scene. I took custody of S-1 and placed him in the rear seat of my patrol vehicle.

W-1 stated the following in summary:

W-1 stated on 16Jun12, at about 0100 hrs, he was working security at Club Arsimona located at 561 11th St. W-1 stated he checks on the Club's parking lot about three times a night to make sure there are no break-ins. While W-1 was checking the parking lot he noticed broken glass near a Newer Dodge Charger 4-D blu Lic #W-1 walked next to the car and noticed the rear passenger side window was broken. W-1 looked inside of the vehicle and observed an MB, wearing a blk hoodie, dk jeans, and blk shoes with tattoo's on his face laying down in the backseat trying to hide. W-1 told S-1 to exit the vehicle and he did. Once S-1 was out of the car W-1 asked if the car was his. S-1 told W-1 the car did not belong to him and he was hiding from someone. W-1 then told S-1 to put his hands behind his back and S-1 tried to move away. W-1 told him not to move or he would taze

S-1. S-1 stopped moving and W-1 handcuffed him.

W-1 stated he then called OPD. When OPD arrived he gave custody of S-1 to the police. W-1 stated before he called OPD he searched S-1 for weapons and found a metal screwdriver device in his front right pants pocket. W-1 stated he also located a social security card in the name of stated he will assist in the prosecution of S-1. (See statement for further details)

I recovered the spring loaded center punch tool and the social security card and turned them into OPD property section.

I took a written statement from W-1.

W-1 provided me with the screwdriver tool he recovered from S-1. I identified the tool as a spring loaded center punch tool. This tool is commonly used by emergency personnel to break glass.

I observed a 2006 Dodge Charger 4-D Blu Lic# in the parking lot of 561 11th St. The rear passenger door of the vehicle was shattered. There was broken glass on the ground outside of the vehicle as well as inside of the vehicle.

While I was on scene I was contacted by ABAI, SABA (V-1) V-1 stated she owns the vehicle but it is registered in her fathers name. V-1 stated she parked the vehicle in the parking lot of 561 11th St on 15Jun12, at about 2200 hrs. V-1 stated she had all of the doors locked and windows up. V-1 stated the vehicle did not have any broken windows when she parked the vehicle. V-1 did not give anyone permission to enter, use, or take anything from her vehicle. V-1 stated she wants to press charges and will assist in the prosecution.

Sgt D Ming (3L71) responded to the scene and approved the arrest.

I admonished S-1 who refused to give a written statement.

I transported S-1 to North County Jail.

Based on W-1's statement and my observations it appears, on 16Jun12, at about 0100 hrs, S-1 was in the parking lot of 561 11th St. S-1 used the tool he was carrying to break the rear passenger door of the above listed vehicle. S-1 then entered the vehicle and was caught by W-1 who was patrolling the area. S-1 was arrested for auto burglary and possession of burglary tools.

I did not locate any additional known witnesses.

NARRATIVE;

On June 21st, 2012, at around 0130 hours, I responded to 561 11th St. to investigate the report of an assault with the suspect being detained by security. The caller also stated the person being detained was pepper sprayed.

Upon arrival on scene Officer B. Estrada and I contacted the security guards at Arsimona Bar and Lounge. They were detaining a male white, later identified as Koplin, Jason, who appeared to suffering from the effects of pepper spray. Security guard Lyons, Corey verbally identified himself and stated that Koplin assaulted him and that he wanted him arrested.

As I spoke with security guard Lyons PMP arrived on scene. Officer Estrada escorted Koplin to the PMP ambulance and Koplin had his face washed with water. Security guard Lyons described the incident to me and then gave me a statement indicating that he wanted to press charges against Koplin for shoving him.

(V1) Lyons stated that he contacted the promoter (S1) Koplin and asked him to pay the owner of the club for the party. (S1) told (V1) that he did not have the money and that he would pay the owner in the morning. (V1) told (S1) that's not how it works and (S1) became hostile. (V1) stated that (S1) then intentionally bumped him in the chest. (S1) and (V1) then walked over to the club owner and (V1) then asked (S1) to pay the owner for the party. (S1) then bumped (V1) in the chest again. (V1) then stated that he pepper sprayed (S1) and (S1) ran towards the elevator where security caught up with him. (V1) stated that (S1) started to kick at security and then he was detained and handcuffed by several security guards. (V1) stated that he wants (S1) arrested for hitting him in the chest and he signed a statement and eventually a citation issued to (S1). (See statement)


As I spoke with (V1) Officer Estrada placed (S1) in the rear of my patrol vehicle when PMP finished washing his face with water. Officer Estrada then took a statement from Witness the club owner. Witness stated that (V1) asked (S1) to pay for the party he was throwing and (S1) stated, "Fuck that, I ain't paying shit!" (S1) then lunged at (V1). Witness stated that (V1) then peppered sprayed (S1) and then the rest of security detained and handcuffed (S1). (See statement)

(V1) attempted to detain (S1) to settle the bill and (S1) bumped (V1) in an attempt to leave the bar. (V1) feeling threatened pepper sprayed (S1) and detained him with the aide of other security guards. The police and medics were called to the scene and (S1) was treated by PMP with water.
