Upon my arrival I observed that security guards were waiting by the side of the building and had one person detained and handcuffed.

I made contact with the club manager, TEMESGHEN, KIFLIT (V1), who told me that he was assaulted by the club promoter, LEWIS, LLOYD (S1).

V1 said that on 14 DEC 13 at approx 2350 hrs he was told by security employees that the club promoter, LEWIS, was passing out flyers. V1 went to talk to LEWIS and told him that he could not pass out flyers while he was in the club, LEWIS, told him "Ok". V1 said that approx 30 minutes later, LEWIS came up to him, grabbed him by the arm and said "Don't you ever disrespect me like that again!" and struck him on the left side of his face with a glass cup. V1 fell to the ground and the security guards handcuffed LEWIS. V1 said that LEWIS told him "This isn't over, I'm going to get you!" in front of the security guards. V1 said that he was not hurt and did not need medical attention. V1 said that he wanted LEWIS arrested. Officer Petersen took a written statement from V1, see statement for details.

I contacted the security guards that had LEWIS detained and handcuffed. I took custody of LEWIS from them in order to further investigate the incident. I pat-searched LEWIS for weapons before placing him in the rear of my patrol vehicle, then put him in the back seat of my patrol car.

I re-contacted the two security guards who said that neither one of them witnessed the incident. Both security guards said that they saw LEWIS and TEMESGHEN together and they appeared to be joking around. The security guards said that they looked away for a brief moment and when they looked back, they saw LEWIS on top of TEMESGHEN. The security guards said that at first they did not know that LEWIS was the one that was fighting with TEMESGHEN since V1 and S1 have been working with each other for a few years. The security guards quickly grabbed LEWIS, handcuffed him and walked him out of the club. No statements were taken since they did not witness the incident.

LEWIS said that the security guards also ran up to them, handcuffed him and took him out of the club. LEWIS said that he wanted TEMESGHEN arrested for elbowing him on the chest. See written statement for details.

I did not observe any visible injuries on LEWIS. LEWIS said that he was not hurt and refused medical aid.

I contacted the head of security who confirmed that he had asked LEWIS not to pass out his flyers inside the club but to wait to pass them out as the customers left the club.

Although LEWIS claimed that his door manager had witnessed the incident, the door manager said that he did not witness the incident.

Tech Ellis J was on scene and took photographs of TEMESGHEN and LEWIS.

It appears that on 15 DEC 13 at approx 0015 hrs TEMESGHEN and LEWIS got into a heated argument over the fact that LEWIS (and his crew) were passing out flyers promoting a new year's party at a different venue while they were at the Bella Ultra Lounge Club and the fact that TEMESGHEN threw the flyers in the trash. The argument became physical, LEWIS threw TEMESGHEN to the ground, jumped on top of him and began punching him on the face. The bar manager saw LEWIS punching TEMESGHEN on the face so he ran up to them and pulled LEWIS off of TEMESGHEN. Club security also ran up to them, handcuffed LEWIS and took him out of the club.

Although TEMESGHEN said that LEWIS punched him on the face with a glass cup, I did not observe any injuries on his face that were consistent with being struck on the face with a blunt object (there was no swelling, reddening, cuts on the inside or outside of his cheek). Although LEWIS claimed that he was defending himself after TEMESGHEN elbowed him on the chest, he clearly stated that he pushed TEMESGHEN causing him to fall to the ground. At that point TEMESGHEN was no longer a threat to him and he could have walked away but instead LEWIS jumped on top of him and began punching TEMESGHEN the face until the bar manager and security pulled him away.

Based on the above and the fact that TEMESGHEN wants to press charges, I cited LEWIS for Battery (242 PC). LEWIS signed the citation and he was released on scene (since the assault was not likely to continue).
