Hello Ms. Marcus,

This is in response to the letter received on July 18 2010 from your office of an alleged excessive noise generated by our leaving patrons. We take this matter very seriously. We have 6 to 8 security staff on duty during our weekly evening events. We escort all patrons out to their vehicles. Security staff cannot leave unless street and sidewalk is clear of all our patrons. We run last call by 1:15 to 1:20am and escort patrons out by 1:30 to 1:45am. This has been our normal business procedures for the past 5 years. We take great pride in who comes in through our doors on a weekly basis. We have a strict dress code policy enacted to deter any "problem" patrons & a reputation for many "entry" denials. We block off both sides of 11th & Clay street on busy nights for the city(not Arsimona) to direct all traffic coming from 10th street(right at the heart of all noise comments). All downtown Oakland night patrons use 10th street to access freeway. But Ms Marcus, we do have new owners of a restaurant/bar that has weekend events with DJ right below us also. We've received numerous complaints directly from surrounding residents of this noise situation form KUWA(1015 Clay St). We have spoken to them about closing and lowering music( as they are on ground floor with open large windows) plus monitoring their patrons numerous times. This is the second such excessive noise complaint brought to our attention brought about by another venue. We were

closed, patrons escorted out with KUWA and other clubs/bar still in operation. I personally have talked to owners about this numerous times. We've discussed this with O.P.D. in the past and they too have personally witnessed this matter. We've received calls about noise from surrounding residents well after we were totally closed and doing paperwork. We've informed residents of this situation so they are well aware in the future. In closing Ms. Marcus, excessive noise where ever it originates from is a nuisance to any surrounding residents. We are and continue to respect surrounding residents and businesses. We have a great relationship with O.P.D. as many of them frequent our venue with many functions and see firsthand, on how we conduct ourselves. Please feel well as all bars on 9th, 10th & 11th street regarding this.

Declaration of Public Nuisance - Illegal Cabaret Operation and **Unpermitted Special Event Activity** 

Civil Penalty:

## Dear Property Owner(s):

Our office has been informed of the nuisance activity at the above-referenced property. The subject property is declared a public nuisance pursuant to Oakland Municipal Code (OMC) Chapter 1, Section 1.08 et seq. Having reviewed the evidence and good cause existing, the City declares the following:

- > The nuisance activity reported to occur on your property includes, but is not limited to, illegal event, cabaret activity in violation of OMC Chapter 5.12 and violation of OMC section 9.52 conducting a special event without a permit, occurring on your property located at 1015 Clay Street, Oakland dba KUWA. These activities constitute a violation (Item #s 3, 6, & 7) of the conditional license issued by Department of Alcoholic Beverage Control (copy attached). Any and all non-approved activities must immediately cease. If you or your tenant proceeds to hold anymore events without the appropriate permits, we will inform ABC; and
- > A review of the information subject you to daily penalties of \$1,000 should you not act immediately to abate the activity; and

➤ Pursuant to the Oakland Master Fee Schedule you are hereby assessed a \$3,500.00 Nuisance Case fee.

Please be advised that thirty (30) days from the date of this letter, the City may impose daily penalty assessments of \$1000.00 a day up to \$365,000 a year (pursuant to OMC Chapter 1, Section 1.08 et seq), unless the nuisance conditions are abated. Assessments will be made every 30 days until you have identified remedial measures taken to prevent recurrence of activity to the satisfaction of the City. Further, buildings and structures or portions thereof which are determined to be a public nuisance, shall be abated by repair, rehabilitation, demolition or removal. It is your obligation to abate the nuisance condition.

Assessment will be based on number and frequency of recurrent nuisance conditions, as well as diligence of property owner in addressing concerns of the City. Fees, costs, payments, assessments, and penalties associated with our enforcement actions are significant and shall be a charge against the property and the owners and, if not reimbursed immediately, shall become a special assessment/priority lien recorded against the property title and are recoverable through the property tax general levy and court action, among other remedies available to the City. Failure to remedy or abate nuisance conditions may result in the City doing so and billing you for the costs.

## Remedial Actions Required

Pursuant to the above findings and declarations, you are ordered to take all remedial measures necessary to abate nuisance activity identified above. These measures include but are not limited to:

- Within 14 days (from the date of this notification), pay all City assessments to date; and
- > Continually maintain the premises free of blighted conditions; and
- > Immediately cease and desist the nuisance activity including, but not limited to:
  - Illegal or unpermitted cabaret operations;
  - Un-permitted special event activity.

You have fourteen days in which to implement remedial measures.

## APPEAL

As prescribed in OMC section 1.08 you have the right to appeal this determination. Pursuant to OMC section 15.08.410 your appeal must be received within 14 days from the date of this notice. An appeal hearing, if required will be conducted before an independent administrative hearing examiner. In order to request an appeal you must pay a \$78.61 non-refundable filing fee, and submit in writing the details upon which you base your claim that the City has erred or abused its discretion in these actions. Please

be advised that you may be assessed fees for the actual costs incurred by the City for enforcement proceedings against your property.

Should you have questions concerning this form or the appeal process or penalty procedures, please contact the Nuisance Abatement Division's Administrative Assistant weekdays from 9:30 to 11:00 am and 2:30 p.m. to 4:00 p.m. by telephone. Your written appeal must be filed directly with the Administrative Assistant, either in person or via first class mail:

The form for filing an appeal an appeal is enclosed. Please be advised that if your written appeal and filing fee is not received **before 4:00 p.m.** (local time), **Monday**, **August 9, 2010**, you **waive your right** for further administrative adjudication of this matter, and your only other method for redressing this matter may be judicial action. Please note that incomplete appeals including, but not limited to, oral notification of your intention to appeal, a written appeal postmarked but not received within the time prescribed, or a written appeal received by the filing deadline without a filing fee, are not acceptable and will be rejected.

## OPTION TO MEET FOR COMPLIANCE PLAN

Depending on the nature of the violations, you may also request to meet with the Nuisance Abatement Division and the referring department to develop a compliance plan to abate the nuisance. In some cases a performance bond will be required along with compliance plan. If you reach an agreement, the City may suspend the daily penalties while you meet the terms of the compliance plan. 


