#### Summary:

On 27 Apr. 2015, I was a working OPD single person unit 1L16 and I was fully dressed in an OPD wool uniform. I was driving a fully marked OPD vehicle #1459. At approximately 1740 hrs, I was dispatched to [REDACTED] to investigate the report of a stolen vehicle.

I arrived at approximately 1800 hrs. I spoke to R/P Kessler, R., who told me the following:

R/P presented a notarized letter indicating that he was authorized to file a police report of a stolen vehicle for (V-1) London, Jill. R/P called London, Jill and I spoke to London, Jill who provided me information about the

stolen vehicle to complete the report. London advised me that she out of town constantly on business and that Kessler, R. watches the vehicle for her.

R/P told me on 24 Apr. 2015, at approximately 1630 hrs, R/P parked, and locked (V-1)'s vehicle 1985 Toyota Truck, 2 dr. red in color (license 5P50869), facing south along the west curb in front of 790 Calmar ave. R/P went inside his home. On 25 Apr. 2015, at approximately 1330 hrs, R/P returned to the area where he had last parked the vehicle, and it was gone.

R/P and (V-1) gave nobody permission to take, borrow, use, or possess the vehicle, and R/P and (V-1) has all the vehicle keys accounted for.

(V-1) London, Jill wants to press charges.

I verified London's identity by her CA driver's license [REDACTED] and Kessler's identity by his CA driver's license [REDACTED]. I ran a vehicle registration check on my computer, and confirmed the vehicle is registered to London, Jill.

I advised R/P and (V-1) that they would be responsible for all towing and storage charges when and if the vehicle is recovered, and they agreed.

I phoned Communications, and spoke with dispatcher #4705CO. She confirmed the vehicle had not been towed or repossessed. I had her enter the vehicle into the S.V.S.

I checked the area where the vehicle had been parked. There were no signs of broken glass; therefore it is unknown by what means the vehicle was taken.

I drove the area but I was unable to locate the vehicle or any additional information about the crime.

There are no known witnesses located. I did not activate my PDRD.

Based on London's and Kessler's statement, I believe the following occurred:

During the above stated time frame, it appears that an unknown suspect(s) took London's vehicle, without her consent, and with the apparent intent to deprive her of possession of her vehicle.
