On 04Dec14 at about 1943hrs., I was working OPD patrol unit 3L14. I was dressed in full OPD utility uniform and operating fully marked OPD patrol vehicle 1485. I was dispatched to 288 Van Buren St apt 5 to investigate a report of a suicide. Below are the CAD details:

SUICIDE SOMEONE HUNG HIMSELF BLIND FOR UNIT TO BREAK-

RP CAN HEAR PEOPLE SCREAMING THAT SOMEONE HUNG THEMSELVE RP DOESN'T KNOW WHAT APT IT OCC IN

RP HEARD NEIGH/MW 30S CAME OUT YELLING TO CALL 911 THAT! 913'D

RP CALLING FRM APT ON THE 1ST FLOOR.. OCCURRING ON 2ND FLOOR APT MY RP ADV THIS IS NOT SECURED BLDG

Upon my arrival PMP rig #2153 and OFD engine 13 were on scene.

I was directed by Officer Stephens to apartment 5 where the possible suicide victim was located.

The apartment building was located on the west side of the roadway. The main access to the apartment building faces the east. The front door of apartment number 5's faces the north. Once inside the apartment there was the living room and east of the living room was the dining room / kitchen. The only bedroom and bathroom was located south of the living room. One has to go through the living room to get to the bedroom and bathroom. The bedroom had one main closet located on the northern wall.

I was directed to where a MW in his late 20's, wearing a gray SF Giants shirt, blue skinny jeans, black and gray vans who was later identified as ADLER, Jeremy (V1). I observed V1 was inside the closet of the bedroom. The closet was located on the northern wall. The closet has a wooden rod about 5' from the ground, that was

used to hang clothes from. I observed V1 appeared to have hung himself with what appeared to be a black tie. The top of the black tie was looped once around the closet's wooden rod and secured with a knot. The base of the tie was looped once around V1's upper neck area (at the base of V1's head) and secured with another knot. V1's body appeared to be suspended about 3" from the closet floor and he appeared to be in a seated position. The wooden rod was not cracked or splintered. The wooden rood appeared to be bowed where V1's body was suspended from.

V1's head and body was facing EB and his chin was touching his chest. V1's body was in a seated position with his legs crossed (left leg over the right leg) with his right hand resting by his right side palm facing himself (NB). V1's left hand rested on the inside of his left thigh and his left hand in a fist. V1's mouth was open and his tongue was protruding from between his teeth and there was dried saliva coming from his mouth. V1's lips, tongue, and the surrounding skin of his mouth were a deep blue / purple color. V1's fingertips, fingers, and hands were also a very deep blue / purple color that gradually faded into a deep red (burgundy) color. The deep burgundy color stopped in the middle of V1's upper forearm area. V1's eyes appeared to be closed.

I contacted l (OP1) and the person who found him. OP1 stated the following: On 04Dec14 at unknown time OP4) who lived in the alled OP1 to see if OP1 has heard from V1. OP1 advised OP4 that he has not heard from V1 since yesterday (03Dec14). OP4 told OP1 that she has been trying to speak with V1 all day (04Dec14 at about 1230hrs). OP1 knew V1 was working from home today (04Dec14). OP1 called V1 and was unable to contact him. OP4 called OP1 again and advised she had one of V1's friends (unknown who) use the FindMyFriend phone application and was advised V1's phone was located inside V1's apartment. OP1 and OP4 decided that OP1 should go to V1's apartment and check on him. OP1 called (OP5) to see if she has heard from V1 today (04Dec14). OP5 told OP1 that she has not heard from V1 since 03Dec14.

OP1 drove to V1's apartment and noticed V1's front doors were not locked. OP1 entered V1's apartment and searched the living room, kitchen/ dining room / bedroom and bathroom and did not locate V1. As OP1 exited the bathroom (which is east of the bedroom) he saw V1 hung himself with a black thing in the closet. OP1 was scared and started to scream. Once outside, OP1 continued to scream over and over "Help!" and "Someone call 911!" Multiple people came to OP1 and tried to help him. OP1 noticed OFD and PMP were on scene soon after. Refer to OP1's signed written statement for further details.

I had Ofc Stephens contacted (OP2) who stated the following:


On 04Dec14 at about 1920hrs., OP2 was walking on Van Buren toward Lee St (NB) when he observed a MW in his 20's wearing a blue shirt with tears running down his face who was screaming (OP1). OP2 tried to help OP1 and OP2 went upstairs to see if OP1's brother was okay. OP2 saw a MW (V1) who hung himself from the closet clothes rack and V1 appeared to be stiff. OP2 checked for a pulse from V1 and did not locate one. OP2 left the apartment and remained with OP1 until police arrived. Refer to V1's signed written statement for additional details.



The family advised V1 did not have any threats or attempts at suicide before.

I called OPD service and performed a premise check to inquire if either V1 and or 288 Van Buren Apt 5 had any mental health calls and or reports made in the past and there were negative results.

V1 was taking

PDRD not used.

No use of force used or observed.

No other additional witnesses were located at this time.

I canvassed the area and did not locate any video cameras.

It appeared between 03Dec14 at about 1900hrs., and 04Dec14 at about 1923hrs., V1 was inside his apartment located at 288 Van Buren Ave apt 5 when he decided to tie a black neck tie around the closet wooden rod and around his neck and end his life. On 04Dec14 at about 1933 hrs., V1 was pronounced deceased at the scene by OFD engine 13's paramedic.
