Any reviewer (regardless of privileges) can comment using the Comments button, which is to the left of the Share button.

# A. Need for and Benefits of Project / Plan / Program

The Wood Street corridor north of W Grand Ave and south of Emeryville, is the spine of the street network, serving Opportunity Area #1 in the West Oakland Specific Plan. While the transportation network provides an excellent framework, most of the infrastructure components are at or beyond their useful design life. Lengths of road are absent curb, gutter, & sidewalk, encouraging disorganized off street parking. Overlays are in various stages of disrepair, severe block, longitudinal & alligator cracking, deterioration adjacent rail lines, severe potholes, poor street lighting & the surrounding industrial areas are in critical need of repair & rehabilitation.

The West Oakland Specific Plan calls for Opportunity Area #1 to become a major regional jobs center. Through equitable land use development and revitalization, the economic base will be strengthened. The catalyst to this revitalization will be improvements to the Wood Street corridor. Pavement repair will improve roadway conditions, creating a safe and attractive infrastructure for multi-modal users & surrounding community. Updating street lighting to meet required standards, increases & supports safe vehicle operation at night, promotes nighttime operation of business, and deters unlawful activity.

#### 1. Expanded project description or scope (1,500 characters or less)

The West Oakland Freight Corridor is a 0.7 mile segment of roadway on Wood Street from W. Grand Avenue to Shellmound Street at the north entrance of Emeryville. As a tool for attracting job-generating businesses to an area congested with vacant, dilapidated, and/or substandard parcels, West Oakland is proposing to remove and replace the existing pavement infrastructure, remove the existing abandoned rails, provide increased street lighting, replace curb & gutter and install pedestrian sidewalks throughout the project limits. By creating a more usable & reliable transportation infrastructure for movement of goods, West Oakland becomes more attractive for new businesses that contribute to economic and environmental health, creating new employment opportunities and revitalizing the surrounding area. As the design unfolds, the project will look to enhance transportation resources throughout West Oakland to adjoining areas, specifically connecting West Oakland BART to Emeryville (via the Mandela Parkway corridor). Lastly, the project aims to create a safe, physically attractive and environmentally sustainable community. This is performed through the use of 'green' building practices, reducing land use conflicts, and the implementation of the street lighting efforts which reduce crime and vandalism.
