Pat said he'd like to see first what impacts would result from the project before going any further with performance standards. It's an iterative process, and we have to wait for the rest of the process to happen before we get to the iteration part. We're working on CEQA review right now. The CEQA consultant has asked the developer to identify practices/measures he plans to implement that are beyond those legally required. The consultant will then determine if those practices/measures would reduce environmental impacts and will identify any mitigation measures that will be needed. We would then see how the performance standards align with the mitigation measures.

Hi Al and Hui,

I am writing about the air quality and environmental health standards for the Oakland Army Base Redevelopment. Just to refresh your memory, last June, our former Deputy Director of Planning, Policy, and Health Equity, Sandra Witt, and I met with you to discuss potential public health-redevelopment collaboration. Among the issues discussed was the Oakland Army Base Redevelopment, specifically Exhibit C of the Exclusive Negotiating Agreement. When we inquired about the environmental health and air quality standards being developed as part of the contract, per section 9 of exhibit C, you informed us that the City would appreciate our support pulling standards together. We appreciate this opportunity to support such an important effort. Unfortunately, soon after our conversation we went through some staff changes, greatly reducing our capacity to take this up until the end of the summer (I am sure you are familiar with such problems). I apologize for the delay.

I developed the attached scope for the environmental health and air quality standards after reaching out to the groups Hui Wang and I discussed when we met in early August (West Oakland Environmental Indicators Project, Oakland Works, Revive Oakland, Alameda County Environmental Health Department, and Pacific Institute, as well as with our Health Officer, Dr. Muntu Davis, and our Director, Anita Siegel). While the attached is a good foundation for the standards, before going any further, I am submitting them to both of you for review, feedback, and discussion of next steps.

I will be on vacation starting September 30th and returning October 10th. Hopefully, you and/or Hui and I can connect after that. If you would like to begin the scheduling process while I am out of town, our administrator Ron Rossi, copied in this email (ron.rossi@acgov.org), has my schedule and can put something on my calendar.

I look forward to discussing this with you soon.
