Hi Joe.

I just wanted to follow up with the park situation. I appreciate and know you are working on it but just want to keep you in the loop. We now have about 10 people with encampments now in the park. One has even taken residence under the playground structure. I certainly have not seen any clean up or enforcement going on to this point and more people arrive each week with their belongings. This is really starting to put a strain on our business and has cost us thousands in lost revenues in unrented apartments that look at the park. I currently have an apartment where the homeless encampment is centered on the window in the living room which has been now vacant 134 days due to the view. That is extremely uncommon in this building. Sorry to be a pest but I have to keep trying to get things changed in the park and protect the interests of the owners.

Mr. Sprague,

On behalf of the City of Oakland, I apologize that your email went without a response since last month but I assure you the City is taking action on the problems in Lafayette Park. Although our Public Works team has been conducting regular clean-up efforts and our Human Services Outreach Team has conducted outreach to this population I recognize that this is not enough. This morning I spoke with the Deputy Chief who oversees this command area and they are prepared to conduct park curfew enforcement now that more officers have been deployed to the Metro Unit. I appreciate that you understand the complexities of the homeless problem and we are working on short and long term solutions to this problem.

As we did in late August, we will conduct a coordinated removal effort that includes Human Services, Public Works, and OPD. We are already looking into why the bathrooms are not being locked, this appears to be an oversight that we can correct quickly. We have asked the HIV Education and Prevention Project of Alameda County to assist by providing Sharps Containers to Intravenous Drug users to prevent the spread of the needles. In regard to the personal belongings that have accumulated, our crews do their best to remove junk and debris but, based on recent court cases, if we are overly aggressive in removing and destroying what someone considers a personal belonging we will be subject to lawsuits. Both the Cities of Los Angeles and Fresno have had to pay out million dollar claims for removing and destroying people's property when clearing homeless encampments which is why Oakland is especially careful in dealing with the accumulation of material.

As soon as the next coordinated effort is scheduled, I think you will see some positive results however, I do not want to suggest we will completely remove the problem.

I've contacted everyone on this email almost a month ago to do something about this park and nothing has been done. I didn't even receive one reply from anyone. I talked to the public works department and they said they were going to escalate to a supervisor but that was almost 2 weeks ago and still nothing. I walked over to discuss this with some of the city workers that were cleaning the park today and they said there was nothing they could do. I was also told that they would not go up on a latter to address the issue with all of the blankets, clothing and garbage on the top of the bathrooms. The homeless encampment has only grown to about twice the size since my last email. My residents are scared to go into this park at night and walk their dogs and will not take their kids to play at the play structure due to many needles found on this play ground and the fact that there are passed out people sleeping on the benches throughout the entire day. Bathrooms remain open at night even though a worker told me they are supposed to be locked at night and reopened during the day. We continue to struggle with the dangers and the horrible condition of this park with zero response from anyone from the city and police. As I stated in my previous email, we are sensitive to the homeless situation in Oakland but don't feel we need to live with the conditions that exist in this park and believe as residents of Oakland we should be able to enjoy the city parks as well. I look forward to someone taking responsibility for these issues. Thank you.

I am contacting you regarding a situation in Lafayette park on the corner of  $10^{th}$  and Jefferson. There is a homeless encampment set up in this park for several weeks now. The material is boxes and other items set up for a living shelter approximately 5 cubic yards in size. We own the property directly next to this park at 901 Jefferson and this has been an unsightly mess for too long. We contacted police but have not seen anything done about it to date. There are also at least 6 other homeless people in the park with blankets and garbage strewn throughout the park. Also as our building is 5 stories in height we can see down on the roof of the bathrooms and there is at least ten big garbage bags, blankets and other material on the roof of this structure which is also

very unsightly and has been there for about 9 months. One of the main problems with this park is that the bathrooms are never locked so they are continuously used each night for illegal drug use as we have found several needles in the bathrooms. We are sensitive about the homeless situation in Oakland however drug use in the bathrooms and other illegal activities are a regular occurrence in this park to 3am in the morning which pose a danger and disturbance to our residents. Furthermore we understand there may be homeless sleeping on park benches all day which exists now but I don't believe you can set up a permanent encampment in the city parks. We have contacted police about the illegal activities but receive no response. That is however a different matter which you have no control but we do feel the following things that you do have control over will help improve conditions in the park. We would like to see this park cleaned up and the above mentioned items removed as well as a policy to lock the bathrooms at dusk to avoid further drug use in those facilities. Thank you and I look forward to your response.

On February 16, 2015, Armando Sandoval and I had a meeting with Steven and Paul Peterson, Owners of Peterson Properties. They currently own a property on 47th Avenue that houses approx. 75 people. They are interested in

collaborating with OPD, BART City of Oakland and the other private property owners in the area to keep this area free of illegal dumping, Homeless encampments and possible sales of drugs and drug activity to a minimum. The Peterson brothers are very interested in collaborating with city of Oakland BART PD and the private land owners of the other parcels in this area to help keep the area of 47th Ave., as well as part San Leandro Blvd. as clean as possible. The Peterson brothers are also interested in contacting the private owners in the area so if any of you have asked to information regarding the private owners, they would like to contact them directly.

As we were made aware of recently, BART has contracted with the City of Oakland, the responsibility of cleaning and maintaining the areas underneath the BART aerial track ways in this city. With that, we need to put a plan in place in the next 10 days to have the area cleared.

On San Leandro St. between High Street and 47th Ave., there are a couple parcels owned by BART and several other parcels owner the camper, as well as storage of 5 to 6 propane tanks, directly underneath the BART tracks. Because this is a safety hazard, (possible fire under the track way) not only to the individuals themselves but for BART patrons and the other privately owned property as well. Sgt. Carter has scheduled officers to accompany Armando and I, to this location at 9 AM to notify individuals of the trespassing, signs are already posted in this area so there will be no need to give a grace period.

My experience in the past three years when we have people misbehaving on Caltrans property is that CHP is very unresponsive—only coming out when Caltrans is actually conducting their monthly clean-ups. By having Caltrans sign 602 statements we have been able to give our officers the green light to take action if needed. It has helped clear encampments in West Oakland, Rockridge, and the Fruitvale in the recent past. I know its technically CHP responsibility but the disturbing the peace call the other night got a response from OPD initially but our officers said there was nothing they could do. That's the sort of situation I hoped the 602 could help with as they have in other parts of the City in regard to the encampments. Officers have relied on them successfully to stop encampments from re-establishing themselves (such as 23<sup>rd</sup> and MLK, 580 and Fruitvale, Miles and Hwy 24, etc.) or just to conduct normal responses at encampments (like what happened at 7<sup>th</sup> and Castro).

Let me know if you are making a determination that OPD will NOT utilize the 602 and I will stop asking Caltrans to fill them out but that would be a step backwards from where we have been.

Crystal, Glen, et al,

It would be really helpful for us to collaborate on this in the following manner:

1. Tell us exactly where your crew intends to start on Wednesday and what locations you want to cover. It sounds like there are several encampments covering multiple blocks under the tracks.

- 2. Our Homeless Outreach Coordinator (Kennedy Solomon) can ask Operation Dignity to provide outreach this week, ahead of time, and post the areas so the homeless know we are coming.
- 3. Our Public Works crew can have a packer truck on hand to remove any debris left behind on City streets or ROW's.
- 4. Our Area Captain can alert and possibly assign a unit to provide support in case there are any conflicts.

By sending in outreach workers first, we can potentially identify people who are interested in receiving services. Also, taking these steps we will give the homeless time to pack up the belongings they want to keep so that process can start before you arrive, it really makes things more efficient.

I copied Area Commander Hamilton, Area Team Lead Greg Minor, our Public Works Supervisor for the Area, and our homeless outreach coordinator so they are aware of the plan.

If the goal is Wednesday Morning, we would want to post the area as per our SOPs no later than Friday.

do I correctly infer that the City has no intention of addressing the health (sanitation) and safety issues unless or until there is an identified area to relocate these people? If so I am deeply concerned. As articulated at length in this email thread these are urgent issues that require immediate attention. In addition to the sanitation issues, last night a ground floor window was broken in an apparent break-in attempt in my building to my knowledge the first such incident since I moved here in 2009. Reports of package thefts, muggings, and the like have increased sharply on Next Door, to which OPD is privy to and therefore should be aware.

I must express my extreme frustration and conviction that if there was human waste on the sidewalk and a marked increase in crime in say Piedmont, those tents would have been removed by the city within 24 hours. As previously stated, although we live in West Oakland not Piedmont, we pay exorbitant fees to the city and have every right to expect the same level of service, responsiveness and enforcement.

By the way, no police were dispatched in response to several calls about the attempted break in last night. Unfortunately, we are very accustomed to that lack of response and no one was surprised. After all, if there are no police reports there is no paper trail and the city can continue to pretend there are no issues.

This is simply unconscionable.

Homelessness and housing in the City of Oakland is at a crisis level and finding immediate shelter and permanent housing for our unsheltered residents is a major priority. Oakland has seen a huge spike in the number of homeless since the recession, rising from an average of 600 to over 1,300 in 2015. Without redevelopment funds, The City is seeking creative, alternative sources of funding, entering into collaborations with other governmental agencies and partnering with non-profits to find solutions that address the concerns of the most vulnerable.

One of the actions that the City has taken recently is to declare a housing state of emergency to allow staff to bypass some restrictions and explore creative new ways to provide shelter for those in need. We looking at San Francisco's Navigator model and how it could work in conjunction with our existing center at the Henry Robinson Center as well as provide additional support that is currently not available. We have doubled the number of beds that are available in the Winter Shelter and are working in conjunction with OHA and County services to follow the Rapid Re-Housing program to get as many people housed as quickly as possible. The use of urban campgrounds, tiny homes in approved settings and shipping container housing are some of the possible solutions under review.

In addition to these steps, other plans are in the works to address the housing problem in Oakland. The Mayor's Housing Cabinet will release a report shortly and Council President McElhaney is working on legislation to address the housing crisis that will be brought to the Council for review soon. In the interim, Public Work staff will address the encampment sites using the same formula that I noted below for illegal dumping because unfortunately the two often go hand in hand. Please continue to report sites and send me the ticket number if you do not see improvement within 5-7 business days.

Hello Keith,

As everyone has noted below, illegal dumping is a major problem that the Council President and City Staff take very seriously. Over the last 25+ years various tactics have been attempted with limited or no success. Part of the problem back then was the reluctance on the part of District Attorney to prosecute dumpers, so in 2013 Council President McElhaney and the City Attorney presented legislation that expanded the City's ability to fine dumping offenders and seize vehicles. The City Attorney assigned a Neighborhood Laws Corps attorney to investigate the illegal dumping cases and administer the fines. A reward program that provided incentives to local residents to provide information was also launched. With the help of public input and determined work of city staff, over \$500,000 in fines have been issued. Last year the City Council increased funding for the Keep Oakland Clean and Beautiful staff to increase the frequency of site abatements and Waste Management will supplement Public Works by cleaning up over 20 illegal dumping sites throughout the city every day.

With the additional tools, the City's Area One team, which includes staff from Public Works, Human Services, OPD and other departments, has met to discuss devise plans on how to best address illegal dumping hot spots. They know that the longer a location remains unabated, more dumping will occur, so they have set up a schedule to address the following locations weekly: 35<sup>th</sup> & Peralta, San Pablo & Castro and Northgate. This is not an exclusive list and other sites are under review and will be added as staff is able to abate and control each location. In addition to the focused clean-ups, the Council recently allocated funds to purchase surveillance cameras that will be placed in hot spots as well in hopes of catching more perpetrators in the act.

Illegal dumping is a serious environmental and health concern, and as residents and workers in Oakland, everyone here at the City is dedicated to bringing this problem to an end. Although it is not completely solved, progress is being made as we send out the message that dumping in Oakland will not be tolerated! Please continue to report dumpers and dump sites to Public Works through SeeClickFix or at (510)615-5566. If you do not see a result within 5-7 working days, please contact me with the ticket number and I will follow-up on your behalf.

Every day, employees of the city of Oakland's and the city of Richmond's public works departments each collect around 30 abandoned mattresses. My suggestion for this group is to do what I did years ago - look to the Federal Government to expose the horrible conditions we live with everyday and request help. Pass on trying to get local officials to do anything as they are too politically connected and won't rock any boat that might effect themselves. There are many Federal Government agencies that, by law, have to respond to urgent matters. In the past I have had great luck also with National based news agencies - the only local press you will get is if you are lucky enough to find someone who has an axe to grind with a current elected official and will desire to make them look as bad as they are - otherwise they are all in the same boat and won't do anything that will give them less access to public officials or "inside" information.

- tampering with emission control or air conditioning systems in automobiles;
- improper treatment, storage, or disposal of hazardous wastes;
- exceedances of pollutant limits at publicly-owned wastewater treatment plants;
- unpermitted dredging or filling of waters and wetlands;
- any unpermitted industrial activity; or
- late-night dumping or any criminal activity including falsifying reports or other documents.

An **environmental emergency** is a *sudden threat* to the public health or the well-being of the environment, arising from the release or potential release of oil, radioactive materials, or hazardous chemicals into the air, land, or water.

Examples of environmental emergencies include:

- oil and chemical spills,
- radiological and biological discharges, and
- accidents causing releases of pollutants

These emergencies may occur from transportation accidents, events at chemical or other facilities using or manufacturing chemicals, or as a result of natural or man-made disaster events. If you are involved in or witness an environmental emergency that presents a sudden threat to public health, you must call the National Response Center at: 1-800-424-8802. I don't want to give any false hope - the Federal government is just a larger scale disorganized group with little interest in helping us either - unless that is of course, we can help them or shame them to action - which is less and less of an option as our standards of healthy neighborhoods continues to be lowered more and more. But they will get annoyed if you keep contacting them and eventually they will contact the same officials you are trying to get to do their nob now and tell them to do something to get us off their back.

When you reach a point where human waste and used needles are the norm in a neighborhood such as ours its hard to get anyone to take action. All the different agencies have worked out a great plan to toss our problems back and forth with little accountability.

So look to agencies who are bound by law to respond to certain conditions. Also - be very wary of any government official who offers you a seat on any committee - nothing works better to stop someone then to promote or distract them. And don't waste your time reaching out to Feinstein or Barbara Boxer - the only time Barbara Boxer came to West Oakland was to support a skate park.

The only other thing that works is to schedule lots of events with the Mayor - its amazing how clean everything becomes if the Mayor and the press attend an event in our neighborhood - it is an election year and no Democrat is going to want to bring anything negative to the press however the other side might......

Keith et al,

To add to Brigitte's response, the City conducted an abatement at this homeless encampment less than two weeks ago, but as you know, the people return. By the way, this is not a Caltrans responsibility, it falls on the City. I copied the Public Works Supervisors on this response and they can and will schedule another abatement but our ability to stop the encampment from returning is severely limited. We send in social service outreach teams first, we offer services, and we just doubled the number of Winter Shelter beds in the area but many of these people do not want to take advantage of those services.

Regarding OPD enforcement, we were reluctant to ask OPD to use any aggressive tactics in the past month at encampments since the city was in the midst of declaring a shelter emergency due to the shortage of available beds. Now that the City Council authorized the funding for new beds and those beds are available we are able to be more aggressive in addressing these encampments. However, we are also focused on long term solutions to mitigate these encampment because our current policies are not working. I might add that this is a statewide crisis and every city is struggling to deal with these type of encampments in light of the broader housing crisis.

That said, I will ask our Area Commander if OPD can more thoroughly partner with Public Works during the next abatement and provide follow-up enforcement actions. I also met with Emeryville Officials late last week and they are considering partnering with us at this location. I am also investigating the cost of installing bright lighting under the overpass with the assistance of Emeryville and Caltrans but this will take more time.

Hello Keith,

As everyone has noted below, illegal dumping is a major problem that the Council President and City Staff take very seriously. Over the last 25+ years various tactics have been attempted with limited or no success. Part of the problem back then was the reluctance on the part of District Attorney to prosecute dumpers, so in 2013 Council President McElhaney and the City Attorney presented legislation that expanded the City's ability to fine dumping offenders and seize vehicles. The City Attorney assigned a Neighborhood Laws Corps attorney to investigate the illegal dumping cases and administer the fines. A reward program that provided incentives to local residents to provide information was also launched. With the help of public input and determined work of city staff, over \$500,000 in fines have been issued. Last year the City Council increased funding for the Keep Oakland Clean and Beautiful staff to increase the frequency of site abatements and Waste Management will supplement Public Works by cleaning up over 20 illegal dumping sites throughout the city every day.

With the additional tools, the City's Area One team, which includes staff from Public Works, Human Services, OPD and other departments, has met to discuss devise plans on how to best address illegal dumping hot spots. They know that the longer a location remains unabated, more dumping will occur, so they have set up a schedule to address the following locations weekly: 35<sup>th</sup> & Peralta, San Pablo & Castro and Northgate. This is not an exclusive list and other sites are under review and will be added as staff is able to abate and control each location. In addition to the focused cleanups, the Council recently allocated funds to purchase surveillance cameras that will be placed in hot spots as well in hopes of catching more perpetrators in the act.

Illegal dumping is a serious environmental and health concern, and as residents and workers in Oakland, everyone here at the City is dedicated to bringing this problem to an end. Although it is not completely solved, progress is being made as we send out the message that dumping in Oakland will not be tolerated! Please continue to report dumpers and dump sites to Public Works through SeeClickFix or at (510)615-5566. If you do not see a result within 5-7 working days, please contact me with the ticket number and I will follow-up on your behalf.

Keith et al,

To add to Brigitte's response, the City conducted an abatement at this homeless encampment less than two weeks ago, but as you know, the people return. By the way, this is not a Caltrans responsibility, it falls on the City. I copied the Public Works Supervisors on this response and they can and will schedule another abatement but our ability to stop the encampment from returning is severely limited. We send in social service outreach teams first, we offer services, and we just doubled the number of Winter Shelter beds in the area but many of these people do not want to take advantage of those services.

Regarding OPD enforcement, we were reluctant to ask OPD to use any aggressive tactics in the past month at encampments since the city was in the midst of declaring a shelter emergency due to the shortage of available beds. Now that the City Council authorized the funding for new beds and those beds are available we are able to be more aggressive in addressing these encampments. However, we are also focused on long term solutions to mitigate these encampment because our current policies are not working. I might add that this is a statewide crisis and every city is struggling to deal with these type of encampments in light of the broader housing crisis.

That said, I will ask our Area Commander if OPD can more thoroughly partner with Public Works during the next abatement and provide follow-up enforcement actions. I also met with Emeryville Officials late last week and they are considering partnering with us at this location. I am also investigating the cost of installing bright lighting under the overpass with the assistance of Emeryville and Caltrans but this will take more time.

Hello Keith,

As everyone has noted below, illegal dumping is a major problem that the Council President and City Staff take very seriously. Over the last 25+ years various tactics have been attempted with limited or no success. Part of the problem back then was the reluctance on the part of District Attorney to prosecute dumpers, so in 2013 Council President McElhaney and the City Attorney presented legislation that expanded the City's ability to fine dumping offenders and seize vehicles. The City Attorney assigned a Neighborhood Laws Corps attorney to investigate the illegal dumping cases and administer the fines. A reward program that provided incentives to local residents to provide information was also launched. With the help of public input and determined work of city staff, over \$500,000 in fines have been issued. Last year the City Council increased funding for the Keep Oakland Clean and Beautiful staff to increase the frequency of site abatements and Waste Management will supplement Public Works by cleaning up over 20 illegal dumping sites throughout the city every day.

With the additional tools, the City's Area One team, which includes staff from Public Works, Human Services, OPD and other departments, has met to discuss devise plans on how to best address illegal dumping hot spots. They know that the longer a location remains unabated, more dumping will occur, so they have set up a schedule to address the following locations weekly: 35<sup>th</sup> & Peralta, San Pablo & Castro and Northgate. This is not an exclusive list and other sites are under review and will be added as staff is able to abate and control each location. In addition to the focused clean-

ups, the Council recently allocated funds to purchase surveillance cameras that will be placed in hot spots as well in hopes of catching more perpetrators in the act.

Illegal dumping is a serious environmental and health concern, and as residents and workers in Oakland, everyone here at the City is dedicated to bringing this problem to an end. Although it is not completely solved, progress is being made as we send out the message that dumping in Oakland will not be tolerated! Please continue to report dumpers and dump sites to Public Works through SeeClickFix or at (510)615-5566. If you do not see a result within 5-7 working days, please contact me with the ticket number and I will follow-up on your behalf.

## What's an environmental violation versus an emergency?

An **environmental violation** occurs when an activity or an existing condition does not comply with an <u>environmental law or regulation</u>. Environmental violations can include (but are not limited to):

- smoke or other emissions from local industrial facilities;
- tampering with emission control or air conditioning systems in automobiles;
- improper treatment, storage, or disposal of hazardous wastes;

- exceedances of pollutant limits at publicly-owned wastewater treatment plants;
- unpermitted dredging or filling of waters and wetlands;
- any unpermitted industrial activity; or
- late-night dumping or any criminal activity including falsifying reports or other documents.

An **environmental emergency** is a *sudden threat* to the public health or the well-being of the environment, arising from the release or potential release of oil, radioactive materials, or hazardous chemicals into the air, land, or water.

Examples of environmental emergencies include:

- oil and chemical spills,
- radiological and biological discharges, and
- accidents causing releases of pollutants

These emergencies may occur from transportation accidents, events at chemical or other facilities using or manufacturing chemicals, or as a result of natural or manmade disaster events. If you are involved in or witness an environmental emergency that presents a sudden threat to public health, you must call the **National Response Center** at: 1–800–424–8802.

I don't want to give any false hope - the Federal government is just a larger scale disorganized group with little interest in helping us either - unless that is of course, we can help them or shame them to action - which is less and less of an option as our standards of healthy neighborhoods continues to be lowered more and more. #### Randy,

I attached the SOPs that Public Works abides by and although some of the names are different (since the SOP is a few years old) the procedure has not changed. These were developed in accordance with CA Supreme Court decisions that protect people's personal belongings while allowing municipalities to address public health and safety concerns. That said, we know that encampments often return right after we abate them.

Regarding your question about different types of City property, The police have limited tools to address these depending on the location. For example, if an encampment is in a City park, the people are not breaking any law until the sun sets at which point our park curfew kicks in. Violating the curfew is a mere infraction, basically one gets a ticket for it. OPD cannot spend extensive resources ticking already impoverished people because it takes a lot of time and the courts throw it out anyway. If the homeless encampment is blocking a sidewalk then OPD can order the sidewalk cleared under the OMC code that requires pedestrian access—again this is just a ticket. If an encampment is within an area posted No Trespassing, then the violation is a state law and a little more hefty but the same problem exists that those being ticketed can't and won't pay. Arresting them is not an option as the jails won't take them and the officers will be accused of criminalizing homelessness.

All of that said, we still will abate an encampment on a regular basis and our OPD partners will conduct enforcement activity as time permits and through as fair and objective a way as possible. Often the regular patrolling after an abatement can be successful at getting people to move on and additional lighting and other barriers, in partnership with property owners can add a lot to the solution.

I know that Public Works is scheduling the abatement for this week and after they do, if it returns I suggest you immediately contact OPD and file another removal request with OPW.

Also, please know that at a policy level the City is looking into long term strategies to alleviate the housing crisis since ultimately that is where the root of the problem lies. Also, this is a statewide crisis—cities across CA are facing this challenge right now.

I was directed to look into the email you sent regarding the encampments near your business. Today Dexter English will be scouting the area and scheduling abatements for the next week or two but I want to point out that his team and Robert Kennedy's have abated these sites within the past two weeks. Unfortunately the homeless return which is why I believe you were working with OPD on a stay away order. This is a very challenging area for law enforcement because in order to engage this population, they need a clear violation of the law that they can respond to such as trespassing or blocking a sidewalk. I copied Edith Guillen on this email as I know she is familiar with your situation and works directly with your Community Resource Officer. If this is a situation where a No Trespassing Statement needs to be submitted, she could provide that to you and speak with your CRO about enforcing it whenever possible.

Dexter can let you know when the next abatement is and he can loop in Edith and hopefully, by collaborating, we can have a more significant impact.

At 22nd and MLK? No, I do not think this is associated with St. Andrew's but I do have some thoughts on it: We do know that a drug dealing operation was set up within the encampment at San Pablo and Grand (and previously at 23rd and MLK). We also heard reports of large amounts of stolen electronic equipment inside a tent at San Pablo and Grand recently and so it is *possible that OPD was conducting surveillance and moved in to make an arrest*. However, some of what is described below sounds a little off. Officers can advise people not to block the sidewalk and have used a threat of citation to clear a sidewalk, also officers can require anybody to produce identification so asking for a full name is not unheard of. Last, if they are searching for a known suspect that they believe is at an encampment, it is possible they would be asking for everyone's names. We have found people with felony warrants hiding out in encampments in the past.

Without more details though I am just speculating.

All,

I have contacted our outreach provider to start engaging and informing folks of the imminent changes to this location. It would also be very helpful if you could let me know when/if requests are made to the call center before, during, and after the fence goes up.

Also, if you can provide for me the date that we can expect the contractors to begin working that would be most useful—at <u>least a one week lead time</u> would be greatly appreciated. I would also be happy to discuss issues, concerns, and manners for addressing problems with the contractor and property operators so that they are aware of/engaged in the proper procedures to enable as stream line and effective process as possible.

This is the action plan I developed with the 5<sup>th</sup> Ave. Bridge team with similar needs; it could apply here as well:

- 1. Need to submit a "SeeClickFix".
