Subject: FW: Senator Feinstein's bill

Dear PAGV Members,

As you may recall, in April we sent a letter to Senator Dianne Feinstein and Representative Peter King expressing the support of a majority of PAGV members for the *Denying Firearms and Explosives to Dangerous Terrorists Act of 2015* (both the letter and legislation are attached hereto). Recently, we were contacted by Senator Feinstein, encouraging individual members of PAGV to write to their Senators supporting this legislation.

This bill would permit the Attorney General to deny the transfer of firearms or the issuance of firearms and explosives licenses to known or suspected dangerous terrorists. Under current law, known or suspected terrorists on terrorist watch lists are prohibited from boarding airplanes, but they are legally allowed to buy firearms and explosives anywhere in the United States. According to information prepared by the Government Accountability Office, individuals on the consolidated terrorist watch list, which includes the no-fly list, cleared a background check for a gun transaction in 94 percent of attempted transactions in 2013 and 2014 (455 out of 486 times). The Supreme Court has held that the federal government can place reasonable restrictions on gun possession; this bill is plainly constitutional under Supreme Court cases.

We encourage all of you to write to your Senators and Representatives and urge the passage of this bill. If you decide to do so, we would appreciate you sending us a copy of that letter. Thank you.
