To Whom It May Concern:

We would like to kindly follow up on the FOIA request that we made on June 15, 2016 on behalf of our client Ariel Spritzer-Satomi. Please find enclosed the City of Oakland's Public Records Request Form. Additionally, please find below our original request for your convenience.

Pursuant to 5 U.S.C. § 552, we are making a Freedom of Information Act request for all records concerning the incident involving Ariel Spritzer-Satomi and the 460 feet metal chain link fence that fell off the 23rd Avenue Overcrossing over Interstate 880 in Oakland, California (the "Overcrossing") and onto Mr. Spritzer-Satomi's car as he travelled northbound on I-880 at or around 6:30 p.m. on October 19, 2015 (the "Incident").

As used herein, "records" includes all data and documents (including all electronically recorded data or databases), including but not limited to, any interview notes or recordings, field notes, photographs, videos, witness statements, field measurements, laboratory measurements, any interim of final data analysis or summaries, procedural write-ups, laboratory notebooks, and any interim or final reports.

Subjects regarding which records are requested:

- 1. All reports and supplemental reports, including all photographs, videos, or other electronic media, associated with the October 19, 2015 Incident and response;
- 2. Any physical evidence collected associated with the October 19, 2015 Incident;

- 4. All Bridge Inspection Records Information System Structure Maintenance and Investigations for any portion of the Overcrossing dating from January 1, 2010 to the present;
- 5. All Bridge Inspection Records Information System Structure Maintenance and Investigations for any portion of the 29th Avenue Overcrossing over Interstate 880 in Oakland, California, dating from January 1, 2010 to the present;
- 6. All documents related to, evidencing or referring to the Freeway Maintenance Agreement with City of Oakland, dated effective August 1, 2013, related to State Highway Route 880 within the jurisdictional limits of the City of Oakland;
- 7. All documents related to, evidencing or referring any work carried out pursuant to the Freeway Maintenance Agreement with City of Oakland, dated effective August 1, 2013, related to State Highway Route 880 within the jurisdictional limits of the City of Oakland.

This Freedom of Information Act request is directed to the entirety of the City of Oakland. For the purposes of facilitating your search, and without limiting generality of this request, we believe that such records may exist at the office of the <u>City of Oakland</u> located in Oakland, California.
