- 1) 14" black crowbar found on the rear step of the vehicle, collected by McDonald and turned into OPD Property Room.
- 2) Brass lock found approximately three feet west of the vehicle, collected by McDonald and turned into OPD Property Room.

Loss:

- 1) One (1) Bag of charcoal \$10.00

Summary:

On 12 AUG 15 at approximately 2340 hours, I was working as OPD PST unit 3C55. I was wearing full OPD PST uniform and driving fully marked OPD PST vehicle 4434. I was dispatched to 8000 Moorpark Street to investigate a report of a auto burglary. Upon my arrival, I made contact with [REDACTED] (OP-1) who identified himself as the security guard for the Uhaul plot. [REDACTED] advised the following:

On 12 AUG 15 at approximately 2304 hours, [REDACTED] (OP-1) had been making his security rounds when he noticed a female white 35-40 years in age, 5'4", 120 lbs, dirty blonde shoulder length hair, wearing a blue short sleeve shirt and blue jeans (S-1) carrying a bag of charcoal loss number one listed above and another female white 35-40 years in age, 5'6, 160 lbs, black shoulder length hair, wearing a dark long sleeve shirt and black leggings (S-2) walking from behind one of the Uhaul vehicle's (LIC#:AE90894 YRMD:07 MAKE:FORD BTM:VN VIN:1FDXE45S57DB22319). The vehicle was parked in the rear lot of the Uhaul plot located at 8000 San Leandro Street. [REDACTED] (OP-1) advised that S-1 has been on the plot in the past digging in the dumpster. [REDACTED] (OP-1) advised that he had escorted both females to their vehicle which was an older model white pick up truck.

[REDACTED] (OP-1) advised me that there is a driveway that leads around the building, so that customers can access the rear storage area after hours and that is how the suspects entered the rear area. [REDACTED] (OP-1) had advised me that the suspects had used a crowbar evidence number one listed above to twist off the lock evidence number two listed above, which had been used to secure the rear door of the vehicle. [REDACTED] (OP-1) showed me a bag full of clothes which he suspects was in the back of the vehicle because they were not

there at the beginning of his shift.

██████████ (OP-1) did not give permission to anyone to enter the vehicle. ██████████ (OP-1) does not know who entered the vehicle but would like to press charges. ██████████ (OP-1) advised that he would take care of securing the vehicle.

I observed the following:

Upon my arrival, I made contact with ██████████ (OP-1) who escorted me to the rear parking lot. ██████████ (OP-1) showed me the vehicle that had been broken into. I could see the crowbar that was left behind by the suspects and a piece of the brass lock that secured the rear door of the vehicle. Upon further investigation I located the other half of the broken lock approximately three feet west of the vehicle. I could see that the suspects had selected some clothing that was left on the side of the truck. The vehicle had been full of misc. items.

I did not leave a tech tag due to no printable surfaces.

I gave ██████████ (OP-1) a blue OPD resource card with his report number written on it.

I located security cameras on the property but was unable to access them. ██████████ (OP-1) advised me that the manager of the Uhaul store had sole access to the cameras and that his supervisor would get in contact with him to see if the suspects were caught on surveillance.

Based on my preliminary investigation, it appears that an unknown suspect(s) entered the vehicle which was parked in the rear parking lot located at 8000 San Leandro Street through the rear door using a 14" black crowbar, collected the above loss and fled in an unknown direction with loss in violation of PC 459.

No known witnesses were located.
