On 29Jan09 at approx 1529 hrs, I was working as OPD Patrol unit 2U33. I was wearing full police uniform and driving fully marked patrol vehicle# 1795. I was dispatched to 851 81st Ave, Suite G for a report of a burglary. Upon arrival, I contacted a [REDACTED] later id'ed as [REDACTED] (r/p#1) who is an employee of Goalson Development Corp. (business#1) [REDACTED] told me that an unknown suspect had broken in and burglarized the business.

[REDACTED] who is account manager of the company last observed the missing items on 23Jan09 at approx 1600 hrs. He was inside working when he observed a broken wall to the right of roll up door# 4. Unknown suspect(s) had pried open the wood and gained entry into the warehouse. The suspect(s) took several items from inside of the warehouse (loss item# 2). The suspect(s) then opened roll up door# 3 and took 2 hand trucks. The suspect(s) pushed the hand trucks outside to a pile of bundled crushed aluminum cans and loaded them onto the hand trucks. The suspect(s) pushed the hand trucks to the front of the building where they were unloaded. The hand trucks were later found by a maintenance personnel who returned them and by the bundles of aluminum cans.

[REDACTED] had the building owners repair the damaged wall and informed them of the theft.

I did not ask for a tech because the evidence had been contaminated by others touching and moving the hand trucks and damaged area.

It appears unknown suspect(s) forcibly gained entry into the warehouse. The suspect(s) then took the listed loss items and fled in an unknown direction.

On 31AUG09, at about 0840 hours, I was working as OPD patrol unit 1L26. I was dressed in full police uniform and I was driving in fully marked police vehicle #1748. I was dispatched to 851 81st Ave to investigate a call of a reported grand theft. Upon my arrival I met with R/P [REDACTED] who informed me that a fork lift of their's was stolen. [REDACTED] directed me to one of her employees W#1 [REDACTED] who would be able to provide more detailed information.

W#1 [REDACTED] told me the following details, he said that on 31AUG09, at about 0030 hours, he was the last one to leave and secure the warehouse. [REDACTED] advised me that the forklift was parked outside, in the rear of the warehouse located on the West end of 851 81st Ave. [REDACTED] told me that he had the only key to the forklift. [REDACTED] said that he arrived the following morning at approximately 0750 hours, and discovered that the forklift was missing. [REDACTED] said that he and the other workers searched for the forklift with negative results.

[REDACTED] advised me that there are no security cameras on the premise. [REDACTED] told me that the forklift has a "low jack mechanism".

No printable surfaces were located so no tech was requested.

I canvassed the area for any additional witnesses with negative results.

I gave [REDACTED] a copy of the police report number and advised her to call for any further problems.

I spoke with dispatcher 4045CO and entered the forklift into SVS.
