(business#1) told me that an unknown suspect had broken in and burglarized the business.

who is account manager of the company last observed the missing items on 23Jan09 at approx 1600 hrs. He was inside working when he observed a broken wall to the right of roll up door# 4. Unknown suspect(s) had pried open the wood and gained entry into the warehouse. The suspect(s) took several items from inside of the warehouse (loss item# 2). The suspect(s) then opened roll up door# 3 and took 2 hand trucks. The suspect(s) pushed the hand trucks outside to a pile of bundled crushed aluminum cans and loaded them onto the hand trucks. The suspect(s) pushed the hand trucks to the front of the building where they were unloaded. The hand trucks were later found by a maintenance personnel who returned them and by the bundles of aluminum cans.
