We were both dressed in full OPD patrol utilities uniform and Ofc Navarro was operating a fully marked OPD patrol vehicle # 1497. At this time we responded to the [REDACTED] to investigate a report of a domestic violence.

On arrival, we met with [REDACTED] (V-1) who told us that [REDACTED] (V-1) hit her multiple times. [REDACTED] stated that she was not hurt and did not require medical attention.

[REDACTED] allowed us to enter her home and told us that [REDACTED] was laying in bed possibly asleep in the rear bedroom. Ofc Navarro and I walked towards the rear bedroom and observed [REDACTED] laying in bed. [REDACTED] opened his eyes and we identified our selves as police officers. We placed [REDACTED] in handcuffs and advised him that he was bieng detained for domestic violence. I conducted a pat search of [REDACTED] outer clothing for weapons with negative results. I then placed [REDACTED] in the rear of my patrol vehicle.

Ofc E. Jordan arrived on scene as our cover officer and spoke with [REDACTED]. [REDACTED] told Ofc Jordan that she was in an argument with [REDACTED] over room in the bed. [REDACTED] advised during the argument [REDACTED] hit her multiple times in the face and [REDACTED] attempted to bite her on the left side of her neck. [REDACTED] stated she did not feel safe with him spending the night at her home but did not want him to go to jail. [REDACTED] does not want to press charges against [REDACTED] and refused to provided a written statement.

[REDACTED] was provided with a copy of the report number and a domestic violence resource card.

It appears that on 16 Apr 15 at approimately 0340 hours, V1 was in a verbal arguement with S1 over S1 ot giving her space on the bed. S1 then proceeded to hit V1 multiple times with an open hand in her face. S1 attempted to bite V1 on her neck but was unable to. OPD officers arrived on scene and placed S1 under arrest for 243(e)(1) Domestic Battery.

[REDACTED] was searched incident to arrest with negative results and transported to Glen Dyer Jail without incident.


