

Summary:

On 24 Apr 11, at approx. 1317 hrs I was working as OPD patrol unit 1L28. I was wearing full police BDU uniform and driving marked patrol vehicle #1795. I responded to the Flea market located at 5401 Coliseum Way to assist Ofc. R. Alvarez on a call of a individuals selling bootleg DVD's.

Upon arrival security guards working for the Coliseum Flea Market directed me to the rental stand at space E 28. Security guards had a female Hispanic detained in handcuffs. I placed the female (later id 'ed as (S1)) in my patrol vehicle so that I could determine what was going on.

Ofc. M. Finnicum responded to our location and contacted the R/P. He took a statement from security officer who told him the following:

Today at approx. 1130 hrs he was working as a security guard for the coliseum flea market. The property manager directed him to space E 28 for someone who was possibly selling stolen items. He observed S1 selling what appeared to be bootleg DVD's. S1 had these DVD's inside a red truck and also out of the truck. He called the police and directed police to S1. (Statement attached)

R/P called Inspector from the Motion Picture Assoc. of America who responded to our location. He inspected the DVD's that from had in her possession. He confirmed that the DVD's were counterfeit. He counted the DVD and found that the possession.

Short took possession of the DVD's.
I admonished who waived her rights by responding "si." only spoke Spanish. I translated her statement from Spanish to English. She told me the following:
Today at approx. 0600 hrs she arrived at the Coliseum Flea Market to work at the DVD stand. She sells DVD's at the flea market. hired her to sell DVD's. She met in Modesto and have known each other for approx. 3 months. She has been selling DVD's for approx. 1 month at this location. She charges \$10 for 4 DVD's. When she arrives at the flea market, leaves his truck unlocked and full of DVD's for her to sell. At the end of the day, he returns to pick up the truck and to pay her \$50 for the day. Her friend also sells DVD's at the flea market. She believes she shouldn't go to jail because she didn't know that what she was doing was illegal. (Statement attached)
R/P gave Ofc. Alvarez a copy of a rental receipt for space E 28. The renter is listed as and is dated 24 Apr 11. Ofc. Alvarez turned in this receipt as evidence (evidence 2).
Sgt. Glover responded to my location and approved the arrest.
Ofc. Alvarez was also directed to a separate stand at the flea market. He also arrested one female for 653 W PC- Failure to ID true name and address of Video Recording, and 350 (a) (2) PC - Trademark Infringement. See RD # 11-020146 for further details.
I transported S1 and Ofc. Alvarez's suspect to NCJ.
Ofc. M. Finnicum towed the truck located in space E 28 for evidence. See tow tag for further details.
No additional witnesses were located.
On 24 Apr 11, S1 admitted to selling counterfeit DVD's to the public. S1 also possessed approx. 2,939 counterfeit DVD's which is a violation of 653 W PC- Failure to ID true name and address of Video Recording, and 350 (a) (2)

PC - Trademark Infringement. She was arrested for these crimes and transported to NCJ.
