

Spring and I started to perform cardiopulmonary resuscitation (CPR) on Spring performed the chest compressions, while I performed mouth to mouth on Ofc. A. Esparza 9355P later arrived on scene, and assisted me and Ofc. Spring with CPR. After approximately 5 minutes of CPR Ofc. Spring, Ofc. Esparza, and myself were relieved by OFD Eng. 18 and PMP 4205. Was later pronounced deceased on scene at 2252 hrs. by Paramedic Brian Fukuhara #P30895.





While en route to the above address, OPD Communications advised that gun shots were being reported there. Upon my arrival, I observed a male Hispanic in his 20's, lying on his back on the ground with no shirt on and blue jeans. He was on the sidewalk IFO the above address, with his head pointed to the east, and his body in an east/west orientation. There was a crowd gathered around the downed person, and were shouting/pointing at a security guard also on scene. The uniformed security guard (also a male Hispanic adult) was standing nearby to the east (in the parking lot), and appeared dazed. There was also a female Hispanic adult lying in the prone position next to the downed person crying and vomiting, and appeared to be suffering from pepper spray.

The male had an apparent gun-shot wound to his abdomen, was bleeding from the back of his head, was not conscious, and had a faint pulse. After advising that the scene was clear for medical, I began conducting a secondary scan for any additional injuries. Officer Esparza was also on scene and began chest compressions (CPR). At this time the male was still unconscious, not breathing, and did not have a pulse. There where handcuffs on the subject, which I removed. I took over chest compressions until I was relieved by OFD.

In an attempt to identify the subject, I searched the subjects pant's (which had been removed), but only located a black cell phone. OFD pronounced the subject deceased at 2252 hours.

Officer Alcantar located a witness with good cell phone video of the incident. After reviewing the video, I noted a male Hispanic adult, wearing a black jacket with white writing on the back, black pants, and white shoes, that

W1 then made a S/B turn in the 1300 block of High Street and then pulled into the Valero gas station in front of pump #12 facing N/B to view the altercation. W2 started recording the incident on his cell phone. W1 advised me that S1 was a security guard. W1 stated he saw S1 and V1 on the ground fighting when three MH started to punch and kick S1 in the head. V1 was able to stand up and took off his green shirt and started to join the attack. SUMMARY:

On 19 Jun 15 at approximately 2237 hours I was working as Oakland Police Department (OPD) patrol unit 3L25. I was wearing full OPD wool uniform and was assigned to fully marked OPD patrol vehicle 1470. On the referenced date I responded to a dispatched call described as a man being assaulted.

Upon arrival I observed responding officers on scene providing life saving efforts, CPR, to an unconscious Hispanic male lying on along the south curb of International Blvd. The male's head was pointed in the east direction and his feet were pointed west. The unknown male appeared to have a gun shot wound to his stomach area.

While on scene I assisted in securing the crime scene by removing on lookers from gas station and along the south sidewalk and advising over the radio where additional units were needed.

I was approached by an unknown male, black, who identified himself as (O-1). We wised he was in charge of security at the 7-eleven and the supervisor of the security guard involved in the incident. Provided me a business card with his contact information.






SCENE DESCRIPTION:

The 4200 block of International Blvd was a commercial neighborhood. International Blvd was an east and westbound roadway with two lanes of traffic in each direction and left hand turn lanes in both directions at each end of the block. The 4200 block of International Blvd had a center median separating the east and westbound directions of traffic.

The west end of the 4200 block of International Blvd intersected with 42nd Ave. 42nd Ave was a north and southbound roadway with two lanes of traffic in each direction. The intersection of 42nd Ave and International Blvd was controlled by 4-way stop lights.

The east end of the 4200 block of International Blvd intersected with High St. High St was a north and southbound roadway with two lanes of traffic in each direction. The intersection of High St and International Blvd was controlled by 4-way stop lights.

4251 International Blvd was a commercial lot on the south side of the street located on the southwest corner of the intersection of High St and International Blvd. The commercial lot consisted of a "Valero" gas station with a "7-Eleven" convenience store at the southern end of the lot. The gas station consisted of twelve gas pumps located along three sections. Two of the gas pump sections were located on the north side of the lot in front of the 7-Eleven and the third gas pump section was located on the east side of the lot on the east side of the building. There were two driveway entrances on the north property line and two driveway entrances on the east side property line allowing access to the gas station.



Street lights surrounded the lot and the lot was lit up by lights at the gas pumps and building. Use of flashlights was not necessary to see most evidence and my notes. The weather was cold with a slight breeze.

SUMMARY:
