Thank you for a good (even though brief) conversation just now about Oakland's proposed building ordinance requiring increased electric vehicle readiness requirements in all new construction. I appreciate your feedback and I will definitely ensure that we explicitly address cost implications for new affordable housing construction. We are definitely using the DAC definition from CalEnviroScreen (and we worked with your colleagues in drafting responses re: the new proposed CES 3.0, FYI).

If you think of anything else, or if there's any way you think of that we can collaborate moving forward, please let me know. On the separate note of what to do with existing multifamily buildings, I'd love to hear any innovative ideas you have that Oakland may be able to help implement/pilot!

Back to the new proposed ordinance, I just want you to know that we'll be going to the Community & Economic Development Committee with the item on Tuesday 11/15 at 1pm (the item is a little ways down the agenda), and to Council at 5:30 on 11/29. Again, I'm here if you have any other questions, concerns or ideas.
