SUMMARY:

On 11NOV16, at about 0918hrs., I was working as 1A21 with Ofc L Mai 9472P. I was driving and Ofc Mai was in the front passenger seat. We were wearing our full OPD police uniform in a fully marked OPD patrol vehicle #1433. We were dispatched to [REDACTED] to investigate a report of a domestic violence that had occurred.

Upon arrival, there were already units on scene.

1L22, Ofc. J. Courtney 9554P was with the suspect, JAIN, Ayush (S-1).

I did not observed any visible injuries on [REDACTED] or JAIN.

OFD#25 and PMP# 2126 arrived on scene and conducted a medical check on all parties.

[REDACTED] stated the following had occurred:

[REDACTED] advised JAIN, her [REDACTED] and herself was upstairs in the bedroom. [REDACTED] stated JAIN and herself were arguing about being naked [REDACTED] [REDACTED] stated JAIN became irritated and started to pull of [REDACTED] legs. [REDACTED] was worried about [REDACTED] health so she told him to stop. JAIN did not stop so [REDACTED] advised she used her body and shield [REDACTED] by bridging over [REDACTED] stated that at that time, JAIN with a open hand slapped [REDACTED] on the back of the neck and back roughly 10 times. [REDACTED] advised JAIN used enough force to feel a sharp back of where she was hit. [REDACTED] wants to press charges and identified JAIN as the person who hit her. [REDACTED] will help with the investigation. See PDRD statement for details.

JAIN spontaneously stated the followed occurred:

JAIN stated he did not do anything and nothing happened. JAIN advised he did not hit [REDACTED] but they were arguing. JAIN advised that [REDACTED] was hitting him.

It appeared that [REDACTED] and JAIN were [REDACTED] and JAIN got into a verbal altercation. JAIN was pulling on [REDACTED] legs which [REDACTED] used her body to protect [REDACTED] JAIN then with a open hand slapped [REDACTED] in the back of her neck and back in violation of PC243 (E)(1) - BATTERY:SPOUSE/EX SPOUSE /DATE/ETC. JAIN slapped [REDACTED] in front of [REDACTED] is in violation of PC273 A - WILLFUL CRUELTY TO CHILD.

Due to the fact that it appeared JAIN was the dominant aggressor, I handcuffed and arrested JAIN. I handcuffed and searched JAIN with negative results. I then placed JAIN in the back of Ofc. Courtney's patrol vehicle.

I admonished JAIN his right which he understood.

JAIN did not want to give a statement.

Ofc Courtney obtained a EPO for [REDACTED] Ofc Courtney advised both JAIN and [REDACTED] the rules of the EPO. [REDACTED] and JAIN both received a copy of the EPO.

I then took JAIN out of Ofc Courtney's patrol vehicle and place him in the back of my patrol vehicle.

I then transported JAIN to NCJ.



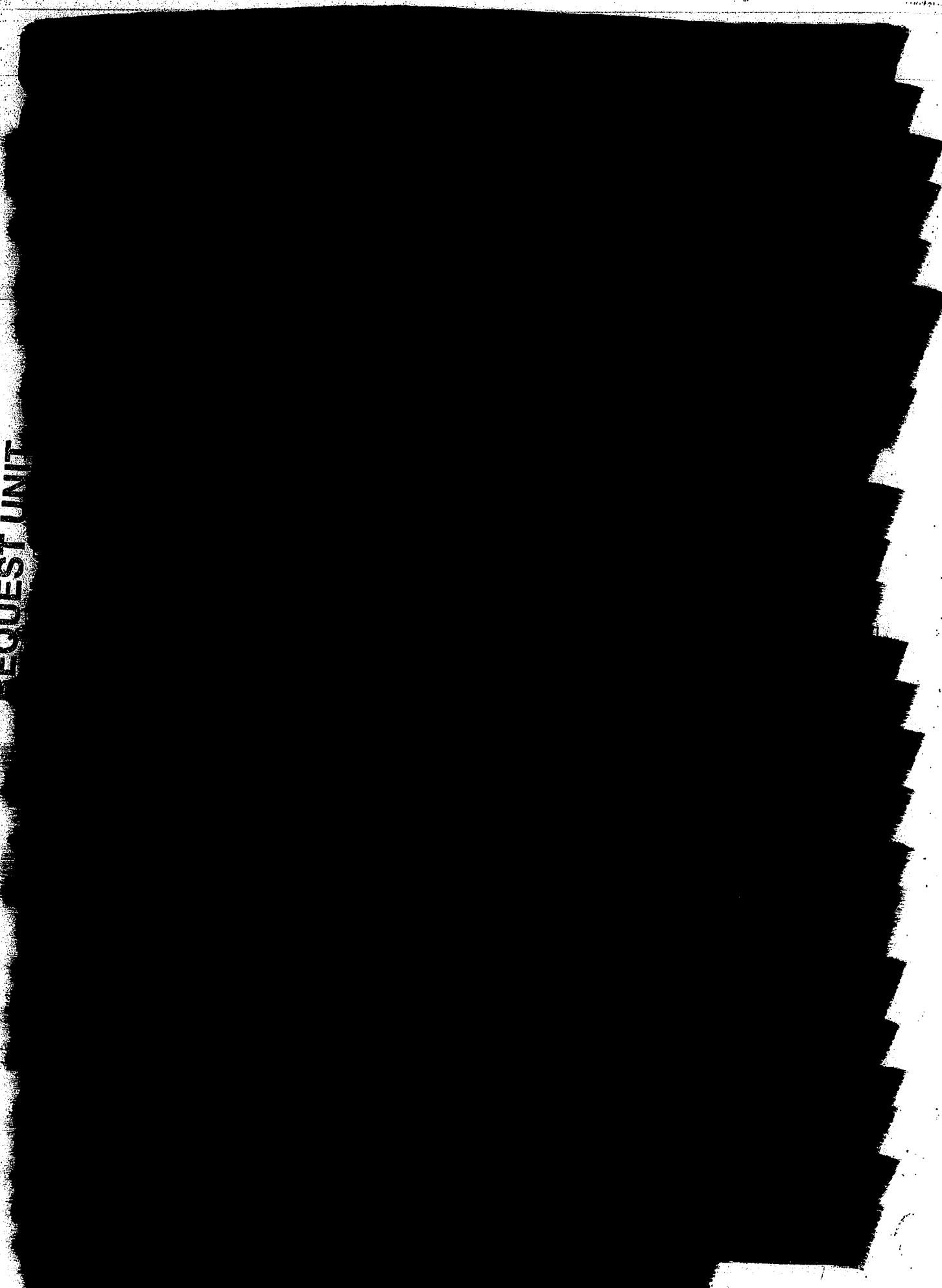
