

I apologize for my delay in responding. We met briefly while I was working at the Port of Oakland in Government Affairs. I'm filling in for Shereda Nosakhare, the Mayor's Deputy Chief of Staff, while she is out on leave. I share your concerns, as does Mayor Schaaf.

Our office had nothing to do with the planning of the OAB groundbreaking event last week. It was planned by Prologis. The Mayor was invited to attend, which as you know, she did. I discussed your message with her, after seeing your email. She mentioned that while she was at the event, she had similar thoughts herself about the absence of community and stakeholder participants. She indicated to me that she will bring this issue to the attention of Prologis.

I'm also copying Angelina Ramos, Mayor Schaaf's scheduler, who will assist in getting a meeting on the Mayor's calendar. Mayor Schaaf is out of town from Nov. 14-22, so it will most likely be in December, but I will let Angelina find a mutually convenient time.

Dear Mayor Schaaf,

Congratulations on the groundbreaking of the Prologis warehouse development at the former OAB. What an exciting time for Oakland and our community to see this development and these jobs coming to fruition.

Unfortunately, we missed an opportunity to involve the community in the groundbreaking and to further spread the word about the success and potential of this project. I am disappointed that Revive Oakland, the Community Jobs Oversight Commission nor the West Oakland Job Resource Center were invited to participate in the groundbreaking.

Conversely when AC Transit broke ground on the third phase of the BRT project, where we also have a good jobs agreement, Jahmese Myres spoke on behalf of Revive Oakland at the event. As a result, EBASE lifted up the project as a model within our national networks and as a part of a pilot project we are involved with at the DOT. Additionally, we leveraged the excitement around the groundbreaking to build community support for Measures RR and C1 during this critical election time.

The success of the OAB project is dependent upon the collaboration that was forged by the partners in the long negotiation process and that is reflected in the oversight commission. As we move into the warehouse and operations phase and begin implementing the living wage, ban the box and temp agency restriction policies, it is more important than ever that we are all working in a true partnership towards the success of the project for the city, the businesses and, of course, the job seekers in Oakland. We hope we can count on your leadership to support this kind of collaboration.

**To that end, we would like to meet with you to discuss how we can effectively work together during this next critical phase of the project. Please advise on your availability,**
