

CITY OF OAKLAND RELEASES OVER 600 PAGES OF PUBLIC RECORDS RELATED TO TRAGIC WAREHOUTER

City Makes Available Records from Police, Fire, Planning and Bu Public Works, City Administrator and Mayor's Offices

OAKLAND – Today, the City of Oakland released over 600 pages of public recito the warehouse fire that took 36 lives on December 2, 2016. All documents di date are available on the City of Oakland website organized by department at http://www2.oaklandnet.com/oaklandfire2016/index.htm. Public record requests through the online database RecordTrac will be answered with links to the relevidocuments on the City's webpage.

"I strongly believe that sunshine helps to light the path forward," said Mayor Lib recognize the media and others have been frustrated by the time it has taken to these documents from many different departments because we were determine wide net to provide all relevant information and take an exhaustive look at not juwarehouse, but also the immediately adjacent properties. Transparency is critic impacted community deserves to know all the facts about this tragedy."

The City received 121 public records requests as of February 3, 2017 related to Avenue warehouse fire and nearby properties, with the initial volume of request the days and weeks following the fire. Staff across City Departments worked dil track down the necessary records to satisfy each request and in many cases, c through thousands of pages of documents to identify responsive records and a redundancies.

Staff from the various departments has been reviewing and redacting informatic exempt by the California Public Records Act. The full range of legal justification redactions can be found at http://www2.oaklandnet.com/w/OAK062776.

Of the 121 public records requests made, 86 are being fulfilled with either the rerecords being released today, a final determination that no records exist, or that are confidential and/or privileged.

In response to the various requests being fulfilled today, the Oakland Police De Oakland Fire Department, Planning and Building Department and Oakland Pub Department all provided documents that predate the December 2, 2016 fire.

Requests for records from the City Administrator's Office and the Mayor's Office documents and correspondence that predate and postdate the fire.



PLANNING AND BUILDING'S RECORDS SUMMARY

Pursuant to the Public Records Requests, the Planning and Building Departme encompassed records for the past 30 years.

OAKLAND, CA – Mayor Libby Schaaf announced tonight the ongoing release of the attached permit and complaint history from the past 30 years from the City of Oakland's Planning and Building Department related to the warehouse at 1315 31st Avenue and the neighboring vacant lot on a separate parcel at 1305 31st Avenue.

This 30-year period roughly covers the length of time for which we have electronic records.

The City of Oakland has prioritized compiling the planning and building records related to the warehouse and the lot because the vast majority of questions from the public are related to the contact we have had through this city agency.

We will be compiling public records from other city departments as well.

It is important to note that there are several possible ways in which the City of Oakland primarily comes in contact with a property and the City's responsibilities vary based on the agency which has the encounter and the nature of the circumstances. For example, if a member of the public contacts the city to complain about building code safety violations, the complaint would be directed to the Building and Planning Department.

Once they are fully compiled, it is our intention to share public records from other agencies. Records will be posted to the City of Oakland website on a rolling basis at http://www2.oaklandnet.com/OAK061753.

FREQUENTLY ASKED QUESTIONS

Who owns the warehouse?

According to public records the owner is listed as Chor N. Ng.

Who owns the lot?

According to public records the owner is listed as Chor N. Ng.

What is the permitted use of the warehouse at 1315 31st Avenue? The only permitted use for the warehouse is as a commercial space. It was not permitted for residential nor public assembly use.

How many complaints have there been on the warehouse that was involved in the 31st Avenue Fire?

Prior to the deadly warehouse fire, <u>there have been three complaints</u> <u>made about the warehouse address</u> – two in 2014 and one in 2005. The complaints were:

- 1) on 10/8/14: constructing house/structure without permits,
- 2) on 9/30/14: Pallets, construction materials blocking the sidewalk; and
- 3) on 11/16/05: Vacant lot next to above address. Lot used as a parking lot and a homeless camping ground.

Currently, there are no open complaints on the warehouse property.

How many complaints have there been for the vacant lot adjacent to the warehouse – 1305 – 31st Ave?

There are 18 records in total related to the lot at 1305 31st Ave prior to the warehouse fire. Seven of these records are complaints involving the lot beginning in 1988. There are no visible street addresses for either the warehouse or the vacant lot and their adjacency may have caused complainant confusion. The following two complaints were made on the vacant lot during 2016:

- 1) on 11/14/16: illegal interior building structure;
- 2) on 11/13/16: "There are a ton of garbage piling up on the property on 1305 31st Ave. Also, a lot of items are left on the sidewalk near the property. Some of trash was hazardous. This property is a storage but the owner turned it to become trash recycle site. The yard became a trash collection site and the main building was remodel for residential. The change causes our neighborhood looks very bad and creates health issue."






Oakland vigil planned to mourn Ghost Ship warehouse fire victims

On the morning of Wednesday, December 7, search and recover efforts at 1315 31st Avenue were concluded. A secondary search by recovery personnel and cadaver dogs was made and returned no additional victims.

Streets in around the fire scene will re-open as the security perimeter shrinks over the next few hours.

The Alameda County Sheriff's Office Coroner's Bureau has notified 32 families, an additional 3 notifications are in process and 1 victim needs scientific identification.

In addition to the previously released names, the Coroner's Bureau has released the names of two more of the 36 victims:

Jason McCarty, 35, Oakland, Calif.

Wolfgang Renner, 61, Oakland, Calif.

There is a correction to the city of residence for a previously released name: Vanessa Plotkin, 21, Lakewood, Calif.

The Alameda County Sheriff's Office Coroner's Bureau is identifying the victims to the public by the names their families ask for, and will note the legal name, if different, on the official death certificate, according to law. They are consulting with an LGBT diversity consultant to assist in appropriate gender identification.

The identified victims' families have been notified. The City of Oakland extends condolences to the families who have received the dreadful news that one of their loved ones perished in the fire.

During this tremendous time of loss and grief for the families and friends of the victims, the City of Oakland encourages the media to respect their need for privacy.

The Family Assistance Center at 2425 E. 12th Street will be fully staffed today.

The Bureau of Alcohol, Tobacco, Firearms and Explosives is continuing their investigation into the source of the fire. "ATF is looking at every possible source of ignition," said Special Agent in Charge Jill Snyder. "There is no timeline for the conclusion of the investigation. ATF experts will be on scene for possibly several more days examining physical evidence. The analysis of data and interviews may take several weeks."

31st AVENUE FIRE CITY OF OAKLAND PLANNING AND BUILDING PERMIT AND COMPLAINT RECORDS

OAKLAND, CA – Mayor Libby Schaaf announced tonight the ongoing release of the attached permit and complaint history from the past 30 years from the City of Oakland's Planning and Building Department related to the warehouse at 1315 31st Avenue and the neighboring vacant lot on a separate parcel at 1305 31st Avenue.

This 30-year period roughly covers the length of time for which we have electronic records.

The City of Oakland has prioritized compiling the planning and building records related to the warehouse and the lot because the vast majority of questions from the public are related to the contact we have had through this city agency.

We will be compiling public records from other city departments as well.

It is important to note that there are several possible ways in which the City of Oakland primarily comes in contact with a property and the City's responsibilities vary based on the agency which has the encounter and the nature of the circumstances. For example, if a member of the public contacts the city to complain about building code safety violations, the complaint would be directed to the Building and Planning Department.

Once they are fully compiled, it is our intention to share public records from other agencies. Records will be posted to the City of Oakland website on a rolling basis at http://www2.oaklandnet.com/OAK061753.

FREQUENTLY ASKED QUESTIONS

Who owns the warehouse?

According to public records the owner is listed as Chor N. Ng.

Who owns the lot?

According to public records the owner is listed as Chor N. Ng.

What is the permitted use of the warehouse at 1315 31st Avenue? The only permitted use for the warehouse is as a commercial space. It was not permitted for residential nor public assembly use.

How many complaints have there been on the warehouse that was involved in the 31st Avenue Fire?

Prior to the deadly warehouse fire, <u>there have been three complaints</u> <u>made about the warehouse address</u> – two in 2014 and one in 2005. The complaints were:

- 1) on 10/8/14: constructing house/structure without permits,
- 2) on 9/30/14: Pallets, construction materials blocking the sidewalk; and
- 3) on 11/16/05: Vacant lot next to above address. Lot used as a parking lot and a homeless camping ground.

Currently, there are no open complaints on the warehouse property.

How many complaints have there been for the vacant lot adjacent to the warehouse – 1305 – 31st Ave?

There are 18 records in total related to the lot at 1305 31st Ave prior to the warehouse fire. Seven of these records are complaints involving the lot beginning in 1988. There are no visible street addresses for either the warehouse or the vacant lot and their adjacency may have caused complainant confusion. The following two complaints were made on the vacant lot during 2016:

- 1) on 11/14/16: illegal interior building structure;

The Alameda County Sheriff's Office Coroner's Bureau has notified all 36 families.

In addition to the previously released names, the Coroner's Bureau has released the names of two more of the 36 victims:

Jennifer Mendiola, 35, Oakland Joseph Matlock, 36, Oakland

The Alameda County Sheriff's Office Coroner's Bureau is identifying the victims to the public by the names their families ask for, and will note the legal name, if different, on the official death certificate, according to law. They are consulting with an LGBT diversity consultant to assist in appropriate gender identification.

The identified victims' families have been notified. The City of Oakland extends condolences to the families who have received the dreadful news that one of their loved ones perished in the fire.

During this tremendous time of loss and grief for the families and friends of the victims, the City of Oakland encourages the media to respect their need for privacy.

The Bureau of Alcohol, Tobacco, Firearms and Explosives is continuing their investigation into the source of the fire. "ATF is looking at every possible source of ignition," said Special Agent in Charge Jill Snyder. "There is no timeline for the conclusion of the investigation. ATF experts will be on scene for possibly several







Fire At 1315 31st Avenue - On Friday, December 2, a tragic fire claimed the lives of 36 victims. Within minutes of the first call to dispatch, crews from the Oakland Fire Department arrived and the incident quickly went to a three alarms. The fire was deemed under control at 4:36 a.m. on Saturday, December 3. We continue to extend condolences to the families and friends who have received the tragic news of losing loved ones in the 31st Avenue warehouse fire. During the height of the response to extinguish the fire, there were 16 units on scene and 77 fire fighters. During this response phase, the Oakland Fire Department received mutual aid from the City of Alameda Fire Department and the Alameda County Fire Department. During the recovery phase, personnel from the Oakland Fire Department; Oakland Police Department; Oakland Public Works Department; Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF); Alameda County Sheriff's Office; Cal OHSA; Alameda County Search and Rescue; Fremont Fire Department; Hayward Fire Department; East Bay Regional Park District's Fire Department; Contra Costa County Fire Protection District and San Ramon Valley Fire Protection District conducted the painstaking work of recovering the victims from the scene of the fire. At times, debris removal progressed by bucket brigade. Due to severe damage to the building, sections of the building needed to be shored-up to provide safe entry for recovery teams. Recovery efforts continued around-the-clock and required the use of heavy equipment. At one point, electrical lines had to be de-energized to allow use of a large crane. Thanks to careful planning, at its height, the planned power outage impacted only 12 residential and commercial customers. On the morning of Wednesday, December 7, search and recover efforts at 1315 31st Avenue were concluded. A secondary search by recovery personnel and cadaver dogs was made and returned no additional victims. From Saturday, December 3, through Wednesday, December 7, a Family Assistance Center was in

operation at the Alameda County Sheriff's facility, 2425 E. 12th Street. The center comforted and assisted family members and friends looking for loved ones with grief counseling and other services. Representatives from Alameda County Behavioral Health Care Services, Alameda County District Attorney's Victims Support Division and the City of Oakland joined in partnership with volunteers and staff from the American Red Cross in providing support to families and friends of the fire victims. On Monday, December 5, Alameda County District Attorney Nancy O'Malley shared the details of the launch of her office's criminal investigation into the fire. INFORMATION

Following are the key activities to be highlighted this week:

Fire At 1315 31st Avenue - On Friday, December 2, a tragic fire claimed the lives of 36 victims. Within minutes of the first call to dispatch, crews from the Oakland Fire Department arrived and the incident quickly went to a three alarm. The fire was deemed under control at 4:36 a.m. on Saturday, December 3. We continue to extend condolences to the families and friends who have received the tragic news of losing loved ones in the 31st Avenue warehouse fire. During the height of the response to extinguish the fire, there were 16 units on scene and 77 fire fighters. During this response phase, the Oakland Fire Department received mutual aid from the City of Alameda Fire Department and the Alameda County Fire Department. During the recovery phase, personnel from the Oakland Fire Department; Oakland Police Department; Oakland Public Works Department; Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF); Alameda County Sheriff's Office; Cal OHSA; Alameda County Search and Rescue; Fremont Fire Department; Hayward Fire Department; East Bay Regional Park District's Fire Department; Contra Costa County Fire Protection District and San Ramon Valley Fire Protection District conducted the painstaking work of recovering the victims from the scene of the fire. At times, debris removal progressed by bucket brigade. Due to severe damage to the building, sections of the building needed to be shored-up to provide safe entry for recovery teams. Recovery efforts continued around-the-clock and required the use of heavy equipment. At one point, electrical lines had to be de-energized to allow use of a large crane. Thanks to careful planning, at its height, the planned power outage impacted 12 residential and commercial customers. On the morning of Wednesday, December 7, search and recover efforts at 1315 31st Avenue were concluded. A secondary search by recovery personnel and cadaver dogs was made and returned no additional victims. From Saturday, December 3, through Wednesday, December 7, a Family Assistance Center was in operation at the Alameda County Sheriff's facility, 2425 E. 12th Street. The center comforted and assisted family members and friends looking for loved ones with grief counseling and other services. Representatives from Alameda County Behavioral Health Care Services, Alameda County District Attorney's Victims Support Division and the City of Oakland joined in partnership with volunteers and staff from the American Red Cross in providing support to families and friends of the fire victims. On Monday, December 5, Alameda County District Attorney Nancy O'Malley shared the details of the launch of her office's criminal investigation into the fire. The District Attorney's Office activated the criminal investigation teams and is actively looking at this with all of the other law enforcement partners. On Thursday, December 8, the proclamation of a Local Emergency by the Oakland City Administrator was ratified by the Oakland City Council during a special meeting. The local emergency, which was, proclaimed on Tuesday, December 6, is an important step in recovery for the City of Oakland and our community. Under

the <u>California Disaster Assistance Act</u>, the City of Oakland may be eligible for reimbursement of up to 75 percent of qualifying response and recovery expenses related to the 31st Avenue Fire. Generally, these include labor, equipment, materials and other expenses related to extinguishing the fire and recovering the victims from the scene. The Oakland Fire Department's Emergency Management Services Division will be developing an initial damage estimate to provide to the Governor's Office of Emergency Services (Cal OES) for consideration for California Disaster Assistance Act funding. Staff from the Economic & Workforce Development Department has already begun distributing the <u>Estimated Disaster Economic Injury Worksheet for Businesses</u>. Artists who may have operated a business in the 1315 31st Avenue warehouse may be eligible for SBA loans, and are encouraged to contact Aliza Gallo, Economic Development Manager, at <u>agallo@oaklandnet.com</u> or (510) 238-7405. City Receives FEMA Grant Funding To Launch Seismic Retrofit Programs - Through Monday, December 19, the City of Oakland is encouraging interested owners of eligible properties to complete and submit a pre-application questionnaire for two seismic retrofit programs: (1) the Earthquake-Safe Homes Program for owner-occupied, singlefamily homes and (2) the Safer Housing for Oakland Program for soft-story apartment buildings. On Monday, October 10, the City of Oakland received notice that it has secured more than \$360,000 in Phase I grant funding from the Federal Emergency Management Agency (FEMA) to develop these two retrofit programs. If the retrofit programs are approved by FEMA after Phase I, the City will be eligible for \$5.4 million in Phase II grant funding for engineering and construction activities. The survey for owners of owner-occupied, single-family homes (the property must be a single family home or 2-4 units and must be the primary residence of the homeowner) is available for download in English, Chinese, Spanish and Vietnamese at http://bit.ly/2fen52N. 

CITY OF OAKLAND RELEASES OVER 600 PAGES OPUBLIC RECORDS RELATED TO TRAGIC WAREHOUTER

City Makes Available Records from Police, Fire, Planning and Bu Public Works, City Administrator and Mayor's Offices

OAKLAND – Today, the City of Oakland released over 600 pages of public recito the warehouse fire that took 36 lives on December 2, 2016. All documents didate are available on the City of Oakland website organized by department at http://www2.oaklandnet.com/oaklandfire2016/index.htm. Public record requests through the online database RecordTrac will be answered with links to the releving documents on the City's webpage.

"I strongly believe that sunshine helps to light the path forward," said Mayor Lib recognize the media and others have been frustrated by the time it has taken to these documents from many different departments because we were determine wide net to provide all relevant information and take an exhaustive look at not juwarehouse, but also the immediately adjacent properties. Transparency is critic impacted community deserves to know all the facts about this tragedy."

The City received 121 public records requests as of February 3, 2017 related to Avenue warehouse fire and nearby properties, with the initial volume of request the days and weeks following the fire. Staff across City Departments worked dil track down the necessary records to satisfy each request and in many cases, c through thousands of pages of documents to identify responsive records and a redundancies.

Staff from the various departments has been reviewing and redacting informatic exempt by the California Public Records Act. The full range of legal justification redactions can be found at http://www2.oaklandnet.com/w/OAK062776.

Of the 121 public records requests made, 86 are being fulfilled with either the records being released today, a final determination that no records exist, or tha are confidential and/or privileged.

In response to the various requests being fulfilled today, the Oakland Police De Oakland Fire Department, Planning and Building Department and Oakland Pub Department all provided documents that predate the December 2, 2016 fire.

Requests for records from the City Administrator's Office and the Mayor's Office documents and correspondence that predate and postdate the fire.


