

Update from the City of Oakland on the 31st Avenue Fire at 4:30 p.m.

As of 2:30 p.m. on Monday, December 5, the number of located and recovered victims is 36. Twenty-two victims have been positively identified and their families have been notified. An additional 11 victims have been tentatively identified and three victims need scientific identification.

Today, Alameda County District Attorney Nancy O'Malley shared the details of the launch of her office's criminal investigation into the fire. The District Attorney's Office has activated the criminal investigation teams and is actively looking at this with all of the other law enforcement partners. In the coming days, after the recovery phase is completed, our focus will shift to a thorough investigation of what occurred. We are committed to bringing every resource to bear to determine what happened here and how such a tragic event could have occurred. Our priority is to bring closure to this tragedy for the victims' families.

Personnel from the Oakland Fire Department; Oakland Police Department; Bureau of Alcohol, Tobacco and Firearms; Alameda County Sheriff's Office; Cal OHSA; Alameda County Search and Rescue and Oakland Public Works Department continued the painstaking work of recovering the victims from the scene of the fire. At this time, about 70 percent of the building has been searched. We anticipate this will remain an active recovery scene for at least t next day.

In order for first responders to complete the recovery process, it was determin that a large crane was needed. To safely operate the crane, it was necessary to de-energize nearby power lines. Thanks to careful planning, the planned outag impacted 12 residential and commercial PG&E customers. The power was turned off at 3:20 p.m. The planned outage is anticipated to last at least 12 hours.

In addition to PG&E's phone notification, outreach teams from the City's Neighborhood Services Division and Economic Development Department pai personal visits to both commercial and residential customers. If customers hav any questions about the outage, they may call PG&E at (800) 743-5002.

Recovery efforts in a portion of the building were suspended this morning around 12:15 a.m. due to precarious building conditions. While a plan to stabilize that wall, recovery work resumed in a different area of the building. Debris removal and victim recovery continue. Currently, 70% of the building has been cleared.

The focus of our efforts remains the recovery of victims. This recovery will be undertaken in a methodical and thorough process in a humane and compassionate manner to ensure that the victims are recovered and identified, and to make sure their families have this information as expeditiously as possible.

Oakland fire investigation: 'No stone unturned'

OAKLAND >> Murder charges remain a possibility as an Alameda County investigative team continued to look into why a horrific fire broke out at a Fruitvale District warehouse, killing 36 people, authorities said Monday afternoon.

District Attorney Nancy O'Malley promised that "no stone would be left unturned" during the investigation, which remained as painstakingly slow as the cleanup, three days after the blaze at the building known as the Ghost Ship.

"We are following up on every single lead," O'Malley said.

Several people have been interviewed as part of the investigation, and more are being scheduled, O'Malley said.

She would not comment on whether Derrick Ion Almena, the resident of the warehouse and the subject of harsh words by people who know him, has been interviewed yet.

"It's too premature to say where the investigation will lead us," O'Malley said. "We are going to be looking at everything."

The recovery of bodies continued through the afternoon after a safety issue forced recovery efforts to stop from around 11:20 p.m. Sunday night until 9 a.m. on Monday, according to Oakland police spokeswoman Officer Johnna Watson said.

The death toll remained at 36, but Alameda County Sheriff's Coroner Greg Ahern said authorities "were not expecting any more huge numbers" of bodies in the building.

Thus far, 33 victims, including the 17-year-old son of an Alameda County sheriff's deputy, have been tentatively identified and 22 families have been notified by the Alameda County coroner's office.

The coroner has five pending notifications. Two victims have not been identified because they are too badly burned and one doesn't match the description of anyone on the missing person's list.

Crews found one victim each from Finland, Guatemala and Korea.

Authorities also said about 50 of the original 220 names who were unaccounted for remained that way Monday afternoon but that doesn't necessarily indicate they were in the building.

Debby Goldsberry remembers the day she logged into her company's bank account and saw something startling: a negative balance of almost \$1 billion. "I nearly had a heart attack," she said.

That was nine years ago. Goldsberry, now the executive director of the Magnolia Wellness Clinic in Oakland, a marijuana dispensary, was then on the board of the Berkeley Patients Group. The Drug Enforcement Administration had seized all the cash in the group's account and, apparently just to be sure that it would be able to seize any future deposits, it created the eye-popping negative balance. In fact, the agency seized only about \$120,000, which had been earmarked to pay state sales taxes.

So Goldsberry's current business runs on cash, as do most marijuana dispensaries. Magnolia employees double-count bills as they come in and out. "We have to treat our cash like a hot potato" to prevent robberies or burglaries, Goldsberry said. "As soon as it arrives, it's got to go."

The passage of Proposition 64 last month, which made marijuana legal for recreational use in California, has done little to change the fact that pot is a cash crop in more than one sense. Marijuana remains illegal under federal law, which means that banks have to file stacks of paperwork just to handle everyday transactions — if they dare to take on marijuana businesses as customers at all.

On Friday, California Treasurer John Chiang said he would form a group to study the banking issues that hamper the cannabis industry. Earlier in the week, the Oakland City Council voted to study a public bank meant to serve pot businesses. Such a bank would allow owners to deposit sales receipts, pay taxes, buy supplies and, perhaps eventually, get loans.

But Oakland's proposal faces enormous challenges, and even if that bank or any others get off the ground, it's not clear they'll solve the industry's banking problems.

Bankers, understandably scared of being charged with money laundering or other crimes, generally won't touch marijuana businesses. Even if governments like Oakland create their own banks, the risk would remain.

As it looks now, however, Oakland's study seems likely to conclude that creating a public bank would be a major challenge at best, and utterly infeasible at worst. Creating a publicly owned bank is next to impossible in the United States, and that's even when such banks aren't serving problematic businesses like pot dispensaries.

Public banks in the United States face "huge, high and flaming hoops," largely because of resistance from established banks, said Gwendolyn Hallsmith, the executive director of Global Community Initiatives, who works with the Public Banking Institute, an advocacy group. Only one operates in the country: the Bank of North Dakota, created in 1919 to serve farmers like a credit union. This is a stark contrast with many other parts of the world, where publicly owned banks are common. "There's one on every street corner in Germany," Hallsmith said.

Any kind of full-service bank must do business with other banks — for example, to transfer funds. Banks that refuse to serve the pot trade might similarly refuse to do business with a public bank involved with it. And government authorities like the Federal Deposit Insurance Corp. and the Federal Reserve would likely look askance.

Chiang acknowledged as much in a letter to members of his working group. "This conflict between federal and state rules creates a number of problems for the states that have legalized cannabis use, Alameda County Sheriff's Office spokesman Sgt. Ray Kelly spoke with some of the families and one woman showed him her phone with a text message on it from her daughter that said, "I love you. I'm going to die, Mom."

"I think it's important to recognize messages like these," he said. "Victims were inside and aware that they were going to die."

Kelly told The Associated Press that rescue crews have found bodies of people "protecting each other, holding each other."

O'Malley said criminal charges could range from murder to manslaughter depending on the evidence uncovered during the investigation. She did not give a timetable for when the probe would be completed, saying only that it will be "methodical and thorough, without sacrificing the detail that's needed."

On Monday, Derrick Ion Almena, the founder of the "Ghost Ship," sent a statement to NBC Bay Area responding to criticism over an earlier Facebook post in which he lamented the loss of material possessions but not the victims.

"In my previous Facebook post, I had no idea there was a loss of life," he said. "This tragic event consumes me every moment. My heart is broken. My heartfelt condolences to the family and friends who have suffered the loss of loved ones."

Almena also told NBC Nightly News reporter Miguel Almaguer that he had spoken with investigators and has not been charged. His family was not at the warehouse when the fire broke out.

"Do I take blame or responsibility for this?" asked Almena, shaking his head.

The city had received complaints about blight and illegal structures inside the warehouse near 31st Avenue and International Boulevard. An inspector paid a visit two weeks ago but left when no one answered the door, according to authorities.

The fire, among the deadliest in California history, is believed to have started on the first floor as dozens attended an electronic music party on the second floor. The power went out and people struggled to escape down a narrow staircase made out of pallets and plywood, according to authorities.

Former "Ghost Ship" tenant Shelly Mack said the artists' collective bypassed the meter and used "massive amounts" of electricity. A back staircase was closed during parties because it was used as a conduit for cables, she said.

People lingered at makeshift memorials set up on sidewalks near the building Monday, some taking pictures and some crying. News trucks from around the world filled nearby streets.

The tragedy drew words of sympathy from President Barack Obama. He said the full toll of the disaster is unknown, but "many people — including young men and women with their whole futures ahead of them — have tragically lost their lives."

Obama also thanked firefighters and other first responders who have worked to recover victims and treat the wounded.

Almena, 46, led the Oakland arts collective and commune from the building known as the "Ghost Ship," but he was nowhere to be seen when the fire broke out around 11:32 p.m. on Friday. The warehouse had been rented for a dance party.

He lived there with his wife, Micah Allison, and three children, and rented space to others.

"Am I the man who should be held accountable?" Almena asked host Matt Lauer. "What am I going to say to that. Should I be held accountable? I can barely stand here right now."

Alameda County District Attorney Nancy O'Malley announced Monday that charges ranging from murder to involuntary manslaughter could emerge from a criminal investigation into the fire, but she declined to say whether the focus begins with Almena. He converted the two-story space in the 1300 block of 31st Avenue, near the corner of International Boulevard, into a Burning Man-style arts collective and commune.

The facility did not have permits for parties or residential living, and former residents and frequent visitors say he was arrogant and indifferent about hazards that one of his former acquaintances dubbed a "death trap."

"Did we modify? Did we make changes? I would like say we made improvements," Almena said.

Said Allison, who accompanied Almena to the "Today" interview: "We didn't have enough money that needed to be done there, and there was nobody helping us in the ways that we needed."

Almena has run into trouble with the law previously. He pleaded no contest in Alameda County to a misdemeanor charge of receiving stolen property in a plea deal that saved him from facing a felony and was placed on probation until 2019. Online records show his criminal history also includes an unspecified arrest in Los Angeles County.

Will the blame for California's most devastating structure fire since 1906 also fall upon him?

"I'm worried man," he told Lauer. "I'm worried that my kids are going to be taken away from me."

Said Allison, who spent most of the interview off camera: "As a mother, I'm having a terrible time ... and I'm so sorry. I'm so sorry for what has happened."

Almena has drawn criticism for not being at the property on Friday night. He, Allison and their children stayed at a nearby hotel. He lamented on Facebook on Saturday morning about the loss of "everything I've worked for," without mentioning the victims, also drawing public ire. He later sent a statement to NBC that he put up his Facebook post before learning of the casualties.

"I'm 47 years old. I'm the father of this space," he said in the "Today" interview. "On the night of the fire, did I know there was going to be a fire? Did I remove myself from this space and get a hotel because I wanted to avoid this, because I wanted to cast blame on other people? No. ... I wanted to get a good night sleep with my children. I wanted to let the young people do what they needed to do."

After Oakland warehouse fire, calls come for more inspectors

OAKLAND — In the wake of the deadly Ghost Ship fire, questions are being raised whether the city has sufficient fire inspectors to cover its diverse and sometimes problematic housing stock, including many older manufacturing warehouses that have been converted to artists' collectives.

Until last year, the city had gone three years without a fire marshal — the person with authority to shut down unsafe structures — and four other inspector positions are funded but remain vacant, according to documents.

And two years before the fire that killed 36 at an artist's collective Friday night, an Alameda civil grand jury report showed the fire department failed to inspect more than one third of the city's 11,000 commercial properties. The 2014 report offered another alarming finding: Oakland was losing about \$1.4 million a year in unrecovered fees, fines and abatement costs due to poor billing and collections practices.

Questions remain about whether fire inspectors ever visited the warehouse after the Ghost Ship opened in 2013. Oakland city officials have yet to release detailed information on the overall history of fire inspections at 1315 31st Ave. However, Tuesday night Mayor Libby Schaaf said the city was compiling records from several departments and would make them available to the public.

Councilman Noel Gallo acknowledged the shortage, and the city's struggles to get inspection efforts on track.

"We have a shortage of staff at the enforcement level and in the fire level," said Councilman Noel Gallo, who represents the Fruitvale district where the fire happened. "We've been trying to merge the building inspectors with the fire inspectors."

A review of employee data obtained by the Bay Area News Group shows in 2015 Oakland had nine fire prevention inspectors; three assistant fire marshals; and a fire marshal, Miguel Trujillo. There were also five fire suppression district inspectors.

Firefighter union Vice President Zac Unger said leaving the fire marshal position vacant for so long "sends a terrible signal that protecting firefighters and citizens isn't a priority."

There is a "giant disconnect" between the firefighters and the civilian fire safety inspectors, he said.

"We see dangerous stuff on the street and we send it up there and it just goes into a void," Unger said, adding that Fire Chief Teresa Deloach Reed "has completely ignored fire prevention."

According to the most recent staffing report released in October, two civilian fire prevention bureau inspectors positions and two fire suppression district inspector positions remain vacant, even though City Council approved funding for the jobs.

"To me, that is the bigger outrage," Councilmember **Rebecca Kaplan** said Tuesday. "There are significant vacancies in the fire department,"

Kaplan said positions are posted and hiring is a priority.

"Those complaints that deal with life safety that pose a threat to people's survival need to be given priority," she said.

Kaplan talked about the city's responsibility to address safety concerns.

Some of the last survivors to escape the Friday fire said law enforcement and firefighters were in that building many times and wonder why nothing was done earlier.

"Well, exactly, and that is why I am supporting the request by members of the public that there be an independent investigation," **Kaplan** said. "Because we don't yet know. Did the incident not get reported up to the next people to respond, or was it reported and not responded to?"

Gallo wants a full accounting of building owners and landlords for those warehouse spaces.

"Many of the property owners who are arriving in Oakland do not live in Oakland and do not live in the United States of America," he said. "I want to clearly identify in terms of the ownership."

Gallo said his own complaint about the 31st Avenue warehouse went nowhere.

"In my district, I have a large immigrant community that is just arriving in Oakland, and they're choosing to live in apartments in these commercial places," he said. "In some places, the property owners are taking advantage of them."

City leaders said they are determined to find out where the system failed to prevent future tragedies.





I worked with Children's Services from 1993-98 at the Henry Robinson Multi-Service Center (emergency housing and 18 month transitional housing for families) and was Children's Services Manager from 1995-98. Certainly many things have changed since then, but not the need for housing.

Ideas to create housing for homeless people

Martin Luther King, Jr. Day is coming up, and, asking what's my dream, this is it: to having a safe, decent place for every homeless person to live, Oakland's "Housing Homeless People" initiative (HHP.) Imagining a solution could look like this.

There are at least three parts: **increase housing stock**, **finance**—paying for it, and **administration**—who goes where (including social workers' "case management," when indicated), coordination of services, problem solving, accountability.

Increase housing stock:

Current SRO's—rehab for homeless people, like the City, Red Cross, Traveler's Aid, and HUD did in a joint project at the Henry Robinson Multi-Service Center, after the Loma Prieta Earthquake. This project created many units for families, had a drop in center for emergency housing up to 30 days, and housed families admitted to the program up to 18 months. I worked with Children's Services there from October, 1993 -98, and was Director of Children's Services from 1995-98. Things have changed since then, but needs have only increased. Except for 1983-June 93, I've lived in Oakland since 1972 and have never seen so many people living on the streets.

Warehouses that currently house live/work spaces: make them safe, up to code, and affordable (see finance).

Vacant land the city owns (? Is there some?) — what could be built on it or a portion of it? While small pods look good as a solution, long term they may create more problems than they'll solve short term. Better: regular construction, but very well designed. A competition? Architecture schools? Contractors? Prize is lots of publicity and you get to build your design... well-coordinated plans with building trades, local hires, will earn extra "points." Applicant has to pay 50% (verified/certified), City (see finance) will pay 50%.

Current distressed housing, not up to code: If the owner has an option to participate in Oakland's Housing the Homeless program to rehab units for homeless people, the owner can access special funding and tax benefits (finance). There would be a required number of years to participate in the program or there would be a lien to pay back all money. After the number of years, the owner could receive tax incentives to keep in the program, accepting people sent by the Housing the Homeless program.

At least 3 categories of housing are needed:

- 1. "Come as you are" housing—getting people off the streets, especially people with addictions and other health issues. This would be staffed, supportive housing. For single people, couples. Presumably children are not there, but if they are, the family should be housed in category 2.
- 2. Supportive housing for families with additional health issues contributing to homelessness.. Staffed, supportive housing.

INFORMATION

This Information Memorandum provides an update on the efforts staff have taken since the 31st Avenue fire on December 2, 2016, as well as information on next steps that are underway to address the longer term impacts of the fire.

Post Disaster Recovery Efforts:

In the days following the fire, the City worked diligently with nonprofit, local, state, and federal partners to secure the site, provide services to the families in need and address questions from the community about the incident. Below is a summary of the key critical actions taken in the Post Disaster Recovery phase.

1. California Office of Emergency Services (Cal OES) Cost Reporting: The Cal OES has the California Fire Assistance Agreement (CFAA) which is the negotiated reimbursement mechanism for local government fire agency responses through the California Fire Service and Rescue Emergency Mutual Aid System. The agreement requires certain documentation to be kept and submitted in order for a local government agency to receive reimbursement funding for expenses in large emergency situations. Oakland Fire Department Emergency

There are a number of actions underway to address the short term and long term issues associated with the 31st Avenue fire. Some of these actions will be completed in the near term and some will take longer as they involve significant policy issues.

Immediate Term:

- 1. <u>Tenant Protections:</u> The City Administrator's Office is working with the City Attorney's Office to develop a list of Frequently Asked Questions (FAQs) that will be posted on the City's website. The FAQs will address various questions that have arisen concerning the rights and responsibilities of occupants and owners of spaces like that of the 31st Avenue warehouse and similar spaces.
- 2. Special Events: The City is creating a coordinated interdepartmental team to address special events. This team will facilitate well-informed decision making to ensure that special events are permitted and safe. This group will also assess staffing needs related to enforcement of special events permits and requirements.
- 3. <u>Relocation Assistance</u>: The Housing and Community Development Department is coordinating short-term housing for those displaced by the 31st Avenue Warehouse fire. For housing questions, please visit https://goo.gl/UoGmfv. More information on housing assistance will be forthcoming through a Frequently Asked Questions (FAQ) link on the Housing Assistance Center webpage mentioned above.

Longer Term:

- 1. Fire Safety Task Force. Immediately following the fire, the Mayor created a Fire Safety Task Force. Staffed by City Administrator's Office, assisted by the National Fire Protection Association (NFPA), the Task Force includes City staff as well as outside experts. This Task Force will use the standards created by the NFPA 1730, "Standard on Organization and Deployment of Fire Prevention Inspection and Code Enforcement, Plan Review, Investigation, and Public Education Operations," as well any other specific NFPA recommendations from the NFPA, to conduct a Community Risk Assessment and a Community Risk Reduction Program. This will be a comprehensive process that will include (but not be limited to) recommendations regarding:
 - a. Developing a plan to create more detailed building stock inventories and to prioritize those buildings with the highest risks;
 - b. Determining potential policy changes regarding inspections, enforcement, special event permitting, and zoning vis-a-vis live/work units;
 - c. Examining how departments communicate with each other and how calls for service and other complaints are tracked, including a close look at our Accela, HDL, and Cityworks databases.
- 2. Artists Task Force: The Mayor's Office Policy Director of Art Spaces is reconvening the Artists Housing and Workspace Working Group of the Oakland Housing Cabinet. The Working Group will continue to solicit input from the artist community on solutions to safety and affordability issues for artist workspace and housing, as well as review and advise on the work of the Fire Safety Task Force.

Other Information:

The City Administrator will continue to provide updates on each of the actions described above and will provide more information with the report to the City Council on February 21, 2017.

Following are the key activities to be highlighted this week:

Upcoming Holiday Closures — On Monday, December 26 and Monday, January 2, the City of Oakland's administrative offices will be closed in observance of the Christmas Day holiday and the New Year's Day holiday. While the City's administrative employees are out of the office, if a situation arises that requires more staffing, the City has a plan in place to call in additional resources. Annual Holiday Food Drive – Through Friday, December 23, the City of Oakland is holding its Annual Holiday Food Drive. The Alameda County-Oakland Community Action Partnership (AC-OCAP), in partnership with Alameda County Community Food Bank, is coordinating the food drive. The Alameda County Community Food Bank serves one in five residents of Alameda County. The cost of living in the Bay Area has made it nearly impossible for many households to make ends meet. Children and seniors remain the most vulnerable to hunger in our community. Food collection barrels are in the lobbies at the following locations:

operation at the Alameda County Sheriff's facility, 2425 E. 12th Street. The center comforted and assisted family members and friends looking for loved ones with grief counseling and other services. Representatives from Alameda County Behavioral Health Care Services, Alameda County District Attorney's Victims Support Division and the City of Oakland joined in partnership with volunteers and staff from the American Red Cross in providing support to families and friends of the fire victims. On Monday, December 5, Alameda County District Attorney Nancy O'Malley shared the details of the launch of her office's criminal investigation into the fire. The District Attorney's Office activated the criminal investigation teams and is actively looking at this with all of the other law enforcement partners. On Thursday, December 8, the proclamation of a Local Emergency by the Oakland City Administrator was ratified by the Oakland City Council during a special meeting. The local emergency, which was, proclaimed on Tuesday, December 6, is an important step in recovery for the City of Oakland and our community. Under the California Disaster Assistance Act, the City of Oakland may be eligible for reimbursement of up to 75 percent of qualifying response and recovery expenses related to the 31st Avenue Fire. Generally, these include labor, equipment, materials and other expenses related to extinguishing the fire and recovering the victims from the scene. The Oakland Fire Department's Emergency Management Services Division will be developing an initial damage estimate to provide to the Governor's Office of Emergency Services (Cal OES) for consideration for California Disaster Assistance Act funding. Staff from the Economic & Workforce Development Department has distributed the Estimated Disaster Economic Injury Worksheet for Businesses. Artists who may have operated a business in the 1315 31st Avenue warehouse may be eligible for SBA loans, and are encouraged to contact Aliza Gallo, Economic Development Manager, at agallo@oaklandnet.com or (510) 238-7405. At a press conference on Tuesday, December 13, the Bureau of Alcohol, Tobacco, Firearms and Explosives, or ATF, and the Oakland Fire Department shared that they have concluded the on-scene investigation for the 31st Avenue Fire. Throughout the District Attorney's Office's criminal investigation and the Oakland Fire Department's scene investigation, ATF has assisted by providing their fire expertise and assisting with witness interviews. All of the scene information has been gathered and analysis of the information will continue. The Oakland Fire Department will prepare the final report of the scene investigation. ATF and Oakland Fire Department's findings will be submitted to the District Attorney's Office in support of their ongoing criminal investigation. Alameda County District Attorney Nancy O'Malley explained that her office's criminal investigation is ongoing. The District Attorney's office continues to ask any witnesses with information about the fire or the warehouse to come forward to assist with the investigation. She also shared information with the public about how those impacted by the fire could access victim witness support available through the DA's Office. The District Attorney thanked the Red Cross for its ongoing support of victims, their families and those displaced by the fire. Members of the Red Cross team provided information on where those impacted by the fire could continue to access support being provided by the agency. The Oakland Fire Department's Emergency Management Services Division will be developing an initial damage estimate to provide to the Governor's Office of Emergency Services (Cal OES) for consideration for California Disaster Assistance Act funding. Staff from the Economic & Workforce Development Department has distributed the Estimated Disaster Economic Injury Worksheet for Businesses. Artists who may have operated a business in the 1315 31st Avenue warehouse may be eligible for SBA loans, and are encouraged to contact Aliza Gallo, Economic Development Manager, at agallo@oaklandnet.com or (510) 238-7405. At a press conference on Tuesday, December 13, the Bureau of Alcohol, Tobacco, Firearms and Explosives, or ATF, and the Oakland Fire Department shared that they have concluded the on-scene investigation for the 31st Avenue Fire. Throughout the District Attorney's Office's criminal investigation and the Oakland Fire Department's scene investigation, ATF has assisted by providing their fire expertise and assisting with witness interviews. All of the scene information has been gathered and analysis of the information will continue. The Oakland Fire Department will prepare the final report of the scene investigation. ATF and Oakland Fire Department's findings will be submitted to the District Attorney's Office in support of their ongoing criminal investigation. Alameda County District Attorney Nancy O'Malley explained that her office's criminal investigation is ongoing. The District Attorney's office continues to ask any witnesses with information about the fire or the warehouse to come forward to assist with the investigation. Following are the key activities to be highlighted this week:

Fire At 1315 31st Avenue - On Friday, December 2, a tragic fire claimed the lives of 36 victims. Within minutes of the first call to dispatch, crews from the Oakland Fire Department arrived and the incident quickly went to a three alarm. The fire was deemed under control at 4:36 a.m. on Saturday, December 3. We continue to extend condolences to the families and friends who have received the tragic news of losing loved ones in the 31st Avenue warehouse fire. During the height of the response to extinguish the fire, there were 16 units on scene and 77 fire fighters. During this response phase, the Oakland Fire Department received mutual aid from the City of Alameda Fire Department and the Alameda County Fire Department. During the recovery phase, personnel from the Oakland Fire Department; Oakland Police Department; Oakland Public Works Department; Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF); Alameda County Sheriff's Office; Cal OHSA; Alameda County Search and Rescue; Fremont Fire Department; Hayward Fire Department; East Bay Regional Park District's Fire Department; Contra Costa County Fire Protection District and San Ramon Valley Fire Protection District conducted the painstaking work of recovering the victims from the scene of the fire. At times, debris removal progressed by bucket brigade. Due to severe damage to the building, sections of the building needed to be shored-up to provide safe entry for recovery teams. Recovery efforts continued around-the-clock and required the use of heavy equipment. At one point, electrical lines had to be de-energized to allow use of a large crane. Thanks to careful planning, at its height, the planned power outage impacted 12 residential and commercial customers. On the morning of Wednesday, December 7, search and recover efforts at 1315 31st Avenue were concluded. A secondary search by recovery personnel and cadaver dogs was made and returned no additional victims. From Saturday, December 3, through Wednesday, December 7, a Family Assistance Center was in operation at the Alameda County Sheriff's facility, 2425 E. 12th Street. The center comforted and assisted family members and friends looking for loved ones with grief counseling and other services.
