Soriano 9034 that the owner of the building had a no trespass order (report #14-006470). I was provided with a copy of the no trespassing order and was advised by Ofc. Soriano that a MB by the name of BARNES, Llewellyn (S1) had been sleeping in the top floor of 2100 Lakeshore.

I conducted a file check of BARNES via CRIMS to obtain a photo of BARNES.

I noticed when I passed the vehicle it showed current 2015 tabs. I made a U-turn and parked against the WB curb line of Lakeshore facing SB.

I observed a MB (later ID'ed by CA ID card as ROBERTSON, D (S-1)) exit the now parked vehicle from the drivers side and walk to the back of his vehicle. S-1 appeared to be on his cell phone walking back and forth behind his vehicle multiple times. S-1 then walked to the base of the Cleveland Cascade stairs and walked up to the first landing. Cleveland Cascades is a park which has a curfew at 2200 hours.

I elected to make contact with S-1 and advise him of the park curfew. I made contact with S-1 who stated that he was going to his friends house which he stated was across the Lake near Grand Ave. Upon requesting to see S-1's ID, S-1 told me that he was on probation for a weapon violation. S-1 provided his CA ID card


S-1 also had in his hand a clear plastic bag containing a green leafy substance suspected to be marijuana. S-1 later stated he had a valid cannibus card which was located inside his wallet.

3L16 arrived on-scene and acted as a cover unit.

I placed S-1 in a search position to PAT search his outer clothing for weapons. During my PAT search of S-1 I felt a small hard object in the front groin area of S-1. When I asked S-1 what the item was he told me "Nothing", and he began to bring his feet together as to conceal the object. S-1 also began to pull his hand away from my grasp. I grabbed around S-1's body and arms moving him up against his vehicle. Ofc O'BRIEN grabbed a hold of S-1's left arm and I grabbed his right placing them behind his back into handcuffs. I recovered the small hard object which was inside the front of S-1's boxer briefs tucked in between the flap which was found to be a black scale with green leafy substance residue inside.

I conducted a full search of S-1's person to locate any addition contraband. During my full search of S-1 I recovered a clear plastic bag containing 4 bindles of a white powdery substance suspected to be cocaine (E-1) in S-1's right front pants pocket. I recovered no additional contraband during my search of S-1. I placed S-1 in the back seat of my patrol vehicle.

I ran a file check of S-1 via W/W and CRIMS and confirmed that S-1 was on probation for 25850(a) PC with a S-7 search clause. I also observed that S-1 did not have a CDL. W/W provided the following details:





I searched S-1's vehicle for any additional contraband with negative results.

While S-1 was in the back seat of my patrol vehicle he made spontanious statements to me that he did not have a CDL (12500(a)CVC)) or any insurance on his vehicle 16028(a)CVC)). He also stated to me that he was aware that the tabs on his vehicle were false (4462(b)CVC)).

Due to the fact S-1 had false tabs on his vehicle, he was driving with no drivers license and had no proof of insurance I elected to tow S-1's vehicle for 22651(o). Ofc O'Brien ordered a tow via service. Ofc Hazelwood confiscated the vehicles rear license plate to turn into OPD property. A&B auto arrived on scene and towed S-1's vehicle.

I issued S-1 a citation (5663055) for the above mentioned traffic offenses. CONCLUSION SUMMARY:

I observed a vehicle park in the 2300 blk of Lakeshore Ave. As I passed the vehicle I ran a file check which showed the vehicle REG was expired and showing false tabs. I observed ROBERTSON, who was the solo occupant, exit from the drivers side and walk to Cleveland Cascade park which was past park curfew. While making contact with ROBERTSON he stated he was on probation for a weapons violation. I verified ROBERTSONS identity via his CA ID card and found he was on probation with a S-7 search clause. During a subsequent search I recovered 4 bindles of a white powder substance of suspected cocaine. I placed ROBERTSON under arrest for 11350 H&I, cited and released him. Additionally ROBERTSON was cited for various traffic violations.

Due to the amount of marijuana recovered on his person, the black scale with suspected marijuana inside and the 4 bindles of cocaine recovered on S-1's person it is my recommendation that S-1's probation be violated or revoked.

Officers searched the area of Fairy Land for a vehicle matching the description with negative results.

Upon my arrival to 2930 Telegraph Ave, I contacted Wayne Shellbarger (ID'd as V1) who stated he had been robbed at gun point, and was currently tracking his IPad (Loss/Recovered#1) which was taken in the robbery. I retrieved information for a Crime Broadcast stating the following: 211PC-Robbery occurred at approx. 0530 hours in the 2800 block of Telegraph Ave. 2 Unknown suspects with only a description for S1. S1 was described as a MB, 6'2, 130, thin build, wearing a blue hoodie (hood on) and he was armed with a black semi-automatic handgun. S2 (unknown description) was driving a 80's-90's small compact vehicle, possibly blue or gray in color but not red. The vehicle could possibly be similar to a Datsun. Both S1 and S2 fled in the vehicle NB Telegraph Ave, unknown further DOF.

As I was speaking with the V1, Officer T. Smith was tracking V1's stolen IPad, Loss/Recovered#1, via his personal cell phone. Ofc. Smith tracked the IPad to multiple locations starting near the Bonsai Gardens and the Lawn Bowling area of Lakeside Park. Ofc. Smith continued to track the Ipad as it began changing locations. The locations where Ofc. Smith tracked the Ipad are as follows:

- 1. Bellevue Av (inside Lakeside Park)
- 2. Bay Pl and Harrison St
- 3. 24th St and Valdez St
- 4. Bay Pl and Harrison St
- 5. SB Harrison St from Bay PI

After Ofc. Smith tracked the phone moving SB on Harrison St approaching Grand Ave, he observed a 2015 Hyundai Accent (Ca Lic# white in color, 4 door) stopped at the SB Harrison St and Grand Ave traffic light. This is exactly where the Ipad had last been tracked to and where it was currently stationary. Ofc. Smith stated there were no other cars on the road and no traffic in either direction.

Ofc. Smith followed the vehicle NB on Grand Ave while simultaneously tracking the Ipad via the "Find My Iphone" App. Ofc. Smith continuously refreshed the tracking app while following the vehicle to confirm that the vehicle was following the same path that the Ipad was traveling. While Ofc. Smith was following the vehicle he made sure to take note that there were no other vehicles on the road other than the vehicle he was following.

Ofc. Smith followed the vehicle from Grand Ave and Harrison St where he initially picked up the path and continued to follow it NB on Grand Ave and EB on El Embarcadero Ave and then SB Lakeshore Ave. In the 2800 Block of Lakeshore Ave additional units arrived on scene to conduct a high risk vehicle stop to investigate the occupant's involvement in the robbery.

Officers ordered the driver of the vehicle, John Goins (later ID'd - S3), into a kneeling handcuffing position and Ofc.Smith handcuffed Goins. Ofc. Smith checked the handcuffs for fit and double locked them. Ofc. Smith conducted a pat search for weapons. No weapons or contraband were recovered. Ofc. Smith advised Goins he

was just being detained. Goins was placed in the rear of Ofc. Smith's patrol vehicle.

Goins made spontaneous statements to Ofc. Smith. Goins spontaneously stated something about a weapon being involved in the crime and also that he found the bag (Loss/Recovered#2) in the intersection of Monticella Ave and Bay PI.

Ofc. Airoso, Ofc. Tran and Ofc. Recendez cleared the vehicle. Ofc. Airoso located a black shoulder bag (Loss /Recovered#2) that matched the description of the loss and there was an IPad in a gray case(Loss/Recovered#1) inside of the bag.

I started to obtain V1's written statement, inside of 2930 Telegraph Ave. V1 told me he may be able to identify S1 (MB, late teens, 6'2, 130, thin build, wearing a blue hoodie). I informed V1 we had one person detained and V1 agreed to participate in a Field Show-up.

While en route to the 2800 Block of Lakeshore Ave I told V1 that the subject, Goins, may or may not be the suspect who robbed him. I transported V1 and my PDRD was activated during the Field Show-Up.

Sgt. Alaura was on scene in the 2800 Block of Lakeshore, for the Field Show-Up.

Ofc. Smith escorted Goins out of his patrol vehicle. V1 stated he positively ID'd Goins based on his stature(size /body type) and skin tone during the Field Show-Up. V1 stated if he had a blue jacket on it would be better to see his size.

There were the following discrepancies with V1's identification:

- -V1 stated S1 was 6'2, Goins is 5'11
- -S1 was wearing a blue cloth hoodie. No blue cloth fabric hoodie was located in Goins possession (only a blue rain jacket with a hood was located). Goins was wearing a striped blue shirt (no hood) and blue jeans.
- -V1 described the Suspect Vehicle color as possibly blue or gray (not red for sure). Goins vehicle is white.

V1 positively ID'd his black shoulder bag (Loss/Recovered#2), black IPad in a gray case (Loss/Recovered#1), one pair of Apple headphones (Loss/Recovered#4), one apple charger (Loss/Recovered#3), and one multicolored small bag with flower print (Loss/Recovered#5). The front screen of the IPad depicted the Find My Alert as well.

It appears Goins was identified as S1 and at this time it is unknown of his involvement or lack there of in the robbery. Goins was in possession of stolen property, Loss/Recovered items:1-4, in violation of 496(a)PC. Goins was arrested for 496(a)PC-Possession of Stolen Property.

Ofc. Recendez took V1's statement. V1 was walking NB on the East sidewalk in the 2800 Block of Telegraph Ave when a vehicle (80's-90's Unk Make/Model, poss 2 door, sedan, not red in color) quickly pulled up behind

him an parked. The passenger, S1 (MB, late teens/twenties, 6'0, 160lbs, dark completed, wearing a blue hoodie and dark jeans) approached V1 while holding a black semi-automatic handgun. S1 got close and said "give the bag" and V1, in fear of his life, said "you got it". V1 gave S1 his bag, Loss/Recovered#2. Loss/Recovered#2 contained Loss/Recovered#1-5 and L1-one small Blue Bag with White Fish on it containing Art supplies (originally in Loss/Recovered#2) and L2- One Sketch Book with sketches.

S1 then asked V1 where his wallet was, and in fear of his life, V1 pulled his black leather two fold wallet (L3) from his font left pant pocket and handed it to S1. V1's wallet (L3) contained V1's CDL, 20x\$1.00, Credit cards, Clipper Card. S1 then ran into their vehicle and fled NB on Telegraph Ave.

V1 refused medical attention. V1 wants to press charges and is willing to help in the investigation. See V1's statement for further details on Field Show-Up, but V1 stated he could not positively ID Goins as S1. V1 does not think he could Identify S1.

Sgt. Alaura admonished Goins. Goins waived his rights by saying "this is a set up". Ofc. Yamashita took Goins statement. Goins stated he was driving home and saw a black bag, Loss/Recovered#2, in the middle of the road on Bay St. Goins does not remember what time he noticed the bag. After he picked it up he drove around the lake and noticed multiple officers behind him. Goins then pulled over in the 2800 block of Lakeshore Ave and was ordered out of his vehicle and placed into handcuffs. Goins denied involvement in the robbery. Goins refused to sign the statement.

Technician Hildreth was on scene for photos. Hildreth attempted to lift finger prints from the Ipad but was unsuccessful. See her report for further.

Ofc. Recendez transported V1 home.

Ofc. Recendez contacted the Patrol Desk to enter a Log Entry. Ofc. Recendez contacted the Communications Division to enter a Comm. Order.

Ofc. Yamashita canvassed the scene where the robbery took place for security cameras with negative results.

Ofc. Yamashita canvassed the area for the Loss near Fairy Land (where the IPad was tracked to initially) with negative results.

I secured Goins backpack in the rear trunk compartment of his vehicle and Ofc Yamashita secured and parked the vehicle legally. Goins vehicle keys were placed in his possession.







While outside of the bar SANDOVAL began to argue with then produced pepper spray and sprayed it in the air. SANDOVAL then ran southbound towards Trader Joe's chased after SANDOVAL and caught up to him about a block away.

I did not see the wrestling or the group of teenaged MB's, but saw SANDOVAL running back towards him and the All 3 parties ran back to wehicle and the Brove them from the scene. While

At approximately midnight SANDOVAL was at the Heart and Dagger bar with playing pool. All 3 parties got into a verbal altercation with another party when approached the group and asked them to leave. SANDOVAL stated that he got into a verbal argument with but left the scene to cool off and have a cigarette. SANDOVAL stated than an unidentified MB, 40's, 6'2", 240 lbs, with braided /dreadlocked hair, wearing a black jacket, carrying a plastic garbage bag (S1) asked him for a cigarette. SANDOVAL told S1 that he didn't have any, and S1 accused SANDOVAL of lying. S1 then lunged at SANDOVAL, causing SANDOVAL to run. S1 chased after SANDOVAL. SANDOVAL then stated that he felt S1 fall and brush against him. SANDOVAL looked behind him and saw S1 lying on the ground behind him. SANDOVAL then got into vehicle and all 3 parties left the scene. 



On 20Jan16 at about 1325 hours I was working as OPD patrol unit 1L14. I was wearing full police uniform and driving a fully marked patrol vehicle #1451.

I was patrolling the area of Lakeshore Ave and Mandana Blvd and observed Veh1 traveling WB on Mandana Blvd. The driver of the vehicle, V1, was trying to get my attention by waiving her hands in the air. I pulled into the parking lot of Shevron Gas Station located at 3500 Lakeshore Ave. V1 exited her vehicle and stated she just got assaulted. I observed V1 limping on her left foot as she was walking. I requested medical response through OPD Radio.

I observed W1 communicating with V1. W1 stated he was in one of the vehicles at the intersection and oversaw the entire incident. W1 was not able to remain on scene to provide a statement. I collected W1's information for documentation purposes.

I later took a PDRD statement from V1:

V1 was driving her vehicle(Veh1) NB in #2 lane in the area of 3400 blk of Lakeshore Ave. V1 noticed that the vehicle behind(Veh2) her was driving very close. V1 yelled at the window, "Stop tailgating me!" V1 proceeded to turn EB on Mandana Blvd. Suddenly the Veh2 passed her on the side and stopped. The driver of Veh2, S1, exited the vehicle and walked to V1. S1 opened V1's door and tried to pull her out the vehicle. As S1 was pulling V1, her leg happened to be in the door frame of the vehicle. S1 then repeatedly slammed the door shot causing the door to hit V1's leg. S1 then got back in his vehicle and started driving away EB on Mandana Blvd. V1 followed S1 and wrote down Veh2's license plate. V1 refused medical attention. V1 wants to press charges.

PMP_i rig #2136 and OFD E10 responded on scene and rendered aid on V1. V1 refused to be transported to a hospital and stated she will self transport at the conclusion of the incident.

#### Summary:

On 25 Jun 15, at about 1150 hrs, I was working as OPD CRT 2 unit 6A09 with Ofc. R. Binder 9097. We were wearing full police uniform and Ofc. Binder was driving marked patrol vehicle #1739.

We observed a vehicle (93 VOLV 940 SW GRN) driving E/B on MacArthur Blvd. toward Lakeshore Ave. The vehicle had blk paper plates (in violation of 5200(a)VC) and a cracked windshield. We initiated a traffic enforcement stop on the vehicle, using our red lights and siren, prior to the on-ramp of E/B I-580 and Lakeshore Ave. S2 elected to drive onto the on ramp and then pull to the right.

We contacted the driver (later ID'd as REED, S-2) and informed him that we had stopped him because he had no license plates on the vehicle. S-2 told Ofc. Binder that he did not have any identification on his person, but told Ofc. Binder that his name was Marcus Reed and provided a control of the locate any information indicating that S2 was Marcus Reed. Ofc. Binder gave S2 repeated opportunities to change the provided information, or give his true name. S2 also advised that he was a confidential informant for an OPD officer. Upon attempting to verify S2's statement, it was also determined to be a lie.

I asked the passenger of the vehicle (later ID'd as ROOFENER, S-1) if he had any identification. S-1 said that he didn't, but provided me with his name and DOB.

I conducted a file check on S-1, which revealed the following information:

I elected to invoke S-1's search clause. I instructed him to step out of the vehicle and detained him in handcuffs in order to prevent resistance or escape.

I asked S-1 if he had anything illegal on him. He told me that he had a needle in his right sleeve. S-1 also told me that he uses heroin, but did not have any heroin on his person. I shook S-1's right sleeve and an unused hypodermic needle (E-3) fell out onto the ground. I conducted a probation search of S-1's person and did not locate any further contraband.

Ofc. D. Lee 9119 conducted a search of the passenger's side of the vehicle where S-1 had been sitting. She located a white Motrin bottle containing a tan/whi powder substance consistent with powdered heroin (E-2). As Ofc. Lee was handing me E-2, S-1 spontaneously stated that the bottle was his.

S-1 also said that he had a black backpack in the vehicle that was his. I conducted a probation search of the vehicle. In S1's backpack I located more hypodermic needles, a tourniquette and a small metal bottle cap with burned heroin residue.


We were unable to identify S-2 using the name and DOB that he provided us. Because of the fact that he was being untruthful about his name, and the fact that we located heroin in his vehicle, we elected to have him exit the vehicle and detain him in handcuffs.

Ofcs. Binder and Lee conducted a search of the vehicle to ascertain if there was more heroin in the vehicle. Behind the rear passengers' seats in the trunk area, Ofc. Binder located a laptop that had a blue tag labeled "Property of Revolution Foods" with a phone number to the business.

Ofc. Binder called Revolution Foods and contacted employee She advised Ofc. Binder that the laptop had been stolen when her vehicle was burglarized in early May. Refer to RD#15-906244 for further details.

Ofcs. Lee and Ransom transported S-2 to North County Jail in order to have him fingerprinted and identified.

S-2 was identified as REED, Ronald Jr. A file check on S-2 revealed the following:


