Summary:

On 14Jun10 at approximately 1210 hours I was on routine patrol in the area of Apgar St and Market St. At that time I observed a black Honda Accord parked along north curb of Apgar St, west of Market St. I further observed two males standing next to the passenger door. I also observed two persons, (Rudd [REDACTED] sitting inside the vehicle. The two males looked in my direction and immediately walked away from the vehicle. This area is high in narcotic activity, specifically in the sales of narcotics and marijuana. Furthermore, I recognized the vehicle as being related to a recent search warrant in the 1000 blk Apgar St. where guns and marijuana were recovered.

I continued w/b on Apgar St past the vehicle. I turned around out of view of the Honda and returned. At that point I observed the Honda pull from the curb and attempt to conduct a u-turn. The vehicle was unable to complete the turn. It stopped, blocking e/b and w/b lanes, reversed, then pulled forward and completed the turn. A Buick travelling e/b on Apgar St IFO my vehicle had to stop and wait for the Honda to complete the turn to avoid colliding with it. I also had to stop and wait for the Honda to complete the turn.

I conducted a stop on the vehicle for the u-turn/unsafe change of course. I then contacted the driver, Rudd, advised her for the reason of the stop, and requested her CDL. Rudd provided me with her CDL. I asked [REDACTED] if he had any identification. He stated that he didn't. He further stated that he knew his "PFN". [REDACTED] verbally identified himself. He also advised me that he was on probation.

I conducted a records query on Rudd and [REDACTED] is active to probation with search clause. I removed him from vehicle after cover officers' Dodds and Greenberg arrived. I conducted a probation search on [REDACTED]

While I was searching [REDACTED] Off. Greenberg provided cover at the vehicle. She then advised me she observed a bulge in Rudd's bra. I observed the same bulge on the right right side of Rudd's bra. Greenberg further advised me that Rudd verbally admitted to possessing marijuana under the driver's seat of the vehicle.

Rudd was subsequently arrested for Poss of Marijuana and removed from the vehicle. She was searched for more marijuana with negative results.

Off Greenberg recovered the marijuana under the driver's seat and turned it over to me.

I cited Rudd for Poss of Marij while driving and she was released.

I conducted a probable cause search of the vehicle for more marijuana.

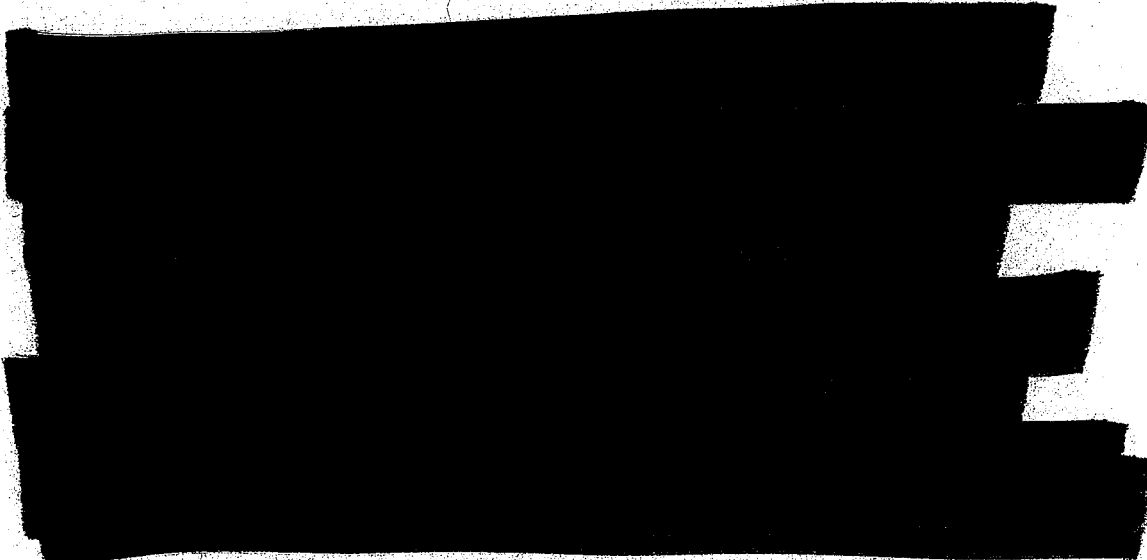

On the scene, I could hear yelling coming from [REDACTED] Ofc McGiffert and I went to this location, and again could hear yelling coming from inside the residence. I knocked on the front door, at which time a [REDACTED] Later ID as S1 Rudd, Jessica) opened the front door, with a [REDACTED] following behind her. As soon as (S1) Rudd walked out the front door, she turned towards (V1) [REDACTED] and punched him directly in the L/side of his face, with her R/hand clenched into a fist. Ofc McGiffert and I immediately detained (S1) Rudd and placed handcuffs on her. As, we placed (S1) Rudd into handcuffs, I could smell the strong odor of an alcoholic beverage coming from her breath. (S1) Rudd also had bloodshot watery eyes, and her face had a ruddy appearance. (S1) Rudd started screaming obscenities towards (V1) [REDACTED] and stated that he had assaulted her.

Based on her verbal statement I detained (V1) and placed (V1) into handcuffs. Ofc McGiffert placed (S1) Rudd into the rear seat of our patrol vehicle, who continued being belligerent. I noticed that (V1) [REDACTED] had an area next to his L/eye, which appeared swollen. I called for medical to respond to the scene.

PMP and OFD responded to the scene. (V1) [REDACTED] refused medical attention. (S1) Rudd also had a complaint of pain to her face area, stating that (V1) had physically assaulted her. I did not observe any injuries to (S1) Rudd face. (S1) Rudd did have a small scratch on her neck.

Ofc McGiffert took a written statement from (V1) [REDACTED] who stated the following: On 29 MAY 13, at about 2000 Hrs, he was at his residence, located at [REDACTED], along with two of his [REDACTED] (S1) Rudd. (V1) [REDACTED] stated that they were drinking alcohol and playing dominos, when he went to the bathroom.
