I remained with the "Red Team" during the duration of the event as they moved to various locations.

During this time I observed a large crowd of protesters in the roadway, along railroad trestles and I.F.O. access gates.

On several occasions I saw several large pieces of debris thrown in the direction of officers.

Due to the crowd density and my position to the rear of the arrest team, I could not identify the responsible party(ies).

I photographed several detained individuals, with the prints being provided to the arrest team.

Summary:

On 7 Apr 03, at 0530 I was working as 2 red 76 assigned to work the Anti-war demonstration at the American President Lines (APL) as part of the Red Team. I was assigned to supervise the Mobile Field Booking Team which consisted of five officers. Officers S. Gray 7928PT, S. Coppess 7506PT, M. Powell 7690PT, D. Burnell 7312PT and L. Riggs 7553P. My officers were to take over custody, obtain information, and take a photo of subjects that were taken into custody at the demonstration and transport the arrestees to an awaiting Alameda County SO Bus.

We arrived at the APL and I noticed several hundred individual protesters blocking at least two entrances to the business and standing in the roadway. I also noticed several semi-tractor trailers stopped in both directions in the middle of Middle Harbor occupied and with their engines running. They appeared to be unable to enter the business due to the protesters blocking the gates.

I heard the order to disperse, to the crowd of protesters. The protesters failed to move and after a few minutes later officers from the Tango Team deployed less-than-lethal toward the protesters.

Several protesters were taken into custody and were handed over to my team for processing.

While moving from location to location at the rear of the formation, I observed broken glass and several large chunks of concrete the size of softballs which I moved to the side of the road.

The group moved toward the Federal building and Frank Ogawa Plaza. We were advised to clear our assignment at approximately 1400 hour.

On 7 Apr 03, I was the Incident Commander overseeing police deployment at a protest demonstration at the Port of Oakland, specifically at two gates at the American President Lines Limited (APL) terminal, 1395 and 1579 Middle Harbor Rd. The Oakland Police Department's objectives for this operation were as follows:

- To allow the peaceful and orderly expression of free speech and lawful assembly rights
- To prevent any non-authorized occupation of any area within the Port of Oakland, APL or other unauthorized property
- To prevent any disruption of business at APL or other locations within the Port
- To prevent the intimidation of the employees or visitors of the Port of Oakland
- To prevent the disruption of surrounding businesses and city streets
- To prevent illegal/criminal behavior
- To arrest violators
- To disperse riotous crowds in a safe direction

Lt. Kozicki advised me that he and his dismounted motorcycle officers attempted to clear the gate at 1579 Middle Harbor Rd at approximately 0615 hrs. The crowd of about 200-300 pushed back at the officers but the driveway was cleared long enough for one truck to pass through.

At approximately 0704 hrs, I issued a dispersal order to the crowd of about 350-400 people, identifying myself and declaring an unlawful assembly. The crowd was disrupting land shipping routes and business as usual within the Port of Oakland. After approximately 15 minutes, officers attempted to move the crowd away from the gate. Once again the crowd pushed back, grabbed officers' batons, and kicked at several officers. Several in the crowd were arrested. The crowd temperament had reached the point in which unlawful conduct and overt acts of violent behavior began to occur. The crowd spilled out into the streets, blocking traffic, walking in, among, and in front of the trucks. Lt. Jordan advised me that the crowd had begun throwing rocks, bottles, and other projectiles at the officers on the skirmish line. A burned, wood torch was thrown at me, landing about seven feet to my left.

I saw a female white, 30's, wearing a black/red vest, white shirt, blue jeans walking in the traffic lanes, disregarding the order to disperse. I directed officers to arrest her as she the skirmish line moved forward and surrounded her. Two officers arrested her for 2800(a) VC Failure to Disperse and 21954(a) Pedestrian in the Roadway.

On 23Apr03, at approximately 1800 hours, I was assigned by Sgt. H. Hu to make contact with persons who were working, and making deliveries to the APL complex, 7Apr03.

I made contact with [REDACTED] who is a driver for [REDACTED]. I conducted a telephone interview with [REDACTED]. He told me that he was in line to enter the APL gate, but was stopped by the gathering of protesters. He stated that he did not see any violence, but did observe a protester waving a flaming torch. [REDACTED] stated that he waited in line, but the protesters and OPD moved farther down Maritime, and away from him. He did not see anything else. [REDACTED] was eventually able to make his scheduled delivery. I took a taped statement.

I also contacted [REDACTED], who is also a driver with [REDACTED]. I conducted a telephone interview with [REDACTED]. He told me that he was also in line on Maritime. He observed the protesters and OPD, but did not witness any kind of confrontation. I took a taped statement.
