



Hi. I'm Jonah Strauss, with Oakland Warehouse Coalition. We have the Ghost Ship Remembrance Day Resolution and Emergency Tenant Protection Ordinance coming before Council at the special meeting next Wednesday at 5pm, but today I am here to speak in solidarity with the tenants of Hotel Travelers.

Words can not express my support for the extension of the SRO conversion moratorium through December 2018. This is a crucial piece of legislation, because when the moratorium was first introduced on a 45-day emergency basis, it was the first major effort to effect Danny Haber's cruel and unusual business practices.

Since his purchase of the Travelers, Danny Haber has demonstrated that he will stop at nothing to remove tenants. He and his surrogate at the building, Dion Ross, worked tirelessly with ruthless and divisive eviction tactics to force out marginalized tenants. These folks are poor, they're senior citizens, and they're primarily people of color. Oakland Warehouse Coalition is proud to stand on their side of this ongoing class warfare.

Minor payouts and brief relocations were made in an effort to pick people off, which was in large part successful. In their precarious situations, many folks simply disappeared with a few thousand dollars in their pocket, which as we all know, does not allow for sustainable relocation in Oakland's current housing crisis.

While the Travelers was an abominable place to live prior to Danny Haber's purchase of the building, he has made it exponentially worse in the last year. His primary tactic for forcing the remaining tenants out has been to tear the building apart around them. Danny Haber fought a War of Attrition against the thirty residents of the Travelers, and he has all but won.

is a cancer survivor, and is even worse off. He never had a private bathroom, but the bathroom on his floor is now inoperable, and he has to shower in the restroom used by the same construction workers who are making his day to day life miserable.

The mailboxes have now been moved to a locked room, and it is difficult for the tenants to get the checks that they rely on to survive, and follow up with City and State agencies in a timely manner. The building is routinely left unlocked, leaving these tenants vulnerable to vandalism.

The list goes on, but the most curious aspect of this situation is the Building Department's complicity in the process. Despite the 45-day moratorium and multiple code violation complaints brought to the City by the tenants, construction continues, and the permitting process has not stopped. Ed Labayog is the Specialty Combination Inspector assigned to the property, and I find it very interesting that immediately prior to his last visit, multiple code violations were suddenly fixed. As says, "The putty was still wet," when Labayog visited.

The Negev is Danny Haber's development firm, which includes Google employee Alon Gutman, and lawyer Yaniv Lushinsky. The Negev's sole purpose in Oakland is to remove low-income housing stock and redevelop it for rent to high-income tech workers. This has been made clear by the Negev's past projects in San Francisco, their one successful conversion in West Oakland, and this is their intent with the Travelers Hotel, 1919 Market, and 674 23rd Street. Using his connections to large-scale property owners such as Seth Jacobson and John Protopappas, Haber has swept through the Town with a mission. The Negev's behavior against tenants strongly resembles Israel's treatment of the Palestinian people, and as a fellow Jew I am deeply ashamed at how Haber, Gutman, and Lushinsky have trampled upon the Jewish code of ethics we hold so dear.

Haber is devoid of conscience and will stop at nothing to remove tenants. He is driven purely by money, and a team of investors have made him capable of major land acquisitions. I heard he walked out of a meeting with Mayor Schaaf with a smile on his face, and that he made a contribution to at least one current Council Member's re-election campaign.
