ON 25DEC96 AT APPROX 1135 HRS. COMP DAVILLA & HIS FRIEND WIT. [REDACTED] WERE WORKING ON DAVILLA'S VEH. THE VEH WAS PARKED NEXT TO THE NORTH WINDOW TO [REDACTED] IN THE SIDE YARD. ONCE THE COMP WAS DONE WORKING ON THE CAR, BOTH WIT. & COMP WERE GOING TO TAKE A DRIVE. COMP STARTED HIS ENGINE & WIT. [REDACTED] SAT IN THE R/L PASSENGER SEAT. COMP THEN SAT IN THE DRIVER'S SEAT TO HIS VEH & CLOSED HIS DOOR. ALL OF THE SUDDEN, AT ABOUT 1140 HRS OR SO, A MALE BLACK JUMPED OVER THE 2' WOODEN FENCE TO [REDACTED]. THIS MALE BLACK (LATER IDEN AS SUSP) WALKED STRAIGHT TO COMP DAVILLA. THE SUSP OPENED THE DRIVER SIDE DOOR, POINTED A SEMI-AUTO PISTOL (VEI TYPE) TO DAVILLA. HEARD & BEGAN TO STATE SOMETHING IN ENGLISH. PER COMP, SUSP PULLED THE TRIGGER TO THE PISTOL. BUT THE GUN WOULD NOT FIRE.
