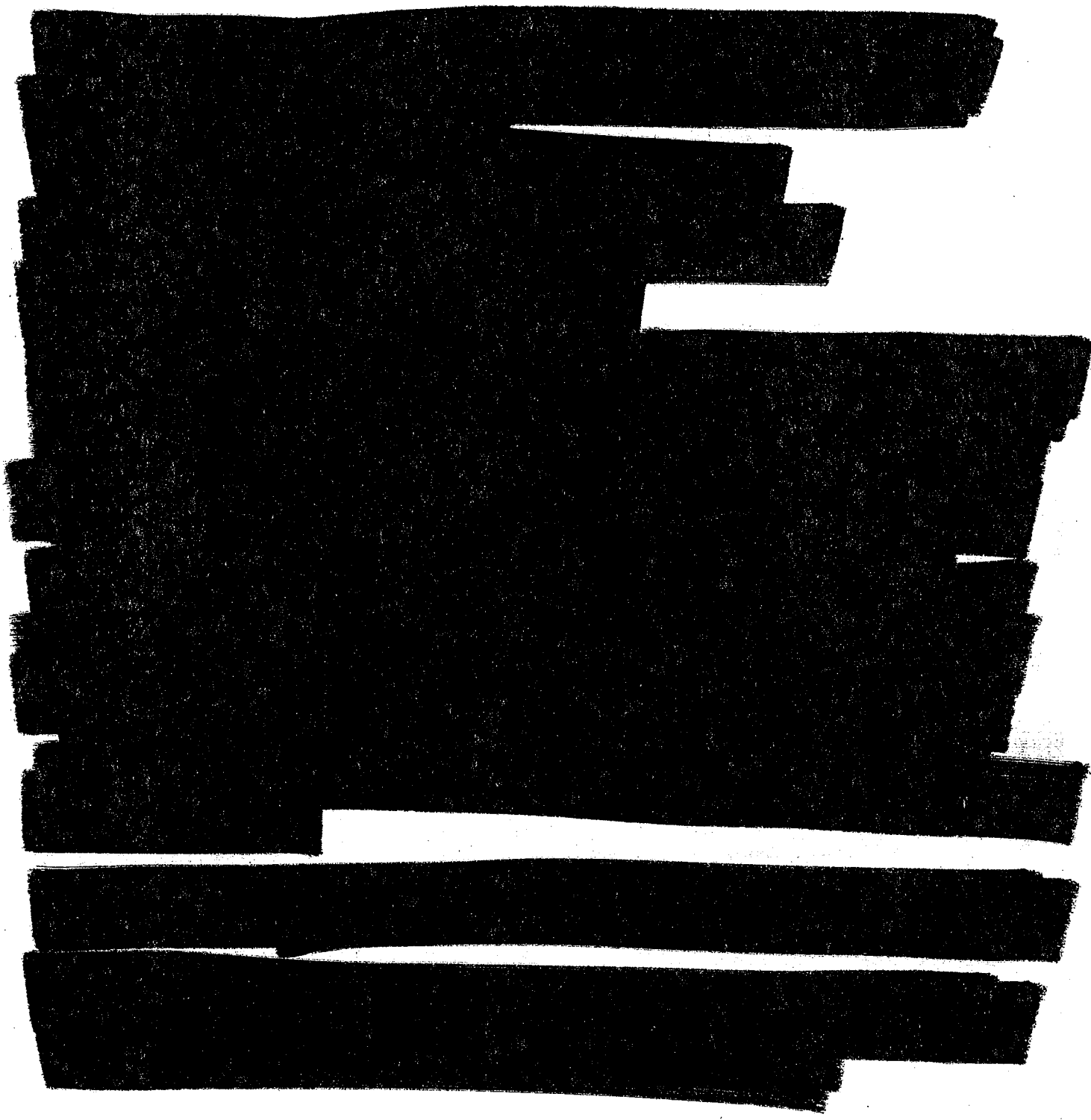



Summary:

On today's date, 30 Sep 12, I was working as OPD patrol unit 2L27. I was wearing a full police uniform and driving marked police vehicle # 1722. At approximately 1748 hrs, I responded to [REDACTED] Seminary Ave to investigate a report of a robbery.

I arrived on scene around 1755 hrs, and met with V1 RODRIGUEZ who told me that an unknown person took a gold heart pendant from his necklace.

V1 stated he wanted the incident documented and extra patrols in the area.

While speaking with V1 I did not see any visible injuries. V1 refused any medical attention.
V1 RODRIGUEZ told me the following in a summary statement:

On today's date, 30 Sep 12, around 1730 hrs, he was standing IFO of his residence when he was approached by S1. S1 asked him if he had a phone that he could use and V1 stated he did not. S1 then snatched V1's necklace from his neck and attempted to run. V1 managed to grab on to S1 which caused him to drop the necklace. S1 manage to break away and flee northbound on Seminary Ave into a waiting green vehicle (NFD /UNIKNOWN MODEL OR TYPE). V1 stated he recovered his gold necklace but the gold pendant attached to his necklace was missing and possibly still in S1's grasp. V1 is unsure if could identify.

There are no known witnesses.

I canvassed the area with negative results.

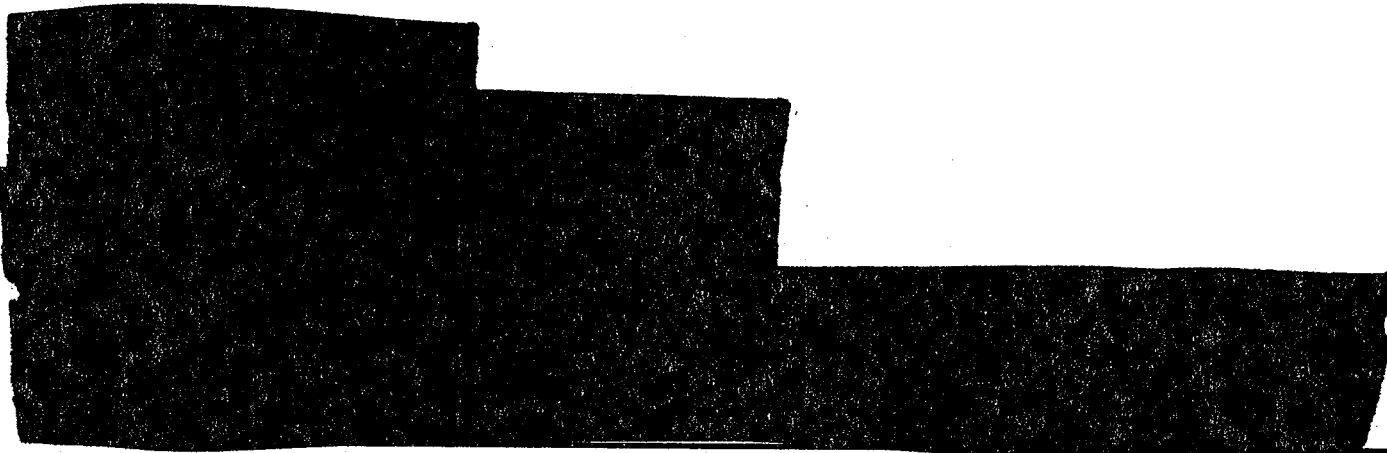
